

PREFACE

The present Memorandum was prepared as a contribution to the continuing study of Communist organization and operations undertaken by The RAND Corporation for the Office of the Assistant Secretary of Defense (International Security Affairs) and for the Advanced Research Projects Agency of the Department of Defense. It is one of a series of five closely related collections of captured Viet Cong documents, translated by RAND consultant Mai Elliott and with introductory material provided by David W. P. Elliott, now a RAND consultant but formerly a member of the research staff leading an interview team in Dinh Tuong province. Editing of the documents has been held to a minimum. Published separately for convenience in handling, the complete series consists of the following titles:

To facilitate the reader's comprehension of any single part, this Preface to the entire series and its appended Chronology are prefixed to each Memorandum.

Although literally tons of documents have been captured from Viet Cong political organizations and military units, detailed records of the entire scope of activities and personnel of such units and organizations are rare. Typically, documents appear to cover only a few aspects of the organization from which they come and often raise as many questions

as they answer. A contributory reason may be that large organizations tend to disperse their records both as a consequence of their size and the diversity of their component parts and as a security precaution. Small units and organizations, while often maintaining central files, are normally represented by documents of limited value.

The collection of documents presented here is unique in presenting a detailed and comprehensive picture of a military unit that, although limited in size, reflects the organizational principles and problems of the larger force to which it is attached. At the same time, the smallness of the unit allows the important factor of personality to come into clear focus, thus complementing the recitation of abstract organizational details.

These documents were captured in mid-May 1967 by an element of a U.S. brigade operating in the Mekong Delta. Their comprehensiveness indicates that an entire file of unit records was captured intact. The records include unit rosters, personnel records, documents relating to Party activities in the unit, training documents, operational plans, unit critiques, and personal letters. Comprehensive as they are, those presented in this series are only a selection from a still larger number of documents. They do, however, exemplify most of the significant data that appear in the documents omitted.

The documents are from the records of a demolition platoon of the 514th Battalion, the Local Force unit of My Tho Province in the Mekong Delta. They reflect not only the organization and command structure of the demolition platoon but that of the battalion as well. Several documents from the battalion command staff discuss problems that go beyond the immediate concern of the demolition unit itself.

An integral part of the 514th Battalion, the demolition platoon participated in many, but not all, of its battles. Since the Battalion often dispersed its companies for operations, not all of its elements were engaged in combat at the same time. Moreover, the 514th Battalion normally played a largely defensive role in its operational area. When it did engage in offensive operations, it relied heavily on the demolition unit as the cutting edge of its attack. The unit leader notes that, "We have the responsibility of being the forward group in any attack, of opening the way for the other elements, and of removing obstacles, erected by the enemy to stop our advance, with explosives."

"Since we are the fighters who have to carry out attacks with explosives," the unit leader adds, "we should always be brave and heroic. We should carry out any task assigned to us, whether it be an attack on enemy forces stationed in posts or in the field." Because of its vanguard role in combat and the need to rely on individual initiative when the unit was operating in a dispersed pattern that makes centralized command difficult, heavy emphasis was placed on developing a unit of highly motivated members. Thus, an unusually high proportion of demolition unit members belong to the People's Revolutionary Party (PRP) and the PRP Youth Group.

The period covered in the documents runs approximately from the beginning of 1966 to mid-May 1967, when the documents were captured. During this time, unit records contain at least five plans of attack but mention only three being carried out. In May 1967, the 514th Battalion and the demolition unit were subjected to a series of attacks by a

U.S. infantry unit that resulted in the Battalion's defeat and the capture of these documents.

The years 1963 to 1964 marked a campaign period that was fairly successful for the 514th Battalion. Its fortunes slipped somewhat in 1965 and 1966, then briefly improved in 1967 with a successful attack on a GVN pacification project. In the above-mentioned series of battles in May 1967, the Battalion was put out of action until the Tet offensive of February 1968. As a consequence, the documents show the unit at a low ebb. Under strength and not often in action, the 514th Battalion and the demolition unit spent much of the time training, reorganizing, and bolstering unit morale. This relatively low level of offensive military activity thus actually allows us a clearer view of the unit's nature and composition than we could normally have gained of a similar unit busily engaged in offensive operations.

Like all records of contemporary events, this one remains incomplete despite its volume and wealth of detail. From the nadir of its fortunes in May 1967, the 514th Battalion and its demolition unit recovered to play a prominent role in the partially successful and immensely destructive Tet Assault on My Tho, the Delta province town, in February 1967. In the absence of specific information concerning the revival of this unit in the intervening months, it is difficult to say how the recovery was accomplished and how permanent it will prove to be. Nevertheless, the following documents give a detailed view of the foundation on which this revival was based, and very likely provide more than a glimpse of underlying strengths and weaknesses of other and larger Viet Cong military organizations.

CHRONOLOGY OF THE C646 DEMOLITION UNIT OF THE MY THO PROVINCE 514th LOCAL FORCE BATTALION

Request from the demolition unit's Party May 6, 1966: Chapter to the battalion for additional men to add to current unit strength of 25. Three-month training course for the demolition May 8, 1966: unit initiated. Attack on Vinh Kim District Town by 514th May 27, 1966: Battalion and the demolition unit. Conference of all cadres in the battalion to June 1, 1966: discuss the new political mission set forth by the Battalion Party Committee. July 19, 1966: Planning for attack on Cay Son. Aug 12, 1966: Battalion assigned a new area of operation by the Province Military Affairs Section. Aug 13, 1966: Battalion moves to Hoa Dong District. Go Cong Province (part of the Viet Cong My Tho Province). Sept 17, 1966: Meeting of all political and military cadres in the battalion to discuss the attack on "K 100," or Vinh Kim village. There are no records of the attack taking place. Oct 17, 1966: Demolition unit commander notes that unit strength is down to 16 men and requests reinforcements. November 1966: One month of training scheduled. Dec 21, 1966: Unit strength totals 23 men, 19 present for duty. Jan 2, 1967: Indoctrination to launch the 3rd Phase of Activities. Jan 9, 1967: Six-day training program initiated with emphasis on political training. Feb 7, 1967: Battalion in bivouac for Tet. Feb 12, 1967: Conference of all cadres in battalion to review the tasks performed in the winter phase and to communicate to all cadres the tasks to be performed during the spring phase.

Feb 22, 1967: Thirty-day training program ordered by the Battalion Command Staff.

Feb 23, 1967: Conference of all military and political cadres in the battalion "to discuss the K 140 and K 111 military plans" on the "center of pacification of the enemy."

Feb 25, 1967: New additions to unit, but active strength remains 19 members.

Feb 28, 1967: Political indoctrination on the role of the cadres.

March 1, 1967: Another plan of attack on points "K 11C, K 18C, and K 18B" is disseminated.

March 4, 1967: Evaluation of the spring campaign.

April 6, 1967: Orders given for "deep penetration into enemy areas." Battalion splits into companies.

April 9, 1968: Meeting of all Company Command Staffs and of the Battalion Command Staff to discuss an attack plan, probably a continuation of the February 23 and March 1 plans.

May 1, 1967: Sixteen-day training schedule issued by the Battalion Command Staff.

May 3, 1967: Defense against a sweep operation in Long Tien village.

May 13, 1967: Attack by the unit on Dong Hoa village, Chau Thanh District (K 19).

May 15-17, Series of encounters with a US-GVN operation culminating in the loss of these documents.

SUMMARY

These documents on composition and personnel provide only a sketchy history of the demolition unit itself. Apparently, this specialized group was not attached to the 514th Battalion until after midsummer 1964. It had previously been an element of an independent company under direct control of the Military Affairs Section at province level, which may account for the occasional references to the unit as a "company," although it was in fact a platoon. At peak strength, the demolition unit had 25 men, but its number had fallen to 15 in the summer of 1966. A request at that time for an additional 19 men had small effect, for the final roster in 1967 shows only 19 in all.

Clear evidence of the elite nature of the unit is found in the documentation of Party membership. It is remarkable, for example, that a platoon, particularly an understrength platoon, should have a Party Chapter, not merely a Party cell. Party Chapters are normally encountered only at the company level. The unit's leaders, almost to a man, belonged to the Party or, among the younger men, to the Party Youth Group, but this is less unusual.

The second and larger part of this Memorandum is a collection of 17 personal dossiers, for the most part compiled by the men themselves. Besides official commendations and formal petitions for promotion in rank or to Party membership, these documents give highly personal accounts of battles and forced marches. Many attest to

the reasons that moved their authors to join the Viet Cong. Most of them provide a brief life history, usually a chronicle of farm or village life, poverty, and curtailed education. Almost inevitably each dossier includes an exercise in self-evaluation. First comes the confession to military derelictions, quarreling with one's fellows, sexual adventure: "I slept with a girl before telling the platoon that I wanted to marry her." Then, with evenhanded justice, comes the attempt to redress the balance: "I have never wavered in the face of fierce struggle."

Whatever trust one can put in instant and coercive self-history and self-analysis, these personal accounts afford unusual insights into Viet Cong practices and habits of mind. If not exactly God's plenty, there is a certain richness of texture. The braggart soldier, the repentant sinner, the roisterous but able leader, the quarrelsome true believer, the romantic revolutionary -- they are all here.

GUIDE TO THE DOCUMENTS IN THIS MEMORANDUM

The demolition unit of the 514th Division is referred to in many of the following documents as a platoon. For the sake of convenience, one of its more frequently used designations is employed here for purposes of identification, the C646 Demolition Unit. Records indicate that the strength of this platoon ranged from 15 to 25. In view of its specialized function, it is normal for such a unit to be numerically smaller than an infantry platoon. In 1967 four of the 19 members of the unit were credited with the rank of squad leader, although only three of the four were listed as actually performing the duties of this rank. The average squad numbered six men.

The origins of the unit are sketchy. A cadre noted in his personal history: "I was sent to the four-month demolition training course organized by the Province in January 1964. Upon completion of the course, the Province Military Affairs Section assigned me to the C320-A unit, which some time later was attached to the 514th Battalion and reassigned the designation of 470C company. I have been fighting with this unit ever since." (6)*

Besides this testimony, there is other fragmentary evidence that the unit was, on occasion, considered to be a company. Other documents suggest that it was an element of a separate demolition company later attached

to the Province Local Force 514th Battalion. Still other unit designations compound the problem of tracing the unit's background.

In general, the documents support the cadre's statement, cited above, that the demolition unit of the 514th Battalion was initially part of a separate province demolition unit which was assigned to the 514th Battalion sometime in 1964. Information from defectors confirms that the Province Military Affairs Section still controls a company-sized demolition unit, which is entirely separate from the C646 Demolition Unit that was assigned to the 514th Battalion.

Several unit rosters chronicle the changes in the composition of the C646 Demolition Unit in exhaustive detail. A list, probably compiled sometime in the summer of 1966, (1) reveals the unit at its lowest ebb, with a strength of only 15 men. Of these 15, five were People's Revolutionary Party (PRP) members, and ten were members of the PRP Youth Group. Unit records normally distinguish between rank and function. This list records only rank, the status enjoyed rather than the actual position occupied.

By this reckoning there were one platoon leader, one assistant platoon leader (both platoon cadres were Party members), three squad leaders (two of whom were Party members), and two assistant squad leaders (both members of the PRP Youth Group). Of 15 men, one was listed as a very poor farmer, twelve were listed as poor farmers,

and two were listed as middle farmers.* Both of the latter were Party members, while only three of the poor farmers had attained that status.

Although the unit was rated as only a platoon, it had a Party Chapter of five members with a Party Secretary, and a Party Deputy Secretary. A Party Chapter is normally found only at company level, while the characteristic representative of the Party at the platoon level is a cell. There is, in addition, a PRP Youth Group accounting for the remaining ten members of the unit.

A list of PRP Youth Group members for August and September (2) and a subsequent list, probably made in late 1966, puts the size of the PRP Youth Group in the demolition unit at ten. (3) An earlier 1966 list identifies the unit as the C470 Company of the 514th Battalion, and records a PRP Youth Group membership of seventeen. (4) While it is certain that the unit's membership was therefore larger in early 1966 than in mid-1966, it still does not seem large enough to merit the "company" designation; it seems more likely that while the C470 Company may have been a company in aspiration, it remained a platoon in fact.

By May 1966, the Party Chapter noted that total unit strength was 25 men, and put in a request to the Battalion Party Committee "to assign more men to the demolition unit." On October 17, 1966, an entry in the notebook of

the Party Chapter Secretary reads as follows: "In view of the 514th Battalion's requirement to bring its troop strength to a normal level, we hope that the Demolition Unit of the Battalion will also receive some reinforcements in order to increase its fighting capability. At present, the strength of the Demolition Unit is 16." (7) in accord with its diminished strength, this document explicitly identifies the unit as a platoon.

The Party Chapter Secretary added, "We submit this request to the Party Committee and the Battalion Command Staff for consideration. We need 19 additional comrades in order to be able to carry out our mission in the forthcoming period." In conjunction with this request, a proposed "change in our unit's cadre composition and the assignment of new functions" was submitted to the Battalion Command Staff.

Unit strength increased only slightly, and by
December 21, 1966, reached 23 members, 19 of whom were
present for duty. The final roster (5) also listed 19, five
of whom were recruited in late February 1967 or later.
It seems probable that the unit's request for additional
personnel was sidetracked by more pressing priorities.
The series of defeats suffered by the 514th Battalion in
May 1967 must have further depleted its strength. Nonetheless, considering the vanguard tactical role of the
demolition element of a battalion, it is likely that the
unit was reconstituted to operational strength.

In conjunction with the requests for additional personnel and the readjustments of cadre roles in late 1966,

the personal history statements of most unit members were brought up to date. The 17 personal history statements (6) reveal the great emphasis given to class background and family connections. The attached biographical data reveal a variety of paths leading toward service in the demolition unit.

Since a unit is inevitably shaped by the personalities of its members, a brief comment on some of the leading figures who appear in the documents may help cast additional light on the documents presented here: (1) Sau Kim: The Party Chapter Secretary and unit commander. During a Party Chapter meeting, he admitted that, "Usually after my unit reached the area of operation assigned by the Battalion Party Committee, I failed to clearly allocate tasks to my subordinates, and this explains why I did not succeed in performing the mission entrusted to my unit in a short time. What's more, sometimes I even organized drinking parties. I slept with a girl before telling the platoon that I wanted to marry her. I failed to hold Party Chapter meetings and to remind my Party cells to hold meetings of their own. I did not observe discipline and regulations well...."

Although hardly a model of cadre virtue, Sau Kim appears to have been a competent leader in most respects. His diary, excerpted in the following sections, shows a conscientious attention to detail and a good grasp of his unit's problems. He also seems familiar with a wide range of military matters. On balance, despite his confessed shortcomings, Sau Kim appears to have been a steady, if not elevated, leader.

(2) Van Tri Phung: The Party Chapter Deputy Secretary and Assistant Platoon Leader, selected as the "exemplary cadre for 1966" by the commander of the 514th Battalion. His "denunciation of exploiters" notes: "I joined the Revolution in 1961...because I saw that during the six years of peace my family and I led a miserable life under the dictatorial regime of the lackeys of the American imperialists." His self-criticism paper states: "Ever since the day I joined the Revolution, I have been determined to fight the enemy to the end, and I have never wavered in the face of fierce struggle."

As for shortcomings, Phung admitted during a Party meeting: "I have a quick temper, and in leading the unit my temper flared up very often and I interfered with others without reason. This created a conflict between myself and Comrade Met. We had many arguments, and this disrupted the unity of the unit. I was cold, indifferent, and partial in my dealings with the men in the unit.... Sometimes I still showed a bureaucratic attitude. My behavior prompted the men under my command to protest and criticize me for it." Nevertheless, as noted in his self-criticism, "from the time I assumed my function to date, I have completed every mission that the higher authorities entrusted to me, as shown in my performance in combat, in reconnaissance mission, in military and political training, and in my everyday leadership."

(3) Tran Van Met: Leader of the 2nd squad and Secretary of the PRP Youth Group Chapter. His wife, also a cadre, defected and tried to persuade him to defect with her. Met threatened to shoot her if she repeated

the subversive suggestion, and she said of him, "He's been in the Front a long time and he's been brainwashed. He no longer thinks of his family. He only thinks of fighting for the people and for himself.... He sent me a letter telling me I was free to get married to someone else, and that as for him, he was going to devote his life fighting for his ideals." (DT-164) Here, then, is the model of the committed cadre -- the true believer.

Met's devotion to duty and personal drive are coupled with an abrasive and temperamental behavior. On one occasion, during a mission, "...the other comrades who were supposed to meet them there did not come, so the other cadres said that they should go back. But Comrade Met refused to go back and was determined to stay there and carry out the assigned mission. While they were performing their task, Comrade Met criticized the other cadres and disrupted unity. For example, Comrade Met said that Comrade Hien was afraid to fight, and Comrade Hien said that if Comrade Met could do his job then he should go ahead and do it, but that if he could not do his job, then he should quit. So that night Comrade Met refused to go on mission."

Harnessing the zeal of a cadre like Met is difficult but, when successful, is rewarded by energetic performance. In this instance, the problem was solved in Party Chapter discussions by arriving at the conclusion that "Comrade Hien committed the error of arguing with Comrade Met when Comrade Met was angry instead of finding a way to settle the problem amiably." This soothing formula is probably an exercise in diplomacy, designed to put to constructive

use this energetic, if sometimes unbridled, devotion to duty.

(4) Nguyen Van "Be Danh": leader of the 1st Squad and Deputy Secretary of the PRP Youth Group Chapter. A member of the PRP Youth Group since 1961 and already the Deputy Secretary of the PRP Youth Group by 1965, Be Danh was surpassed in zeal and devotion to duty only by more single-minded cadres, such as Tran Van Met, who rose from ordinary member of the PRP Youth Group in 1965 to Chapter Secretary in 1966. In part, Be Danh's relatively slow progress in advancement appears to have been due to an exceptionally gregarious nature revealed by his voluminous correspondence in the concluding section of the documents.

Danh was wounded in late 1966 and, according to a Party Chapter comment, "he did not return to the unit for a long time. While living in the village, whenever the local infrastructure assigned him a task he refused to perform it, and so the infrastructure lost confidence in him. He did not hear from the unit for a long time; during Tet he felt sad and asked the infrastructure and the local cadres to go out with him. The local infrastructure did not say anything, so we went to My Tho during Tet."

In one of his many florid letters, Danh writes,
"Wherever we go, we see only scenes of destruction -- heaps
of ashes and debris where warm and happy homes used to be.
What are we going to do? When the country is plunged into
a sea of fire, the only thing we can do is to transform
our hatred into action and make use of all our strength
to bring a Spring of victory to the people. When victory
is achieved we will rebuild the bridge that links North

with South, no matter what, so that the North and the South will be united again, and so that the loved ones who are now separated will be united again..."

These, then, are the leaders of the demolition unit; the fallible but competent leader, his aloof but dedicated deputy, the true believer, and the romantic revolutionary. Along with several other unit members, they figure prominently in the documents in the following sections. Just as a knowledge of their background and personalities contributes to a more thorough appreciation of the documents, so do the documents in succeeding sections cast additional light on these individuals, and on their relations with the unit and each other. The elaborate organizational mechanisms of the unit and the detailed guidance and direction from higher authority, described in the documents, should not obscure the importance attached to individual motivation and performance by those whose guiding maxim is "man is the decisive factor."

I returned home when I was 16 years old and worked as a mechanic to help support my family. In 1961, I joined the Revolution and worked for the local infrastructure. After the enemy destroyed the infrastructure I stopped working for a while because comrade Sanh, the man who contacted me and recruited me in the Revolution, had been killed. At the beginning of 1962, I went looking for members of the Revolution on my own in order to resume my work for the Revolution. I told comrades Phan and Dau of my aspiration and explained to them why my work had been interrupted. I was allowed to resume my work, and in September 1962 was sent to the province to attend a demolition training course. Upon completion of the course I was assigned to the Province Demolition Unit.

Up to date, I have participated in over 30 big and small battles. I was commended once, and was chosen as the most outstanding fighter of the Province Demolition Unit section [phan doi Dac Cong tinh] in 1963 and as the most zealous fighter in 1964 and 1965. I have also been awarded a Military Region Letter of Commendation, signed by comrade Tran Dan Tien.

a. Good points: from the point of view of my ideological stand and state of mind.

Since I joined the Revolution, my mind has always been at ease. I have always been able to distinguish between the right cause and the wrong cause in this struggle. No matter what the difficulties and hardships were, my mind was at ease and I was determined to complete my mission in combat. From the time I was in the guerrillas to the time I was in the District Local Force and finally in the Province Unit, I always fought with courage in battles, no matter what the difficulties were and no matter how fierce the fighting was, and always completed my mission, even in battles when I was wounded. I always carried out the policy concerning the dead and wounded in combat, and have never violated it.

b. Bad points

Since I joined the Revolution to date, my performance has not been devoid of shortcomings. For example, I was hot-tempered and there were instances when I disrupted unity and spoke in an irresponsible manner. Once, I was angered by the criticism of So, my superior at the time (he has now surrendered to the enemy), and asked to be

transferred to the Demolition Unit of the battalion. The reason I gave for the request for a transfer was that So's criticism was inaccurate and disturbed me. But now, my mind is at ease again.

FULFILLMENT OF THE TARGET REQUIREMENTS DURING THE FIRST AND SECOND AP BAC EMULATION CAMPAIGNS

I. <u>Ideology and State of Mind During the Two Emulation</u> Phases

In all the activities I showed a good ideological stand -- during combat, during everyday life in the unit. I loved to fight. In the attacks that took place during the emulation phases I had to endure many difficulties and hardships, but nothing could destroy my determination. I performed production tasks and maintained my weapons well. This showed my sense of responsibility, and constitutes my contribution to the collectivity in order to consolidate our ranks and to heighten the achievements of our unit. My ideological stand was very good. In the attacks that took place during the emulation phases, I encountered many difficulties and was wounded seriously many times, but I didn't go through an ideological evolution because of these things. I neither felt complacent about my

performance nor was I afraid of the enemy. My hatred for the enemy became deeper.

II. Execution of the Resolutions in the Attacks During The Emulation Phases

I carried out my orders quickly and faithfully. I understood the resolutions of the higher authorities and fulfilled the target requirements. I completed the tasks assigned to me in the attacks against the enemy during the emulation phases. I always carried out my orders cheerfully, and considered them as the resolutions of the Party and of the unit commander. No matter what difficulties I encountered I did my utmost to execute them, because I considered this as a mission that I, being a fighter, should perform. I took part in 11 attacks and in 2 counter sweep operations against enemy infantry troops in An Thanh Thuy and Binh Trung Villages.

First Battle

When I first joined the unit, I was only a guerrilla fighter fresh from the village. I was sent to attend a demolition training course. Upon completion of my training I joined the unit for combat duty. At that time I understood the basic techniques but was not good at fighting. The unit drew up a plan to attack the Go Keo tower. I was then a fighter and was assigned the task of assaulting the post. While explaining the plan of attack to the troops, the unit commander mentioned all the difficulties and advantages we would have during the attack. I understood the situation clearly. I was assigned to attack the

second flank of the enemy, and was armed with a 3 kg mine and two grenades. Even though I was still unfamiliar with the fighting technique, I was determined to do my best and support my comardes. After we had prepared our equipment, we left at 5:00 p.m. and walked toward the target area. We marched in an orderly fashion and my squad observed good discipline. At 7:00 p.m. we came close to the enemy and were only 10 m from them. Each comrade had the task of annihilating the enemy. I was told that when the order to open fire was issued I should rush forward and destroy the signal room and advance inside the the blockhouse. After we had been waiting for about one hour, some of the comrades were careless and the enemy detected us. The unit commander ordered us to open fire and to assault the post. I immediately rushed forward to occupy the signal room along with the comrades in my cell. One comrade opened the fence to let our troops in. was seriously wounded and was stuck in the fence. enemy put up a fierce resistance and we couldn't advance any further. The unit commander ordered me to go to the fence and take the wounded comrade back. There were four members in my cell: one was wounded and stuck in the fence, another one who handled the submachine gun was also wounded, and there were only the cell leader and myself left. I found my wounded comrade and carried him out, but half way the enemy threw grenades at me and I was wounded in three places. I couldn't walk and had to crawl. I was determined to implement the resolution from above, and because of my love for my comrade-in-arms, I tried my best to carry him out, even though the enemy from the Strategic Hamlet were advancing out to reinforce the Go Keo tower.

thought that I should carry my comrade out in order to implement the order from above.

Second Battle

Destruction of the Tram Sap tower. At that time, the situation in this area was difficult, because in spite of our attacks and increased pressure on the Phu My base, the reactionary enemy made preparations to fight us. So an attack on the Tram Sap tower was ordered. A few comrades in the unit and I did not know the terrain around this post well, but no matter how difficult it was for us to implement the resolutions of the higher authorities, I did my best to implement the order from above in order to fulfill the requirements concerning the attacks on the enemy during the emulation campaigns. I prepared my weapons and bolstered the morale of the comrades by saying that we should do our best to destroy this post. When we reached our target area I was led close to the post to reconnoiter it and to make sure where our attack should be directed. I detonated the mine that I carried and blasted an opening for the assault group. When the fighting broke out, the first comrade quickly rushed forward and detonated his mine. The second comrade was frightened because of the enemy's shooting, so the cadre in charge of my wing ordered me to rush forward and detonate my [his] mine. Usually we took advantage of the smoke to plant the mine and detonate it, but when I came up to the post, there was no screen of smoke to protect me. Since I was determined to carry out my order, however, I rushed forward cheerfully and completed my mission. When we occupied the post, I seized two pouches

full of Mas 36 cartridges and American cartridges for semiautomatic weapons. I had just recovered from my wound, but I was determined to take part in this attack. During our withdrawal my cell withdrew in an orderly manner and maintained secrecy. I carried out my orders well -- during the withdrawal as well as during combat.

Third Battle

We carried out the resolution from above which ordered the destruction of the Tan Binh post, as part of a wave of attacks on the enemy before the cease fire on the occasion of Tet. I attended an indoctrination course and understood what my mission as a fighter was. I was selected to go and and reconnoiter the Tan Binh Post. Our superiors told us that we would have only one night to complete the reconnaissance mission and that the attack would be carried out the following day. We encountered many difficulties in performing our mission -- there were no local guerrillas to guide us, we had to cross the river by sampan, and it was cold at night. The leader of our group gathered us and talked to us about the difficulties we faced. I understood my mission and overcame the difficulties. I was unfamiliar with the terrain but I did my best to reconnoiter the road, and then profiting from the carelessness of the enemy I penetrated near the enemy and reconnoitered our target. When we came back to the unit, the leader of our group drew a sketch of the target area, and mentioned the difficulties and advantages that we would have when we carried out the plan of attack. I contributed my opinion even though my fighting technique was not good. But I did my best to contribute to the explanations and make clear to

the other comrades all the difficulties that we had encountered while carrying out our reconnaissance mission. Before starting out to attack, I prepared my weapons carefully. At 5:00 p.m. we set out for the target area. During the march I had to carry a heavy load and the road was full of obstacles, but I overcame all difficulties and bolstered the morale of my comrades, reminding them of their responsibility. I came close to the enemy without being detected. After taking up position, we waited for the order to open fire. I reminded the other comrades not to go to sleep, because if they did, it would be dangerous for us. I was ready to attack when the order to open fire was given. My group was the third one to attack, and had the task of blasting an opening in the fence for the assault group to advance inside the post. The first comrade from my group rushed forward and blew up the first Then the second comrade rushed forward and destroyed the second fence. I quickly and calmly rushed forward and while the smoke was still thick I detonated my mine and destroyed the third fence. I therefore completed my mission. During the withdrawal I helped carry the dead and wounded comrades from the battlefield to the area where the civilian laborers were waiting. During the withdrawal I stayed close to the unit and maintained secrecy. I also checked the weapons that we still had with us.

Fourth Battle: Attack on the Xom Buon Post

At that time the policy of the higher authorities was to attack Vam Lang. I don't know what the difficulties were, but the plan of attack on Vam Lang was abandoned,

and instead we were ordered to attack Xom Buon post. Another comrade and I were given two bangalores and had the task of blasting an opening for the assault group. After the order was given and after the unit studied the map of the post, I immediately prepared my weapons for the attack. I maintained secrecy during the march. When the firing started, the first comrade planted his mine and then came back. I approached the fence so that I wouldn't have to run far to plant my bangalore and so that I would save time. When the first bangalore exploded the blast threw me in the ditch because I was too close. But I climbed out quickly and rushed forward to destroy the second fence. After I completed my mission I got some grenades from the assault group so that I could throw them at the enemy who were throwing grenades at us themselves. I was wounded, but I remained calm and checked the weapons that were left to us. During the withdrawal I stayed close to my cell.

Fifth Battle: Attack on An Thanh Thuy Post

The resolution from above ordered an attack on the An Thanh Thuy post. First, a reconnaissance group was sent out to reconnoiter it. The leader of this group, upon his return, told us about the difficulties that we would encounter in the attack and the advantages that we would enjoy. I understood these difficulties and advantages. We didn't have much time to prepare our equipment for the attack, but I did my best to get my mine, batteries and wire ready in time. I would be the second fighter to explode my mine. We had to walk a long distance to reach

the target area. During the march I had to carry the bangalore, which was very heavy. I was still feeling weak because I had just recovered from an illness, but because of my determination I carried out my task cheerfully. The moon was still bright when the order to open fire was issued, but in spite of the moonlight I completed my task. After that, the comrade who commanded us ordered another comrade and me to go up to the barbed wire fence and cut it off. The enemy were putting up a fierce resistance against our wing, but I didn't hesitate to try and carry out my order. I waited for the right moment to go up to the fence and cut it off, but the enemy detected me every time I made a move and threw grenades at me. couldn't approach the fence to cut it off, but we didn't withdraw from our position. We only withdrew when the order was given. On the way I checked the weapons that we had left, stayed close to my cell, and maintained secrecy.

Sixth Battle: Attack on Tan Hoi Post

I was assigned as a reserve demolition man. After the other comrades had detonated their mines to attack the targets assigned to them, if there were still a fence, or a tower or some other target left, and if the enemy still kept on firing from these targets, then my mission would be to destroy these targets when the unit commander gave the order. Or if a mine failed to explode, then I would have to replace it with mine. I carried out my order well. We couldn't destroy the enemy because the assault group was slow. The commander saw that it would be disadvantageous for us to continue the fighting, so he ordered me to cut off the wire of the mine and to withdraw. I

observed discipline well during the withdrawal.

Seventh Battle: Attack on Cau Do Post

Eighth Battle: Attack in Kim Son

Ninth Battle: Attack in Binh Duc

Tenth Battle: Attack on Song Thuan Bridge

Eleventh Battle: Attack on Cau Ca Quoi

I did my best to carry out the resolution from above, but failed to carry out my task because the first comrade to detonate the mine was too slow, and when I rushed forward to plant the mine that I carried, the blast of his mine threw me some distance away and I couldn't get up to plant my mine. Even though I couldn't carry out my order I wasn't criticized for it, because the fault wasn't mine.

Attack on the Song Thuan bridge. Another comrade and I had the mission of detonating two C 8-kg bangalores on the main support columns of the bridge. We destroyed one span of the bridge. I didn't commit any errors while carrying out my mission. I maintained secrecy during the withdrawal.

Attack on the Cau Do post. I was assigned the task of destroying the first fence. Even though the mine failed to explode I still completed my task. I withdrew with the cell in an orderly manner and maintained secrecy.

Attack on the Kim Son post. I was assigned the task of destroying the first fence. I maintained secrecy while approaching the target and completed my mission. I implemented the resolution faithfully during the attack as well as during the withdrawal.

Attack in Binh Duc. I detonated a mine to destroy the Binh Duc post. I tried my best and succeeded in carrying out my order in line with the plan of attack.

III. Shortcomings During Combat

I lost 50 m of wire and five batteries during the attack on Tan Hoi post. During the attack on the Cau Ca Quoi post, I was over-confident and did not observe the tactic of attacking with bangalores. I came too close to the target, and when the first mine exploded I was knocked out by the blast and couldn't detonate mine. I acted in too great a hurry.

IV. Shortcomings and Good Points During the General Activities of the Unit.

Good Points. I observed the time schedule of the unit, and the discipline of the unit. I studied military and political subjects diligently. I performed production tasks, and helped the people. But generally speaking, I didn't observe all the regulations in the unit.

Shortcomings. Sometimes I failed to observe the regulations and the time schedule of the unit.

V. Unity Within the Unit and Between the Unit and Other Friendly Units.

Good Points. I observed the spirit of unity within the unit in everyday life as well as in combat.

Shortcomings. Sometimes I lost my temper with my comrades in our everyday life.

I observed the spirit of unity with our friendly units, in combat as well as when we camped close to each other.

VI. Commendation and Discipline.

<u>Discipline</u>. I violated discipline and quarreled with the comrades in my squad. I was criticized by the platoon and my errors were made an indoctrination subject for the platoon.

Commendation. I was awarded a letter of commendation by Region II, and was recommended three times for commendation in front of the platoon -- the first time for my performance in the attack on the Xom Buon post, the second time for my performance in the attack on the An Thanh Thuy post, and the third time for my performance in the attack on the Tan Binh post. The higher authorities had agreed to enter my performance in the attack on Tan Binh post in the second Ap Bac Emulation Campaign.

The enemy platoon was going to Bo Xe Hamlet to conscript the people and force them to build Strategic Hamlets. The District Local Force with which I participated in the attack wiped this platoon off the map -- this attack took place on July 20, 1963. After that I volunteered to join the Phuoc Thanh Village unit in Chau Thanh District. I was sent to the Province Engineering Unit, and was trained on the job by Thanh Thanh, Tu Hien and Sau Thai.

While I was with the Province Engineering Unit I took part in an attack on a GMC truck at the end of November 1963. The truck was completely destroyed and eight enemy soldiers were killed. But afterward they released me and allowed me to join their armed forces. A month later, I was contacted by letter once and told to manage to get assigned to the village post. But I could not do it right away, because I was still attending a training course. Before I could get assigned to the village post, the enemy night patrol unit which I was in was attacked by the Go Cong District Local Force. I threw down my weapon and surrendered.
