OBSERVATIONS (LESSONS LEARNED)

A. Utilization of air splint in the combat sones

DISCUSSION: Orthogenic Surgeons at the 8th Field hos; ital have noted that many combat casualties arriving here are inadequately splinted. Instead of air splints, Field Medics are either using the wire ladder and board silint or none at all. . . ire and lidder silints ere bulk and do not adequately ismobilize the joints above and below the bone fractured. The air splints are easy to apply with minimum. manipulation of the extremity, are designed to properly inmobilize any extremity fracture other than funoral, and are light and compact and could be easily carried in adequate numbers to meet the demands of a mass casuily situation. The ease of application would encourage the medics to use the splints on suspected fractures which are often not splinted. The immobilizing and cushioning effect of the air splint would add to the ratient's confort. Supply could be simplified by using the long leg splint for all frectures of the lower entretities.

OBSLRVATION: Lecause of the L.ck of supply or lack of treining, the medically superior air splints are not being used on rotients arriving at the 8th Field Hospital.

B. Prisoner of War latients

DISCUSSION: The 8th Field Hospital treats 10% patients until only minimum follow-up attention is required. Unlike U.S. Latients, who are further evecuated for long term convalascense, some POM's remain it this hospital longer than 3 months. Except that many are in casts, FOW patients present the same administrative problems as other POW's. The average hospital is not constructed or organized to carry out the normal activities of a FGW comp, however this hospital has experienced no attempted escares. Installation of ters to separate ION's from other patients is not a satisfactory solution because IOW's must leave the word for certain purposes such as ; sing to the latrine.

OBSERVATION: A centralized IOW medical holding com any specifically organized and constructed for holding IOW's after initial treatment would free beis at this and other hospitals. A centralised facility would make it a sier for specialized personnel to a ploit the favorable effect of good treatment being offered FOW's.



Prisoner of War Patients: A single medical holding facility augmented with Vietnamese speaking guards and PSYWAR personnel should be established for holding POW patients who are not yet medically ready to be turned over to ARVN authorities. POW's should be evacuated to such a facility as soon as their medical conditions permit.

1. Forwarded is the Operational Report - Lessons Learned for Period Ending 30 April 1967 in corrected format from the 8th Field Hospital, J.PC 96240.

2. The following comments are made concerning Observations and Recommendations in Section II, Part 2.

a. The use of the air splint is not commonly practiced in Viet Nam. The recommendation is considered valid and should be forwarded to the medical Field Service School for consideration in its training program.

b. Prisoners Of Mar in this zone are transferred through Frovost Larshall Channels to the ARVA POJ Compound, Pleiku. Because of the limited medical care available at Pleiku, it is necessary that wounded PON's be retained in Army Hospitals until only minimal medical care is required. As reflected in statistics shown in para I, Section I, often POJ's occupy beds for periods in excess of 60 days. Certain individual cases have been held for 4-5 months. It is the understanding of this headquarters that the 44th Medical Brigade intends to devote portions of a Medical Company (CLR) to the care of POJ's in the near future. This action would free 25 beds at the 5th Field Hospital and 5 beds at the 91st Evacuation Hospital.

1. This headquarters has reviewed the Operational Report-Lessons Learned for the period ending 30 April 1967 from Headquarters, 8th Field Hospital as indersed.

2. Pertinent comments follow:

a. Reference item concerning use of air splints, Section II, part I, paragraph a; paragraph 2a, 1st Indorsement and paragraph 2a, 2d Indorsement: Wonconcur. The initial supply of air splints were to be used for testing the item. Unfortunately evaluation reports were not returned in sufficient numbers or with sufficient information upon which to base a valid conclusion. While most reports were favorable, some problems with the air splints were encountered. A plan for a controlled retesting is under consideration. In the meantime, standard methods of splinting which have stood the test of several wars are still acceptable. The supply of these splints is adequate.

b. Reference item concerning prisoner of war patients, paragraph B, Section II, part I; paragraph B, Section II, part II; paragraph 2a, 1st Indorsement and paragraph 3, 2d Indorsement.

(1) Concur.

(2) Establishment of a FW hospital facility would free a significant number of beds for use by other category patients requiring intensive medical treatment. Additionally, a centralised FW hospital facility would provide for more effective control of FW hospital patients requiring minimum treatment and would allow for more economical and efficient utilisation of military police guards.

(3) The PMO, USARV, has coordinated with representatives of the 44th Medical Brigade and the USARV Surgeon's Office relative to the site layout plan and physical security requirements for a proposed PW hospital facility to be constructed at Phu Thanh, Vietnam.
