

Mentor Protégé Program Reauthorization Updates

- Reauthorize Mentor-Protégé Program
 - On Sept. 25, 2018, U.S. Rep. Sheila Jackson Lee (D-Texas) introduced legislation, H.R.
 6875, that would reauthorize the DoD Mentor-Protégé program. The bill was referred to the House Armed Services Committee
- > Scheduled to meet with congressional staffers to discuss the reauthorizations and recommended changes to the program
- > Mentor Protégé Agreements during reauthorization period
- ➤ Kick-Off for the 2019 Mentor Protégé Program conference will start in March timeframe



2019 Nunn-Perry Award Nomination

➤ Nunn-Perry Award Update:

- Late-January we completed adjudication of the Nunn-Perry Award Nomination Packages
- Received a total of 21 packages, including 2 credit agreements
- Very close competition with strong submissions
- We will release the results 2019 Nunn-Perry selection on 18 February 2019
- > This years Nunn-Perry candidate submissions display a great examples of companies who are making major contributions to the defense industrial base



Mentor Protégé Data Base Highlights

▶ MPP Data Base Capability:

- Automate the mentor application process
- Reduce the timeline between mentor application submission and approval
- Automate the mentor protégé agreement application process
- Enable the mentor to customize mentor protégé agreement applications by selecting amongst the various service offerings of HBCUs/MIs, PTACs, and SBDCs
- Enable Program Managers and Mentors to store and reference important agreement documents
- Enable Program Leadership to conduct historical and up-to-date analysis on the program by running reports and looking at programmatic metrics

National Defense Authorization Act 2018

- ➤ In Section 851 of the Act, Congress requested the department to address the following four areas:
 - 1. Ensure Small Business Programs Further National Defense Programs and Priorities
 - 2. Improve Small Businesses Points of Entry into Defense Market
 - 3. Enable and Promote Coordinated Outreach to Small Businesses
 - 4. Create a Unified Management Structure

Improve Small Business Points of Entry Into Defense Market

Engaging on Policy and Process

- Developing the right types of legislation, regulation and policy that reduces entry for small businesses
- Track the involvement of small business professionals in acquisition strategies and peer reviews for major procurements

▶ Utilizing Tools, Technologies, and Data

- Acquisition professionals can utilize to streamline how they conduct market research, track performance management and run comparative analytics
- Utilize data analytics to effectively measure performance across North American Industry Classification System (NAICS) and Product Service Codes (PSC)
- Develop big data tools that will measure the impact of policy initiatives on small business performance



Enable and Promote Coordinated Outreach to Small Businesses

> Improve Outreach and Communication

- Establish targeted outreach events (APBIs, Industry Day, and Technology Demonstrations)
- Strengthen partnership with the Procurement Technical Assistance Center
- Engagement from senior leadership across the Department promoting Small Business

> Address Small Business Cybersecurity Challenges

- Work with Department cybersecurity components and utilize both regulatory and voluntary programs to improve small business cybersecurity readiness and DFARS compliance; and
- Develop mechanisms to create roadmaps and threat assessments for small businesses to improve cyber security posture

Protect Small Business Intellectual Property

 Work with government and industry partners to enhance communication and outreach to small businesses about current intellectual property education programs

Create a Unified Management Structure

- ➤ The Department began progress to implement a unified management structure in early 2017 as a result of Section 901 of the National Defense Authorization Act 2016
- ➤ The Under Secretary of Defense for Acquisition, Technology, and Logistics (AT&L) was divided into Undersecretary for Research & Engineering (R&E) and an Undersecretary of Defense for Acquisition and Sustainment (A&S)
- ➤ In this new structure, the Department of Defense Office of Small Business Programs resides within the Undersecretary of Defense for (A&S) as a part of the Industrial Policy



Four Key Messages

- > Proactive approach to strengthen industrial base and defense supply chain
- > Focus key innovation programs for small business participation
- > Develop the right tools for acquisition professional
- > Streamline policy and regulations where appropriate

- Follow-Up Reviews For Marginal And Unsatisfactory Ratings





Vistra Energy Overview



Vistra Existing Generation and Retail Presence



Vistra Energy (NYSE: VST) is a premier, integrated power company based in Irving, Texas, combining an innovative, customer-centric approach to retail with a focus on safe, reliable, and efficient power generation.

Current System and Short Comings



This presentation is going to delve into solutions for two Corrective Action Plan items for Vistra Energy as a result of the 2016 audit.



Vistra Energy uses the UNSPSC (United Nations Standard Products and Services Code) accounting system, while we need to use NAICS to be in compliance with SBA reporting.

- Proposed Solution: <u>UNSPSC to NAICS Code Conversion</u>
- Inability of suppliers to fully and accurately identify all NAICS codes associated with their product/service to determine small business size status resulting in inaccurate SBA reporting for Vistra Energy
 - Proposed Solution: <u>Self Certification With SBA Size Standard Table</u>

UNSPSC to NAICS Code Conversion



 Mapped UNSPSC codes to NAICS codes allowing us to convert our UNSPSC coding system into the NAICS coding system.

 Mapping allows companies to use UNSPSC systems and map to NAICS systems without making significant technology investments







Self Certification With SBA Size Standard Table



• **Issue:** Confusion on supplier's part as to how to navigate the SBA website and SBA Size Standard Table based on NAICS Code to determine if they are Small or Large.

 Solution: Changed Self Certification online form to ask a supplier for their Employee Count (12 months average) and Revenue (three year average). We then match their size elements against the SBA Size Standard Table to see which NAICS codes are valid for SBA spend reporting. This takes the burden off the supplier having to search through NAICS codes and also increases the accuracy of auditable reporting.








