Hypothesis is that caregivers in REACH will improve in depression, burden, anxiety, frustrations, and management of Veteran problems. Data collected at baseline, 3, and 6 months.

During this year, 47 potential participants have been screened, 66 participants randomized, 66 participants had baseline interviews, and 70 participants had 3 month follow up interviews, and 76 participants had 6 month follow up interviews. All data so far have been entered.

Cumulative, 226 potential participants have been screened, 163 participants randomized, 163 participants had baseline interviews, and 152 participants had 3 month follow up interviews, and 147 participants had 6 month follow up interviews.


