SUBJECT: Nuclear Warfare: A Selected Bibliography

1. The latent threat posed by nuclear weapons, be they strategic or tactical, has dramatically captured world thinking in the latter half of the Twentieth Century. Hardly a week goes by without a major publication appearing, addressing one or more facets of the problems associated with nuclear weapons. The amount of available printed materials is virtually overwhelming.

2. The purpose of this selected bibliography is to provide the student of nuclear warfare a starting point for his research of the subject. By design, the bibliography does not contain publications dealing with arms reduction/ limitations negotiations nor civil defense. However, the publications listed are located in the US Army War College Library and do provide a broad background of information for those individuals interested in nuclear warfare and the evolution of nuclear strategies over the past decade.
