

1. introduction

Public participation and information has been on on-going element of the GREAT I Study since its beginnings in 1974. Since 1976 Public Participation Program staff work has been carried out by the consulting firm of Dan McGuiness & Associates under contract with the GREAT I Team via its fiscal agent, the St. Paul District, U.S. Army Corps of Engineers. This report covers the contractor's work for the period November 7, 1978 through October 31, 1978.

During the above-referenced period, the contractor continued providing staff services to the Public Participation and Information Work Group (PPIWG), provided information to the public as needed, prepared and published a Soundings newsletter, maintained a study information library, and worked closely with the PPIWG Executive Board in preparation of a draft and final Position Paper on the entire range of GREAT I Study issues.

As a report of the <u>contractor</u> the contents do not necessarily have the endorsement of the Public Participation and Information Work Group of GREAT I. The work group's executive board, however, will be asked to review the report and provide comments to the contractor. As such, the report also serves as a discussion paper for use by GREAT I in the formulation of work group programs for the balance of the study.

2. activities & accomplishments

The activities of the contractor are based upon two directives. The first is the <u>Scope of Work</u> as contained in the contract between the firm of Dan McGuiness and Associates and the St. Paul District, U.S. Army Corps of Engineers. Appendix A contains that Scope of Work. The second is the FY 1978 <u>Plan of Action as adopted by the GREAT I</u> Public Participation and Information Work Group (PPIWG) Executive Board (see Appendix B). Since the contractor serves both GREAT and the citizens, both have a role in guiding the contractor's efforts. The following information is provided as a summary of work accomplished under the two aforementioned directives. Information is arranged to be consistent with the tasks as outlined in the Plan of Action.

WORK GROUP TASK 1

Dredged Material Site Review

During FY 1977 the PPIWG was extensively involved in reviewing dredge material placement sites; the evaluation to be used in forming a channel maintenance plan. In FY 1978 the PPIWG continued active involvement in the process of channel maintenace plan development as follows:

* February, 1978 Channel Maintenance Plan Workshops: On the dates of February 8th and 9th, 1978 the contractor conducted two workshops in St. Paul, Minnesota and Winona, Minnesota, respectively. The workshops were open to the public and written invitations were sent to all PPIWG members with invitation to the general public via media releases. At the workshops citizens were asked to evaluate dredge material placement method preferences and criteria preference. A report containing citizen evaluations was transmitted to GREAT by memo of March 13, 1978.

* April, 1978 Pool Placement Site Review Meetings: Subsequent to the above-noted meeting the contractor held 5 public workshops throughout the GREAT I Study area for the purposes of reviewing dredge material placement alternatives on a pool by pool basis. Those meetings were as follows:

At these workshops citizens were given the opportunity to express their opinions about specific disposal sites and placement methods. All members of the public were notifed via written invitation or through the media. A report summarizing citizen input was sent to GREAT I via memo of May 9, 1978.

*Involvement in the channel maintenance planning effort since May has been limited to monthly updates for the PPIWG Executive Board, and direct involvement by the PPIWG staff (contractor) on behalf of the public.

WORK GROUP TASK 2

On-Site Inspection Program

During the 1978 dredging season the contractor and, at times, members of the general public attended on-site inspection team meetings for the purpose of having direct input into the dredging and material placement review process. To date the PPIWG has had representation at the following OSIT meetings:

Attendance at these OSIT meetings allowed for direct public participation in OSIT recommendations for dredging and disposal of actual dredge operations. While OSIT recommendations do not carry the weight of law (they only serve as recommendations to the Corps) public involvement helps to assure public values were considered in making those recommendations.

Assist GREAT in Reviewing ED and EQ Plans

During the period covered in this report the GREAT I Plan Formulation Work Group has not yet carried out a formal evaluation of the channel maintenance plans or river resource management alternatives for economic development and environmental quality accounts. Therefore, there has been no formal public input under this task. The PPIWG representative to the Plan Formulation Work Group has, however, been active in establishing the evaluation criteria and process through attendance at regular Plan Formulation Work Group meetings and as a member of a special Channel Maintenance Plan Task Force.

WORK GROUP TASK 4

Assist in Review of "Without" Plans

During the period covered in this report, the GREAT I Plan Formulation Work Group has done only minimal work in the development of a "without plan". GREAT's <u>Interim Status Report</u> dated March, 1978 mentioned on pages 60-64 some potential results of proceeding to operate "without GREAT". Through review and comment on the <u>draft</u> Interim Report (in FY 1977) the public provided some input concerning this subject. Major public input cannot take place until the GREAT I Plan Formulation Work Group issues more detailed information. Thus completion of this task will not occur until FY 1979.

WORK GROUP TASK 5

Continue Use of Coordinator and Office

During this phase of the contract the contractor has maintained a Public Participation Headquarters located at 149 Main Street in Wabasha, Minnesota. The office was staffed by a Coordinator, Assistant Coordinator, and additional support staff. The office provided meeting space for visitors, contains a library of all GREAT documents, minutes, reports, etc., and serves as an information referral center. Regular office hours were maintained and the staff was available full time during normal business hours to assist the public. The contractor, in addition, spent considerable time travelling to meet with individuals, organizations, and local government groups. The staff prepares and produces "in-house" a newsletter with regular distribution via the Corps of Engineers mailing system, and transmits information to the public on a regular basis. For the period November 7, 1977 through October 31, 1978 the contractor has provided a total of 2,484.75 hours of professional staff time and 824.75 hours of secretarial staff time to the GREAT I effort.

As part of the contractor's public information efforts, its staff has worked with the news media in the study area. Currently all known media outlets are informed about meetings and special events. Throughout the study to date the GREAT Team has had periodic exposure in the media, and the contractor will continue this program until completion of GREAT.

In an effort to provide information and obtain input from organized groups in the study area the PPIWG staff has offered to meet with them and obtain their comments. To date, the staff has attended meetings of the following groups at their invitation.

In performing the duties for GREAT I the contractor's staff travelled 12,569 miles by auto plus air travel during the contract period November 7, 1977 - October 31, 1978.

WORK GROUP TASK 6

Evaluate Information Function of Plan Formulation Work Group

A long-standing concern of the public in 1977 and early 1978 has been the lack of basic information available to the general public from GREAT. This matter came before the PPIWG Executive Board in the form of a recommendation from the contractor on February 9th, 1978. The contractor recommended that he take over the layout, writing, and physical preparation of the <u>Soundings</u> Bulletin with preparation costs to be borne by the contractor under the existing contract. Further, that the Corps of Engineers take the finished product and mail to the 2500 member mailing list using their own mailing facilities and computerized mailing label service. The PPIWG endorsed this recommendation. The GREAT I Team, at their April 5 meeting

also endorsed this proposal. As a result of these actions the Contractor has published Soundings as follows:

The contractor plans to continue publishing Soundings in FY 1979. The PPIWG will continue to monitor GREAT's public information efforts and make recommendations as needed.

WORK GROUP TASK 7

Assist in Planning Town Meetings

In addition to the Channel Maintenance Workshops noted under Work Group Task 1, the contractor has held one special town meeting:

WORK GROUP TASK 8

Assist in Developing Specific Links with Public

During this contract phase the contractor continued to work with the previously formed PPIWG Executive Board, a group of citizen-volunteers representing a cross-section of citizen interests (see Freface). Through this executive board GREAT has attempted to maintain an open line of communication with those groups and individuals with a high degree of interest in GREAT. The board has met frequently (see below) to obtain information and submit input to GREAT. A major product of the board (and one which was a result of many, many hours of volunteer time) was a draft and final <u>Interim Position</u> <u>Paper</u>. This paper consolidated and summarized all citizen input to date and listed interim positions on all major preliminary recommendations and conclusions by GREAT to date. The contractor printed and transmitted over 500 copies of this report to citizens, legislators, and agency people. Other accomplishments and input of the board is listed in Appendix C.

WORK GROUP TASK 9

Develop Broad Public Information/Participation Program

All of the activities summarized in work group tasks 1-8 represent the implementation of this task. The contractor, through a combination of staff activity, executive board activity, the newsletter, public meetings and workshops, and reports (including this one) to the team and public has provided a comprehensive public information/participation program as required by the Water Resources Council and endorsed fully by GREAT.

3. contractor's recommendations

Within the context of the contractor's Scope of Work, the objectives of the PPIWG, and based upon a review of the past year's activities and accomplishments, the contractor makes the following recommendations to the GREAT I Team:

- 1. In the last year of the study (FY 1979) GREAT should continue to fund a full time independent PPIWG headquarters with a minimum of 2000 manhours of staffing by the contractor.
- 2. The contractor should continue to attend as many work group and GREAT meetings as possible to keep current on work group positions, findings, etc., and to provide direct input from the public at the work-group level.
- 3. PPIWG Executive Board meetings should continue to be held as needed to provide detailed public review of GREAT products and subsequent input as the Team prepares a draft and final GREAT report. Meeting schedule will be dependent upon GREAT's actual product completion dates. The contractor should continue to inform all members of the PPIWG (now about 400) of all meetings and all PPIWG members should continue to receive PPIWG minutes.
- 4. A special public review of GREAT I work group draft appendicies, recommendations and product, should be held by the PPIWG in January, 1979. This should be done in the form of a workshop at which the public as well as GREAT I Team and work group members attend. Findings generated at this workshop should be published and considered by GREAT in the preparation of its draft final report.
- 5. Upon completion of the <u>draft</u> final report by GREAT the contractor and GREAT should jointly sponsor a series of no less than 3 and no more than 6 Town Meetings for purposes of presenting a summary of findings and obtaining public input. Upon completion of the meetings the contractor should prepare a Town Meeting Report summarizing citizen input. Contents of said report should be reviewed by GREAT to consider modifications for the final issue of the final report.
- 6. The contractor should continue to meet with the general public to provide information and obtain citizen input. Executive board members should assist, where possible, in this effort.
- 7. Transmittal of work group meeting agenda's, minutes, and relevant papers directly to the PPIWG Executive Board should continue until end of GREAT I as it has been demonstrated that this is the most effective and efficient way to inform the board so that members can provide input based on an informed mind.

- 8. The contractor should continue to prepare and print <u>Soundings</u> until end of GREAT as a major public informational tool. The Team, however, should consider a major public information effort to expose the public to the Téam's draft report contents. This should be done "in-house" or through a contract modification to Phase D of the PPIWG Program Services contract. Further, upon completion of GREAT Final Report publication, a major public information program should be carried out to inform citizens of the final recommendations and conclusions of GREAT I.
- 9. The contractor notes that one of the major products of the PPIWG program in FY 1978 was a Position Paper on GREAT. This paper should be thoroughly reviewed by all members of the GREAT Team and work groups and given <u>serious</u> consideration by GREAT as it writes its draft documents.
- 10. The contractor notes that the matter of reimbursement of citizens for participation in GREAT continues to be a major citizen/team issue, with diverse opinions presented in both sectors. The contractor, in its Phase B Report, noted that funding citizens "is not essential to participation in general ... ". The U.S. Army Corps of Engineers has determined that reimbursement to citizens for participation in GREAT is no longer allowable as it is not done on other Corps study efforts. The contractor still maintains that reimbursing citizens will not substantially increase citizen participation. However, based on the contractor's discussions with citizens during FY 1978 it does recognize that, in principal, citizens should not be barred from participation due to cost of travel to citizen meetings or team or work group meetings. This stand is further enhanced when it is known that agency representatives, in fact, are so reimbursed. Finally, it is known that while lobbying groups are capable of paying the costs of lobbying for or against an issue, individual citizens must bear the expenses of their efforts from household funds. This results in an inequality in the ability to influence the decision making process - one inherent in our democratic free-enterprise system. The contractor has no solution to offer other than to, suggest that individuals who must bear costs out of household expenses attempt to organize themselves or align themselves with interest groups who do have funds to lobby, a second alternative is to obtain a change in existing law or rules.

It is uncertain as this report goes to press, what will happen on this on FY 1979.

- 11. In early FY 1979 emphasis should be placed on obtaining specific input from the public on the work group products. After publication of a draft final report major emphasis should be given to widespread public review of the draft documents and concise input on same back to GREAT from the public.
- 12. Finally, the contractor recommends that the Team explore ways to continue citizen involvement after completion of the GREAT Final Report is transmitted to Congress to provide a means for citizens to monitor implementation efforts.

4. summary

Fiscal year 1978 was a year of diverse activities; intense public participation in the development of material placement plans; active representation at several meetings by PPIWG staff; and a long and hard process of writing a major position paper. The executive board, still a group of citizens of diverse interests, had the opportunity to become intimately involved in the study. For the executive board citizen involvement was almost a daily activity. Evidence of the thoroughness of the executive board's work can be seen in the comprehensive nature of the position paper it produced. The executive board, as representative of many broad interests, will continue in FY 1979 to be intensely involved in detailed analysis of GREAT products and resultant recommendations to GREAT.

As the Study goes into its final year, citizens recognize that their support or lack of same will become more meaningful. As noted years ago the true test of citizen input will occur when the final report goes to Congress. If, in fact, there is strong citizen support, individual Congressmen will have a base from which to push for implementation. If support is lacking, Congressmen will respond in kind. It will be most important for GREAT to keep its "ear to the ground" to assure that the final report is a supportable document - not just technically, but politically (for lack of a better word).

The contractor has observed that GREAT has come a long way in the last year toward defining its end product. Public input has been a major element of GREAT in FY 1978. The opportunity for input was provided. Many accepted. The final question for 1979 is: "Will the input be heeded?" The <u>credibility</u> of public input will certainly be addressed by GREAT. That input found to be credible <u>must</u> have an effect on the final report. If not, there must be a credible reason "why not". FY 1979 will be a year in which GREAT's findings will be thoroughly exposed via a draft report. Will the report withstand the test of public involvement? Will the public be able to underwrite the report as it goes to the agency heads and Congress?

APPENDIX A

SCOPE OF WORK

Phase C for Contract No. DACW37-76-C-0185

Coordination of the public participation program of the Great River Environmental Action Team (GREAT I).

The contractor will be required to continue coordination of the public participation program with other aspects of GREAT I. The coordinator will also assure public representation at Team and Plan Formulation Work Group meetings. The coordinator will act as staff of the Public Participation and Information Work Group and will continue efforts to broaden the public base of the study. Other work identified by the public and GREAT I as necessary to represent the public on the study will also be carried out by the coordinator.

In addition, monthly status reports will be required. At the end of phase C, the coordinator will present a written report presenting recommendations for necessary changes in the public participation program.
