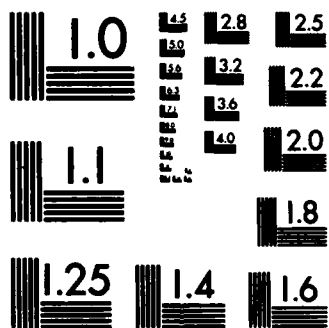

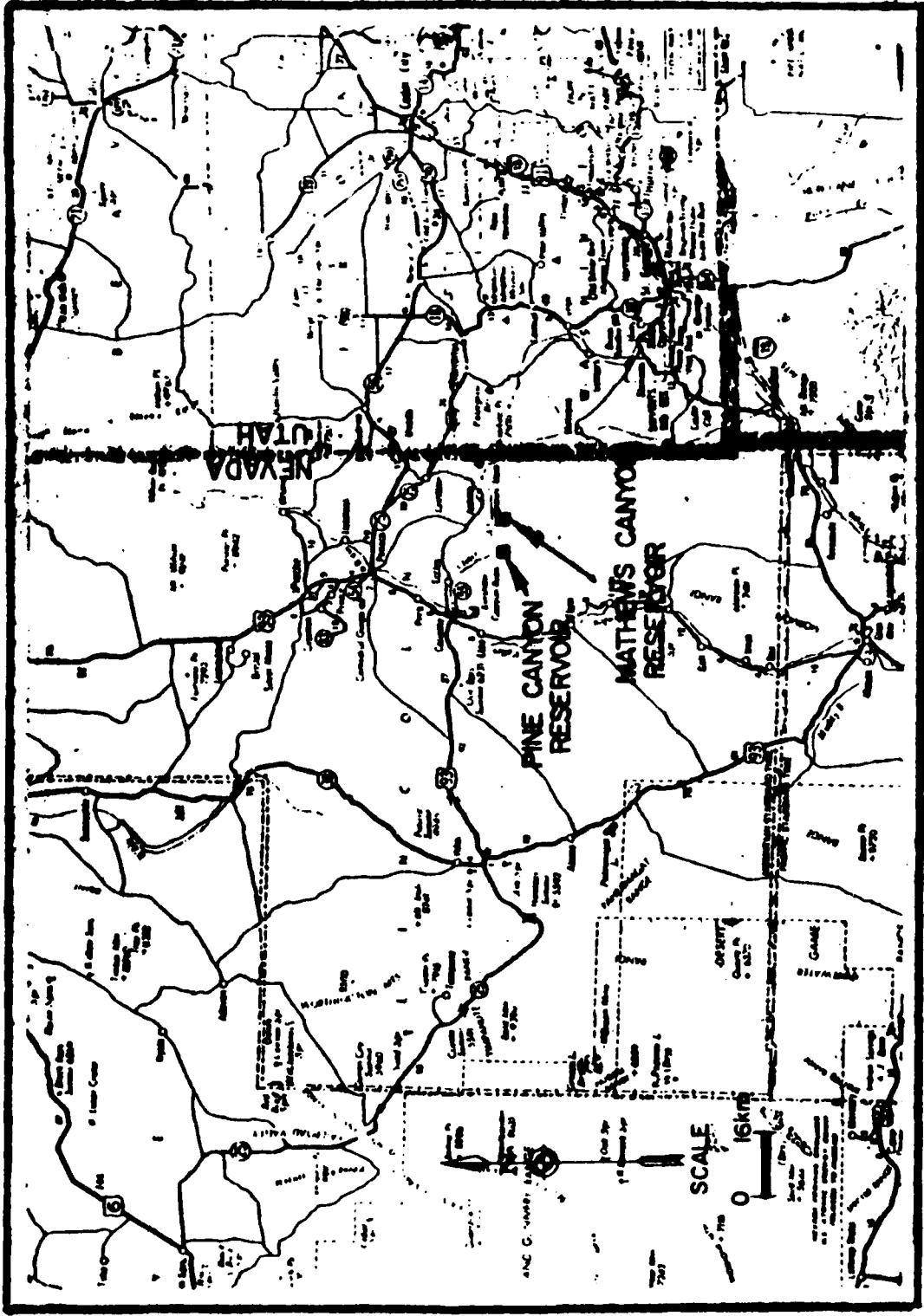

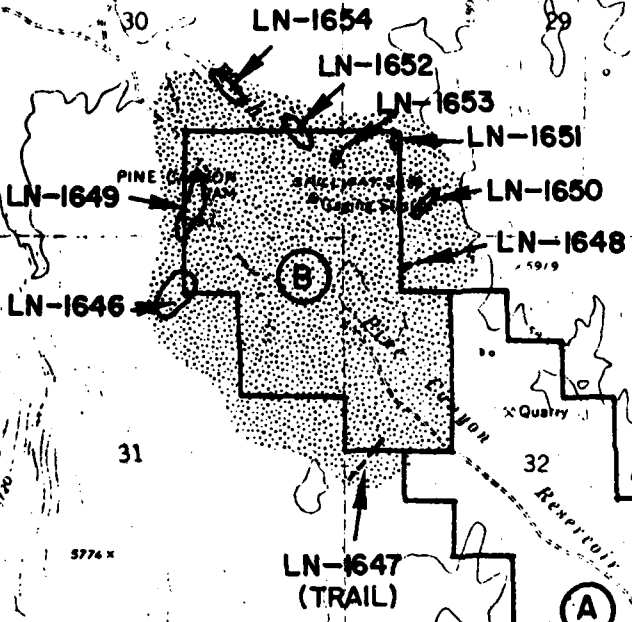

Map 1 - Pine Canyon Reservoir and Mathews Canyon Reservoir, Colorado River Basin, Nevada.

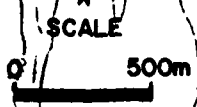


# PINE CANYON RESERVOIR

 — AREA SURVEYED

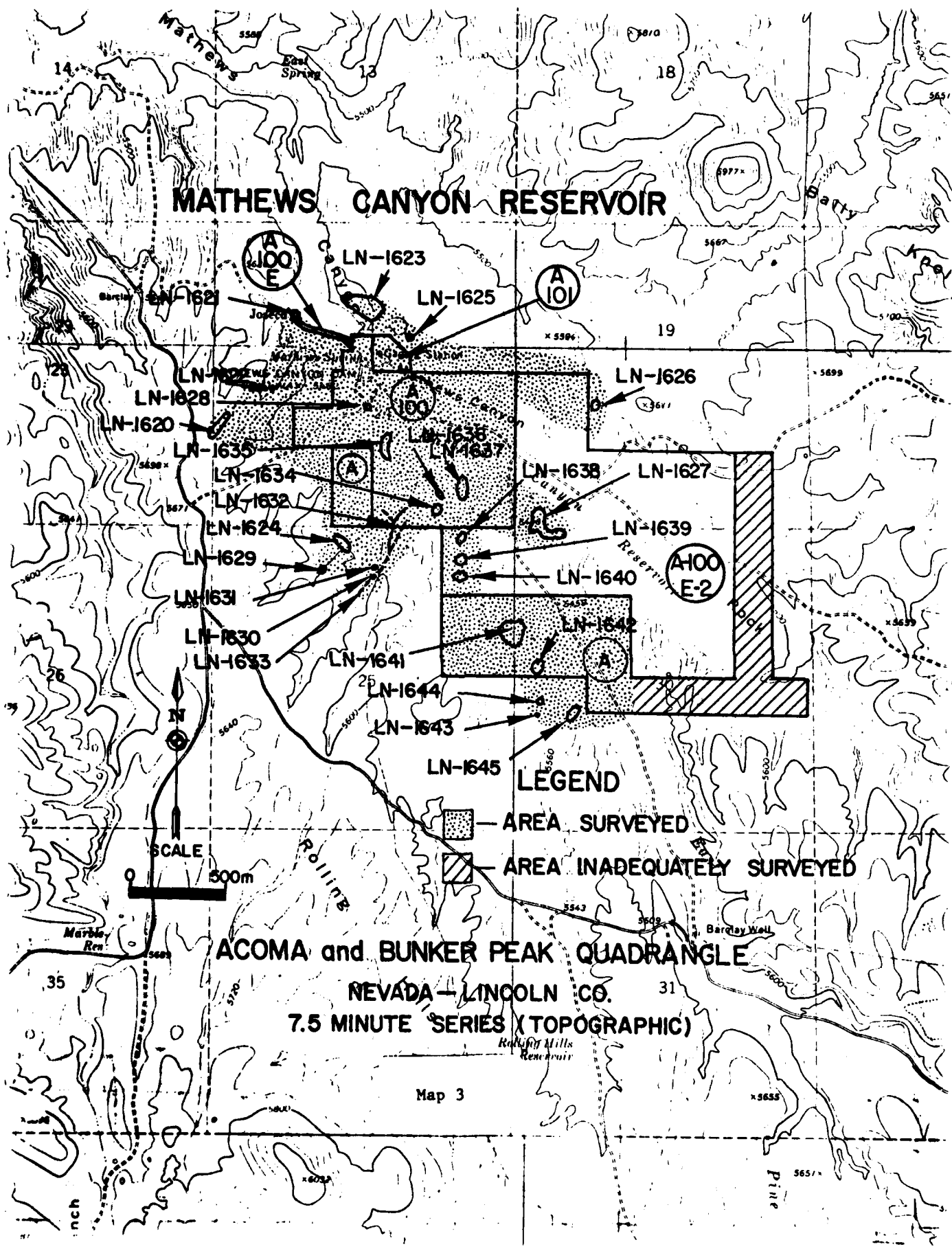
