The RTM does not provide traceability to the Table Identifiers (DF) in Appendix H of the SDD. However, this appendix does identify access of the CMOS Tables by CSUs. This is necessary to satisfy the CMOS functions recognized by the CSCs. Hence, it is most important that complete traceability be documented.
