Reconcile inconsistencies between previous design documents and current version of the STP.

RATIONALE:

This version of the STP introduces "TFs" at the single-digit level, that is, TF1, TF2, and TF3 are now part of the STP. There is no corresponding SC for these TFs in any of the SRSs or the SSDD. The addition of TFs at the CSCI level deviates from the practice of having a direct correlation between SCs and TFs, since the SRSs identify Applications, Communications, and System Environment as Configuration Items (CIs), not as System Capabilities.

Reconcile the consolidation of Shall Statements to the highest common level.

RATIONALE:

There has apparently been an attempt to test requirements at the highest level of structure that implements those requirements. In general, if two subordinate elements contained the same requirement to be tested, the requirement was deleted from the two subordinate elements and moved to the next highest level. This realignment affected Increment I requirements as well as those specific to Increment II. In addition, this process was not consistent in two related ways. First, two children of the same parent sometimes both have the same Shall Statement; for example, SS2171 is found in TF268, TF269, TF26A, and TF26C. Second, a parent and its children sometimes have the same Shall Statement; for example, SS2166 and SS2167 are found in both TF2 and TF22. If this realignment of SS#'s is to be employed, the numerous instances of these internal inconsistencies need to be resolved.
