Atlas of Tumor Pathology

Reporting Period: April 1, 1990 - September 30, 1990

This research grant is to provide the necessary editorial support to identify topics for future fascicles, invite recognized pathologists to serve as authors for these topics, to coordinate the receipt, review, and revision process for the authors' manuscripts, to copy edit the manuscripts for publication, and to prepare camera-ready copy of the text for printing at the Armed Forces Institute of Pathology. This work is accomplished with the advice of an Editorial Advisory Board of 11 anatomical pathologists, coordinated by the Editor, Dr. Juan Rosai, and the Associate Editor, Dr. Leslie H. Sobin, and executed by staff of the grantee.

During the reporting period, UAREP continued work on the final fascicle of the second series, Tumors of the Hematopoietic System. This activity involved typesetting 75 tables, formatting and placing the frames for 508 figures, and formatting text.

The final manuscripts for the first two fascicles of the third series were submitted to UAREP during this period. UAREP staff verified the references, correlated the figures with the text, sized the figures (approximately 300 per fascicle), labelled subcomponents of each black and white figure, solicited permission to use copyrighted material, and copy edited text and figure legends. UAREP contractors formatted and typeset the text and figures using either traditional methods or desk-top publishing techniques.

The formatted galleys were submitted to the authors for final corrections. Author changes were completed on one fascicle during this period, typesetting changes were completed, the terms in text and figures were indexed and typeset and front pages were prepared and typeset; camera-ready copy was submitted to the AFIP on October 1, 1990. Final revisions to the other fascicle were in process at the end of the grant period and were completed subsequently with delivery of camera-ready copy text, index, and introductory pages to AFIP on October 25, 1990.
