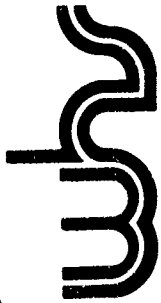

FOREWORD

Prime Contract Awards by Region and State is published annually. This issue provides information on the geographical distribution of Department of Defense prime contract awards over \$25,000 for Fiscal Years (FY) 1991, 1990, and 1989 by the United States region and state.

This information is detailed in ten tables and three figures showing

1. The net value and percent distribution of awards, by region and state, for FY 1991, 1990, and 1989.
2. The net value and percent distribution of awards within the seven major hard goods programs, by region, for FY 1991, 1990, and 1989.
3. The net value and percent distribution of awards in the 25 major procurement programs for each state for FY 1991, 1990, and 1989, and
4. The net value and percent distribution of awards for research, development, test, and evaluation by region and state according to the type of contractor for FY 1991, 1990, and 1989.

INTRODUCTION

This report contains a variety of data on the net value and percent distribution of DoD prime contract awards over \$25,000 within the United States, by region and state, for Fiscal Years (FY) 1991, 1990, and 1989.

This publication is divided into four parts: Part I, Net Value and Percent Distribution of DoD Prime Contract Awards Over \$25,000 by Region and State; Part II, Net Value and Percent Distribution of DoD Prime Contract Awards Over \$25,000 for Major Hard Goods; Part III, Net Value and Percent Distribution of DoD Prime Contract Awards Over \$25,000 by State; Part IV, Net Value and Percent Distribution of DoD Prime Contract Awards Over \$25,000 for Research, Development, Test, and Evaluation.

Prime contract data are not a means of measuring the total volume of defense work performed within a state, as a substantial amount of the work may be subcontracted.

Notes on Coverage

Contract work is not necessarily performed in the state where the contract is awarded. Most manufacturing contracts have been attributed to the contractor's location where the product will be processed and assembled. When contract work has been performed at more than one plant, the contract has been attributed to the location where the largest dollar amount of work was produced. Both construction and service contracts have been attributed to the state where the work is to be performed. Contracts for transportation and communication services in most cases have been attributed to the state where the contractor's home office is located. For purchases from wholesale or other distribution firms, the location is the contractor's business address.

Amounts not distributed by state include contract actions of \$25,000 or less, contract actions performed in classified locations, Foreign Military Sales (FMS) contract actions entered into overseas, and other contract actions for work performed in the U.S. outlying areas.

Some special characteristics of the data on prime contract awards by procurement program category should be noted:

1. The Electronics and Communication Equipment category includes all electronics procured separately under prime contract. However, in the case of Missiles and Space Systems or Aircraft Engines and Related Spares, electronics work is often a basic part of the assembly prime contract; therefore, awards for electronics are included in the statistics for these categories.
2. Contracts for all other types of equipment and parts for repair, maintenance, overhaul, modification, or other services, which can be identified with a specific category, are assigned to that category. As an example, the installation or inspection of equipment at ballistic missile sites is recorded as missile work in the state where the site is located. However, the contract for manufacturing such equipment is reported according to the location of the manufacturer's plant. Therefore, aircraft, missile, or other program contracts may be reported in states where there are no weapon assembly plants but where bases, laboratories, or suppliers of instruments, parts, or support equipment may be located.
3. The dollar value shown for each category includes the Research, Development, Test, and Evaluation (RDT&E) work associated with it. RDT&E coverage includes research, exploratory development, advanced development, engineering development, operational systems development, and management and support. Full definitions for each of these categories are provided in Federal Acquisition Regulation 35.001.
4. Figures in these tables may not add up due to rounding. An "*" in the percent column represents a figure of less than 0.05 percent.

Highlights

Total prime contract awards in FY 1991 totaled \$150,855 million, an increase of \$6,182 million or 4.3 percent more than FY 1990. Awards over \$25,000 for work performed within the United States, by region and state, are shown in this report. These awards totaled \$124,119 million in FY 1991. The kinds of awards not included in this report (see Notes on Coverage) are distributed as follows

PART I
NET VALUE AND PERCENT
DISTRIBUTION OF PRIME CONTRACT AWARDS
OVER \$25,000, BY REGION AND STATE

The U.S. regions are shown in Figure I-1 (page 4). The three regions that received the largest share of the awards in FY 1991 were the Pacific (22.2 percent), the South Atlantic (18.1 percent), and New England (11.2 percent). (See Figure I-2, page 5.) Those regions that make up the eastern part of the United States received awards totaling \$66,917 million or 53.9 percent. The western regions received the remaining \$57,202 million or 46.1 percent of the awards.

Table I-1 (page 6) shows the net value and percent distribution of awards, by region and state, for FY 1991, 1990, and 1989. The regions with the largest percent increase in the net value of prime contract awards from FY 1990 to FY 1991 were the East South Central, up 25.6 percent; the East North Central, up 13.7 percent; and the West South Central, up 7.4 percent. Conversely, the regions having the largest percent decrease in the net value of total prime contract awards from FY 1990 to FY 1991 were Mountain, down 17.3 percent; New England, down 2.6 percent; and the South Atlantic, down 2.1 percent. The three remaining regions had award changes in FY 1991 ranging from 5.8 to -0.2 percent.

Of the individual states, South Dakota had the largest percentage increase, \$89 million or 251.1 percent, while West Virginia had the largest decrease, \$73 million or -32.2 percent. Eleven other states had award increases of 20 percent or more; five other states had award decreases of 20 percent or more.

The following ten states had the largest percentage change in procurement award dollars from FY 1990 to FY 1991 (shown from largest percentage increase or decrease to smallest percentage increase or decrease).

CENSUS REGIONS

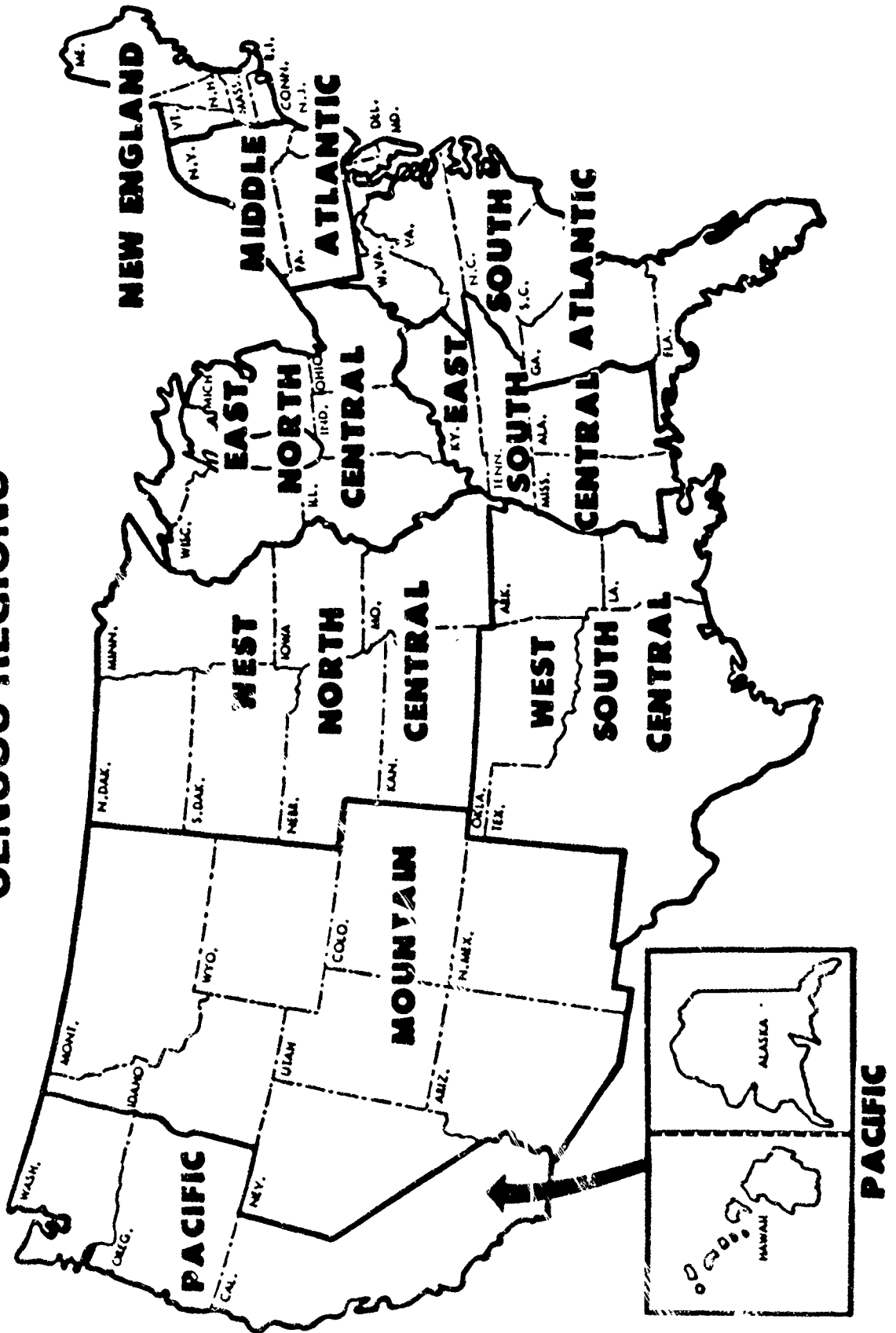
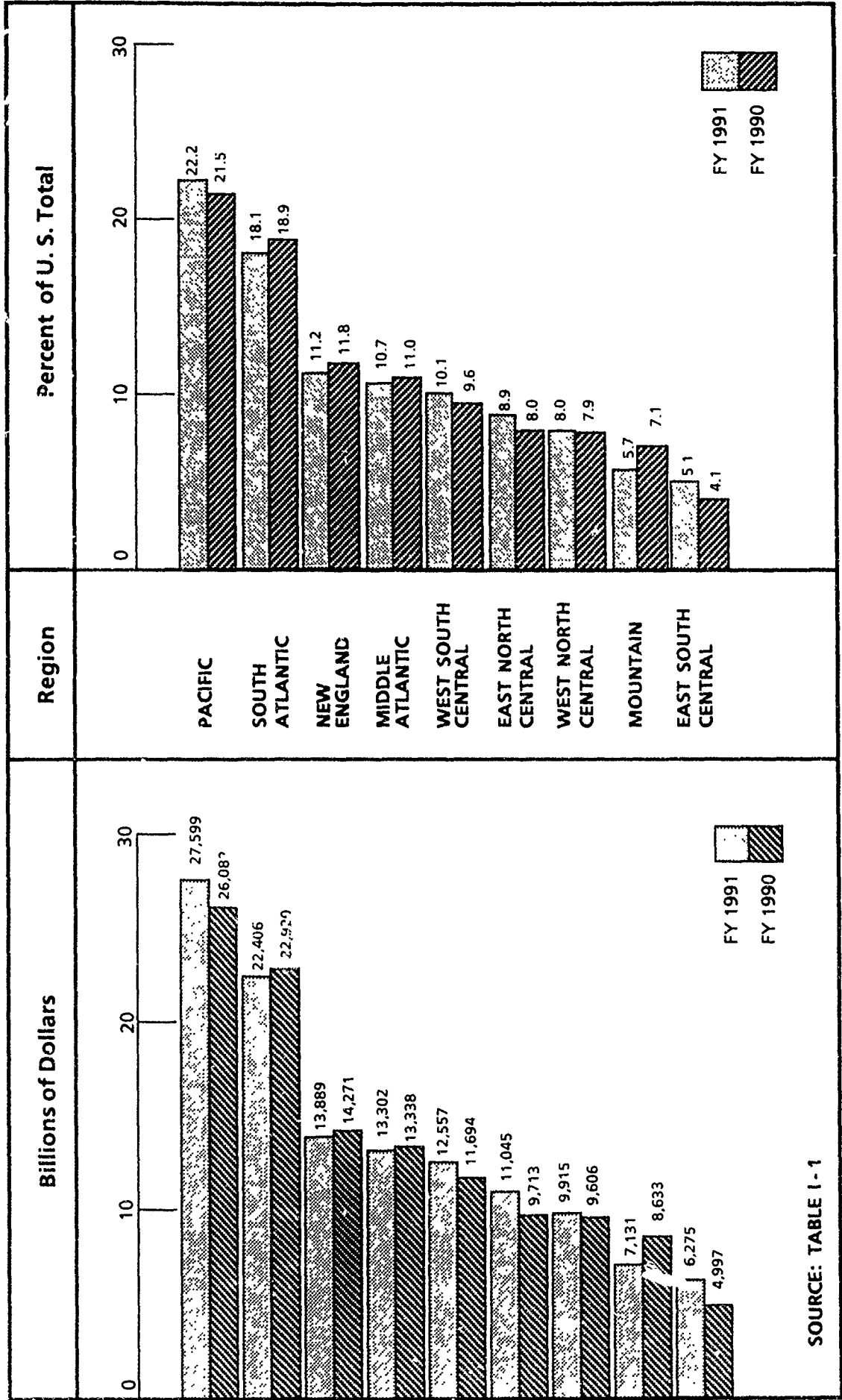

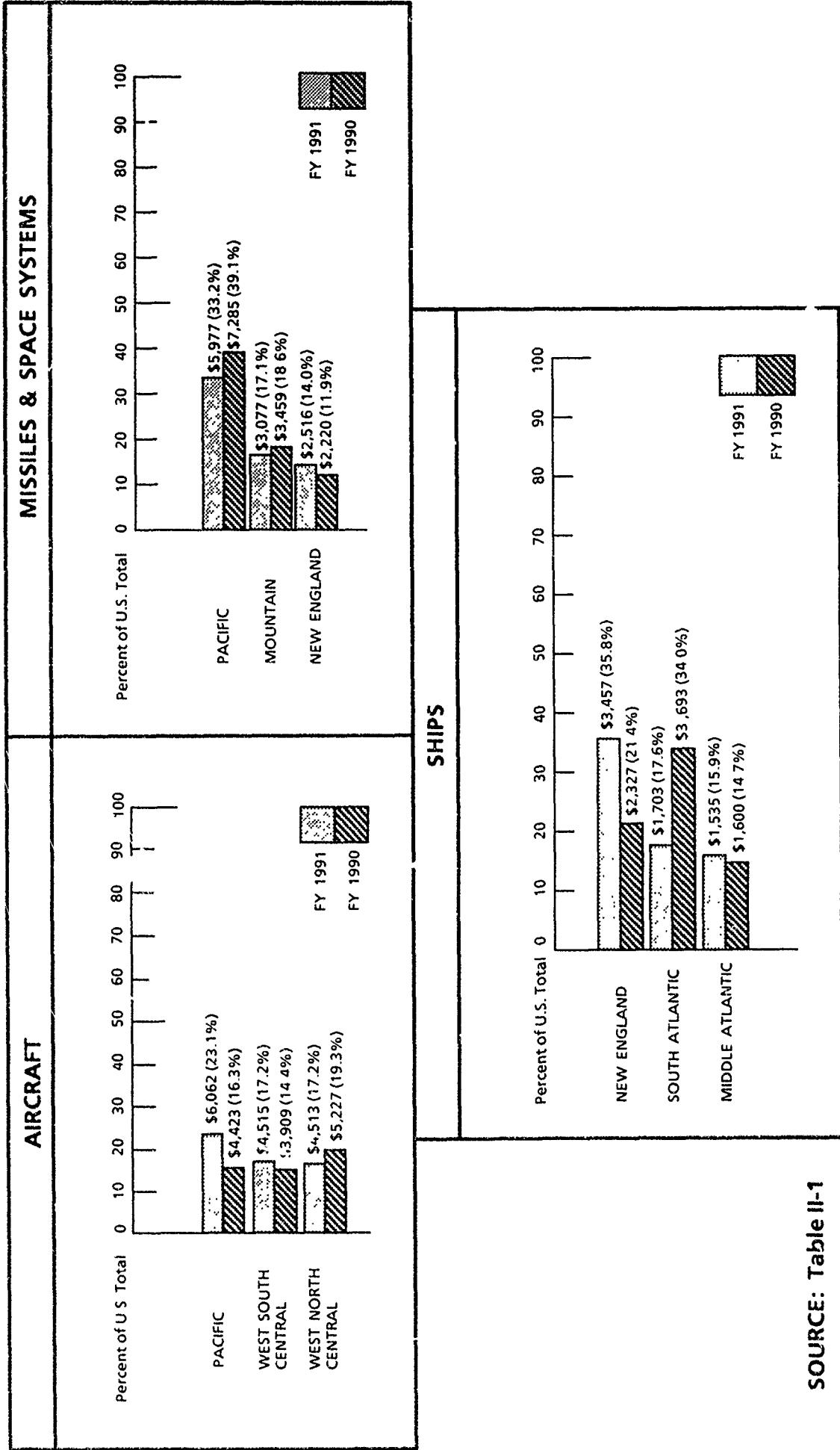

PART II
NET VALUE AND PERCENT DISTRIBUTION OF DoD PRIME
CONTRACT AWARDS OVER \$25,000 FOR MAJOR HARD GOODS

Figure II-1 (pages 10 and 11) shows the top three regions for FY 1991 in each of the seven major hard goods programs, as well as the net value and percent distribution of awards in each region for FY 1991 and 1990. The Pacific region ranked as one of the top three regions most frequently, placing first or second in five of the seven major hard goods programs. Table II-1 (pages 12 and 13) shows the net value and percent distribution of awards within the seven major hard goods programs, by region, for FY 1991, 1990, and 1989. Table II-2 (page 14) shows that awards within these hard goods programs accounted for 67 percent of all prime contract awards in FY 1991. Overall, hard goods programs decreased 4.2 percent from FY 1990 to FY 1991. The percentage distribution of awards within the seven major hard goods programs, as a percentage of all awards, shows awards for aircraft, ships, ammunition, and electronics and communication equipment decreased from FY 1990 to FY 1991, while awards for tank-automotive increased during the same time period.

 FOR MAJOR HARD GOODS: FY 1991 AND 1990**

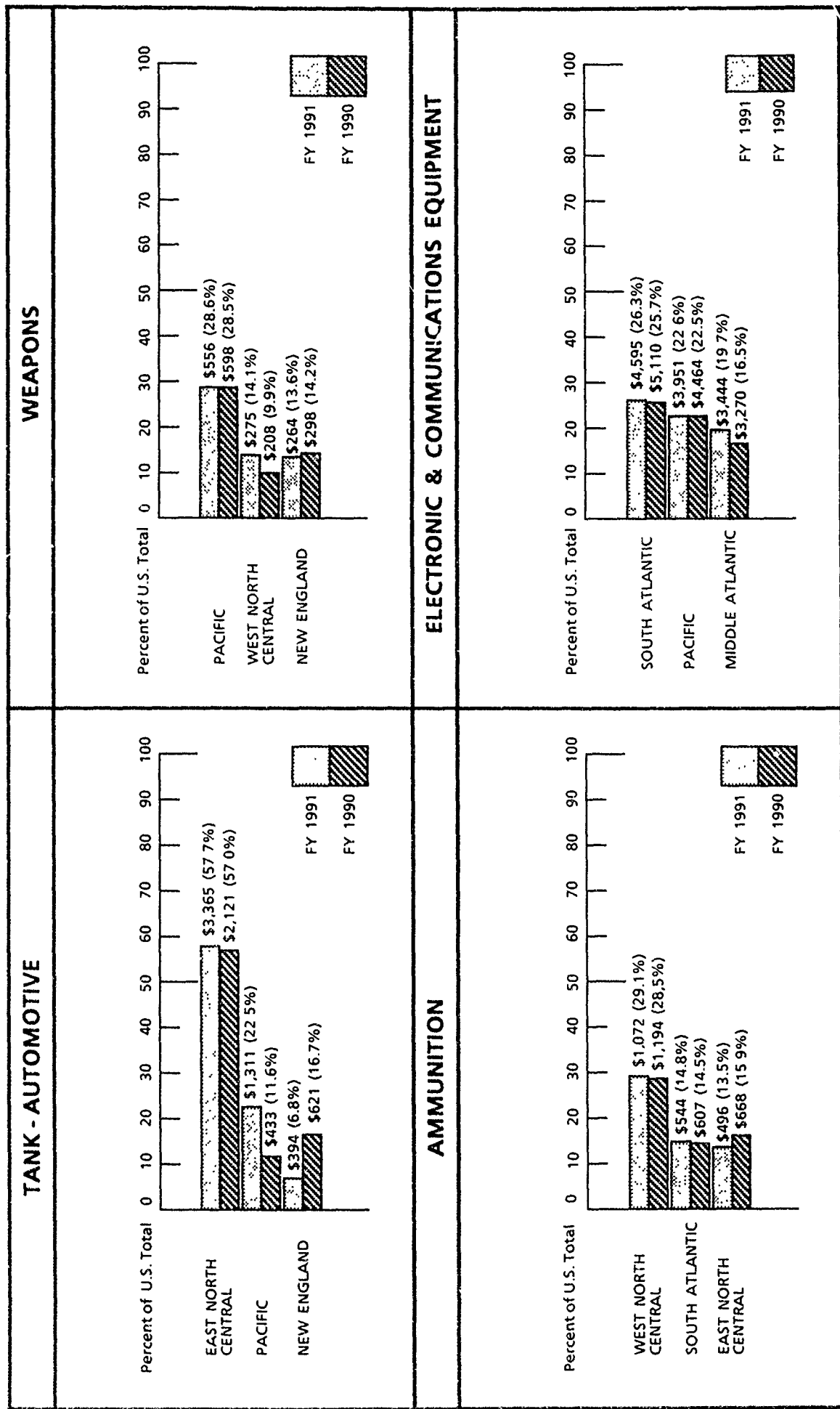

The net value and percent distribution of awards in each of the 25 major procurement programs for the fiscal years 1989 through 1991 for individual states are provided in Tables III-1, beginning on page 17. Table III-2 (page 69) shows the five leading states in each of these 25 procurement programs for FY 1991. While California ranked first in eleven of the programs, there was a broad representation of other states in the top five ranking. A total of 31 states appear in the table, one state less than appeared in FY 1990 and FY 1989. In FY 1991 and FY 1990, 13 states ranked first in one or more of the programs compared with 12 states in FY 1989.

PART IV
NET VALUE AND PERCENT DISTRIBUTION OF DoD PRIME
CONTRACT AWARDS OVER \$25,000 FOR RESEARCH,
DEVELOPMENT, TEST, AND EVALUATION

As shown in Table IV-1 (page 72), RDT&E awards totaled \$20,268 million in FY 1991, a decrease of \$1,523 million or 7.0 percent from the FY 1990 figure. The ratio of RDT&E awards to total awards decreased slightly for FY 1991. Table IV-1 also shows that the distribution of RDT&E awards among the three types of contractors had a three year trend of decreases in awards for Educational & Nonprofit Institutions, and Business Firms, while Other Nonprofit Institutions showed an increase in awards for the same time period.

Table IV-2 (page 73) shows the net value and percent distribution for both total awards and RDT&E awards, by region, and the percent distribution of RDT&E awards within each region for FY 1991. Four of the nine regions received more RDT&E awards in FY 1991 than in FY 1990. The Middle Atlantic region had the largest RDT&E dollar increase, \$1,099 million more than in FY 1990. In terms of the distribution of RDT&E awards, the Pacific region showed the most significant change. In FY 1990, 33.9 percent of RDT&E awards were in this region; however, in FY 1991, this percentage decreased to 27.5 percent.

The ratio of RDT&E awards to total awards showed a decrease from FY 1990 to FY 1991 (18.0 percent to 16.3 percent). Regional RDT&E awards as a percent of regional total awards did not change significantly. The four regions that experienced increases were the Middle Atlantic (8.3 percent), West South Central (4.1 percent), South Atlantic (2.5 percent), and Mountain (0.7 percent).

Tables IV-3, IV-4, and IV-5 (pages 74, 77, and 80, respectively) show the net value and percent distribution of prime contract awards for RDT&E work, by region and state, according to type of contractor (educational institutions, other nonprofit institutions, and business firms), for FY 1991, 1990, and 1989, respectively. As shown in Table IV-3, the four states receiving the largest share of RDT&E awards in FY 1991 were California (25.3 percent), Colorado (9.4 percent), New York (8.2 percent), and Massachusetts (7.5 percent).
