# Department of Defense Instruction

**SUBJECT** Guidance for Accounting and Reporting of Government Property Lost, Damaged or Destroyed

AD-A272 583

A. PURPOSE

This Instruction authorizes DoD Manual 7200.10-M as a Department of Defense issuance on the principles, policies, standards and procedures that will govern property accountability for Government property lost, damaged or destroyed.

B. APPLICABILITY

The provisions of this Instruction apply to the Office of the Secretary of Defense, the Military Departments, the Defense Agencies, and the Unified and Specified Commands, hereafter referred to as "DoD Components."

C. RESPONSIBILITY

1. The Director, Defense Logistics Agency, after appropriate coordination with interested DoD Components, shall develop, publish, and revise as necessary, and distribute the Manual separately from this Instruction.
2. The DASD(MS), OASD(C) shall maintain surveillance over the principles, standards and procedures prescribed in the guidance.

D. EFFECTIVE DATE

This Instruction is effective immediately.

Guidance for Accounting and Reporting of Government

**A. PURPOSE**
