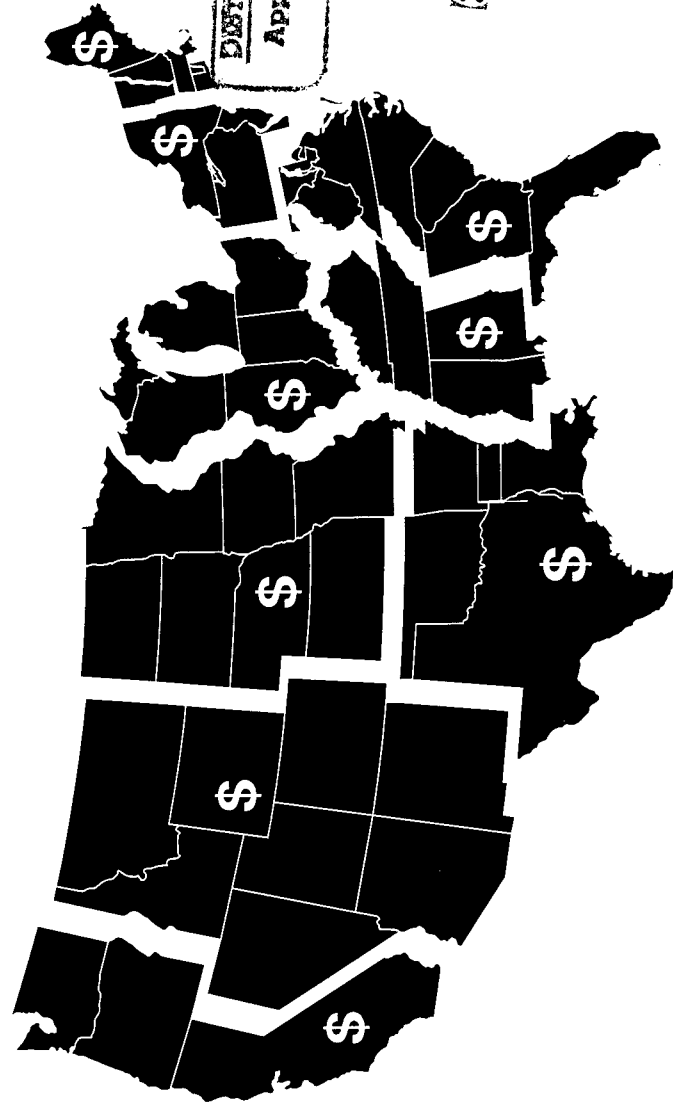

FOREWORD

Prime Contract Awards by Region and State is published annually. This issue provides information on the geographical distribution of Department of Defense prime contract awards over \$25,000 for fiscal years (FYs) 1996, 1995, and 1994, by the United States region and state.

This information is detailed in ten tables and three figures showing:

1. The net value and percent distribution of awards, by region and state, for FYs 1996, 1995, and 1994;
2. The net value and percent distribution of awards within the seven major hard goods programs, by region, for FYs 1996, 1995, and 1994;
3. The net value and percent distribution of awards in the 25 major procurement programs for each state for FYs 1996, 1995, and 1994; and
4. The net value and percent distribution of awards for research, development, test, and evaluation, by region and state, according to the type of contractor for FYs 1996, 1995, and 1994.

INTRODUCTION

This report contains a variety of data on the net value and percent distribution of DoD prime contract awards over \$25,000 within the United States, by region and state, for fiscal years (FYs) 1996, 1995, and 1994.

Notes on Coverage

Contract work is not necessarily performed in the state where the contract is awarded. Most manufacturing contracts have been attributed to the contractor's location where the product will be processed and assembled. When contract work has been performed at more than one plant, the contract has been attributed to the location where the largest dollar amount of work was produced. Both construction and service contracts have been attributed to the state where the work is to be performed. Contracts for transportation and communication services, in most cases, have been attributed to the state where the contractor's home office is located. For purchases from wholesale or other distribution firms, the location is the contractor's business address.

Prime contract data are not a means of measuring the total volume of defense work performed within a state, as a substantial amount of the work may be subcontracted. Amounts not distributed by state include contract actions of \$25,000 or less, contract actions performed in classified locations, contract actions entered into overseas, and other contract actions for work performed in the U.S. outlying areas.

Some special characteristics of the data on prime contract awards by procurement program category should be noted:

1. The Electronics and Communication Equipment category includes all electronics procured separately under prime contract. However, in the case of Missiles and Space Systems or Aircraft Engines and Related Spares, electronics work is often a basic part of the assembly prime contract; therefore, awards for electronics are included in the statistics for these categories.
2. Contracts for all other types of equipment and parts for repair, maintenance, overhaul, modification, or other services, which can be identified with a specific category, are assigned to that category. As an example, the installation or inspection of equipment at ballistic missile sites is recorded as missile work in the state where the site is located. However, the contract for manufacturing such equipment is reported according to the location of the manufacturer's plant. Therefore, aircraft, missile, or other program contracts may be reported in states where there are no weapon assembly plants but where bases, laboratories, or suppliers of instruments, parts, or support equipment may be located.

3. The dollar value shown for each category includes the Research, Development, Test, and Evaluation (RDT&E) work associated with it. RDT&E coverage includes basic research, exploratory development, advanced development, demonstration/validation, engineering and manufacturing development, management support, and operational system development. Full definitions for each of these categories are provided in Defense Federal Acquisition Regulation Supplement 235.001.

4. Figures in these tables may not add up due to rounding. An “*” in the percentage column represents a figure of less than 0.05 percent.

Highlights

Total prime contract awards in FY 1996 totaled \$132,178 million, an increase of \$813 million, or 0.6 percent, more than FY 1995. Awards over \$25,000 for work performed within the U.S., by region and state, are shown in this report. These awards totaled \$109,408 million in FY 1996. The kinds of awards not included in this report (see Notes on Coverage) are distributed as follows:

PART I

NET VALUE AND PERCENT DISTRIBUTION OF DoD PRIME CONTRACT AWARDS OVER \$25,000, BY REGION AND STATE

The U.S. regions are shown in Figure I-1, page 4. Those regions that make up the eastern part of the U.S. received awards totaling \$59,830 million, or 54.7 percent. The western regions received the remaining \$49,578 million, or 45.3 percent, of the awards. As shown in Figure I-2, page 5, the three regions that received the largest share of the awards in FY 1996 were the South Atlantic, 25.4 percent; the Pacific, 20.4 percent; and West South Central, 10.0 percent.

Table I-1, page 6, shows the net value and percent distribution of awards, by region and state, for FYs 1996, 1995, and 1994. Six of the nine regions showed an increase in prime contract awards from FY 1995 to FY 1996 with the East South Central having the largest increase (\$681 million, or 13.4 percent). The remaining three regions showed a decrease in prime contract awards, with the South Atlantic region having the largest decrease (\$2,403 million, or 8.0 percent).

The following ten states had the largest percentage change in procurement award dollars from FY 1995 to FY 1996 (shown from largest percentage increase or decrease to smallest percentage increase or decrease). Of the individual states, Kentucky had the largest percentage increase, \$313 million, or 55.8 percent. Montana had the largest percentage decrease, \$43 million, or 32.2 percent.

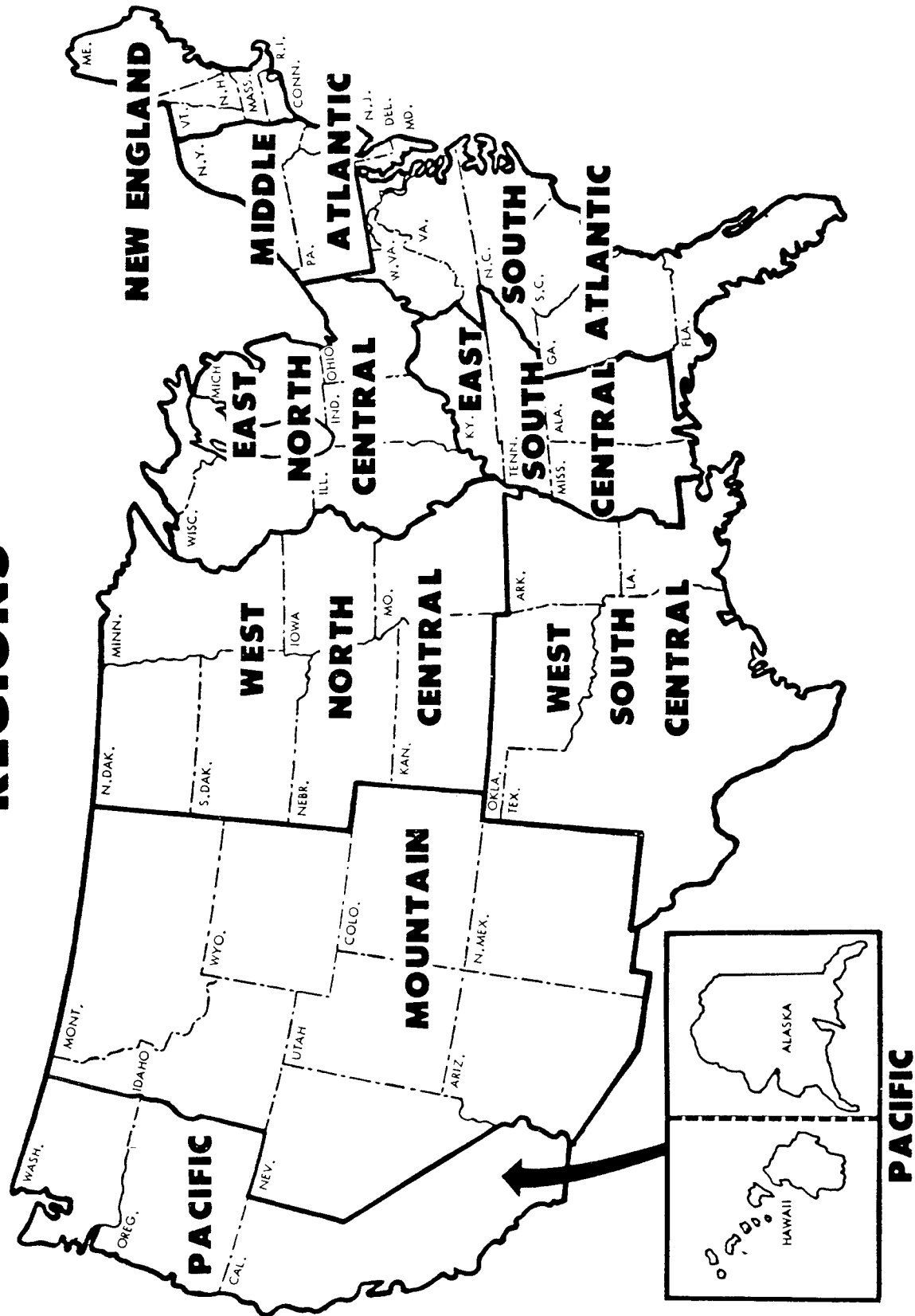
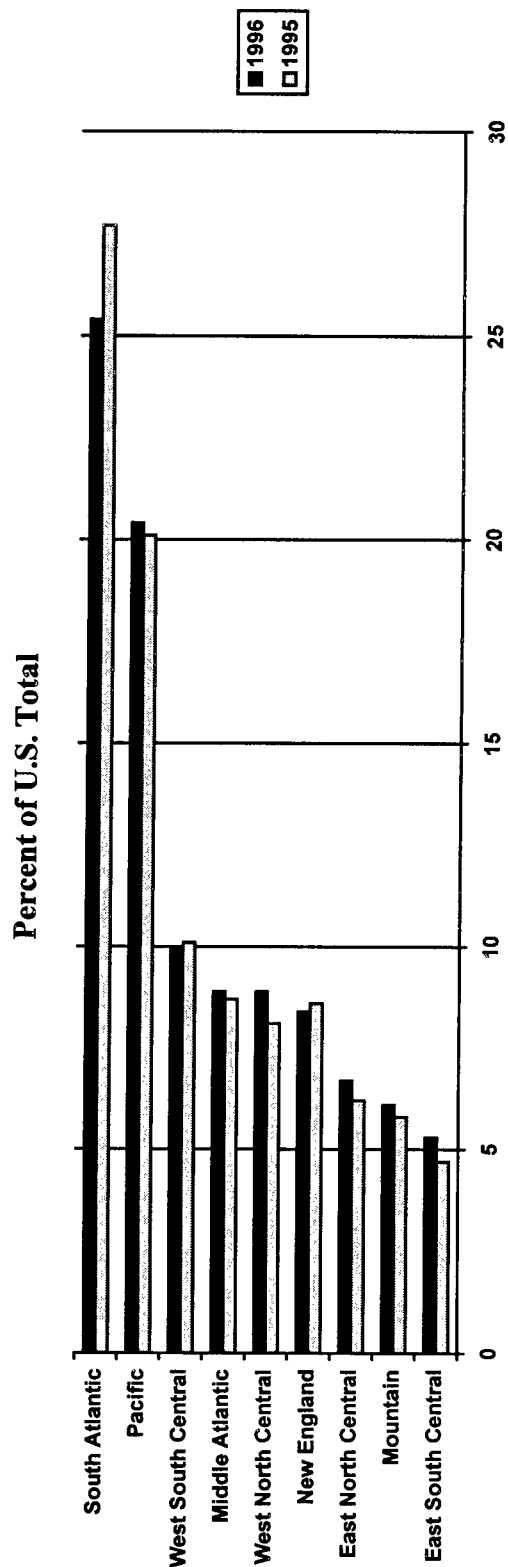
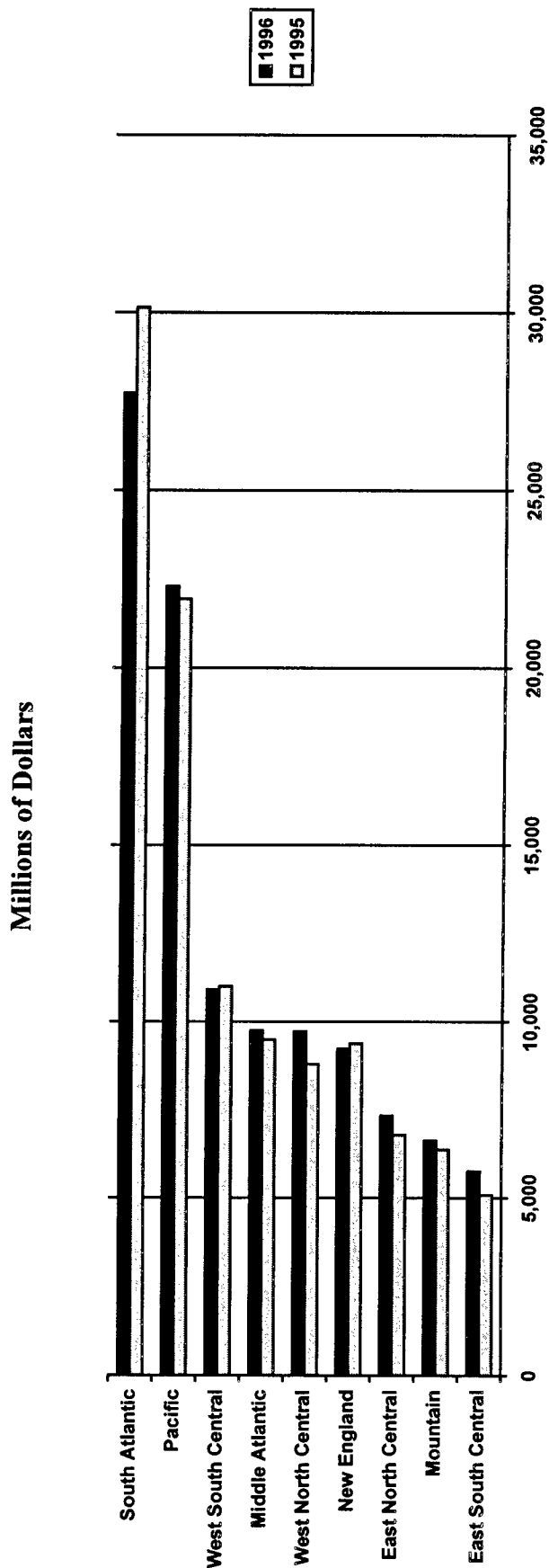

PART II

NET VALUE AND PERCENT DISTRIBUTION OF DOD PRIME CONTRACT AWARDS OVER \$25,000 FOR MAJOR HARD GOODS

Figure II-1, on pages 10 and 11, shows the top three regions for FY 1996 in each of the seven major hard goods programs, as well as the net value and percent distribution of awards in each region for FYs 1996 and 1995. Eight of the nine regions are listed at least once, with the South Atlantic region ranked most frequent, placing first, second, or third in five of the seven major hard goods programs. The Pacific region is the second most frequently shown region, appearing in four of the seven major hard goods programs.

Table II-1, on pages 12 and 13, shows the net value and percent distribution of awards within the seven major hard goods programs, by region, for FYs 1996, 1995, and 1994. Table II-2, page 14, shows that awards within these hard goods programs accounted for 59 percent of all prime contract awards in FY 1996. Overall, the hard goods programs dollar amount decreased by \$189 million, or 0.3 percent, from FY 1995 to FY 1996. As shown in the chart below, the percent distribution of awards for Other Supplies and Services shows a steady increase over the three year period. Conversely, the percent distribution of awards for the major hard goods shows a consistent decrease.

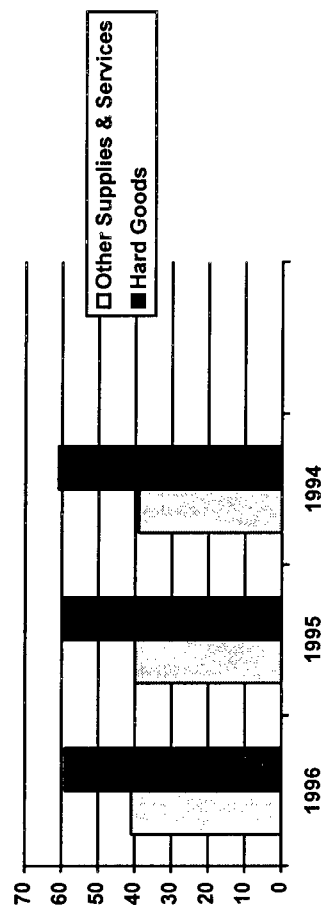
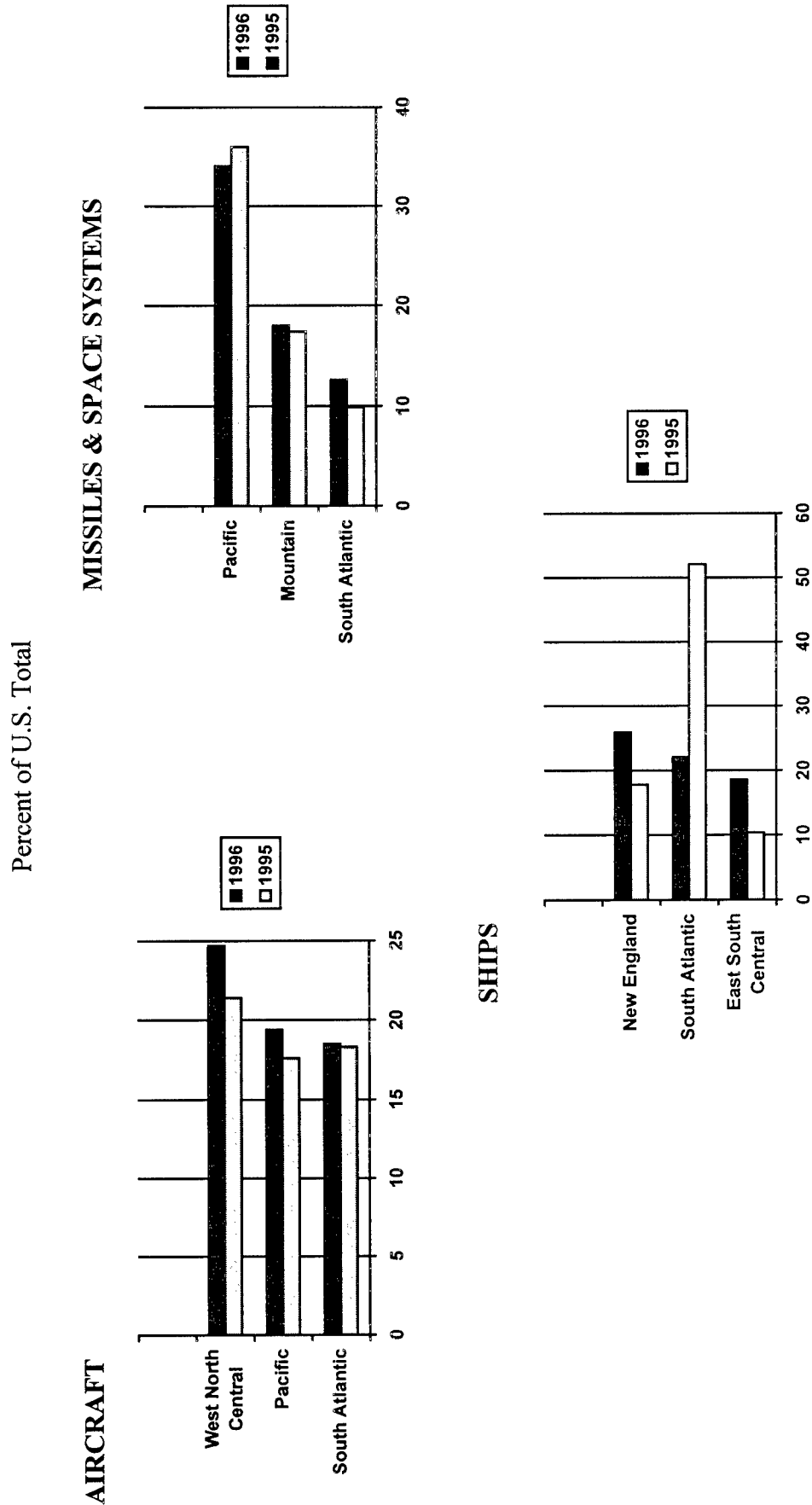

FOR MAJOR HARD GOODS: FYs 1996 AND 1995



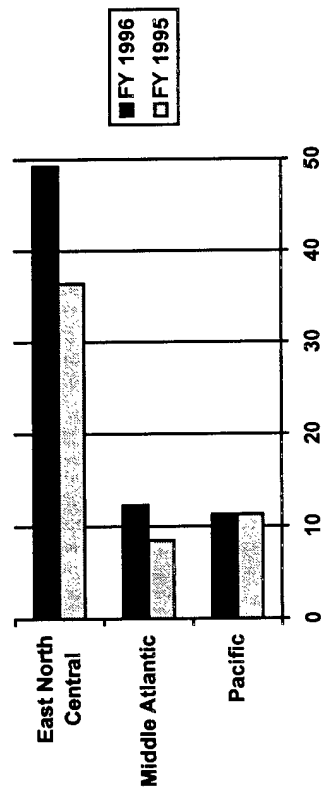

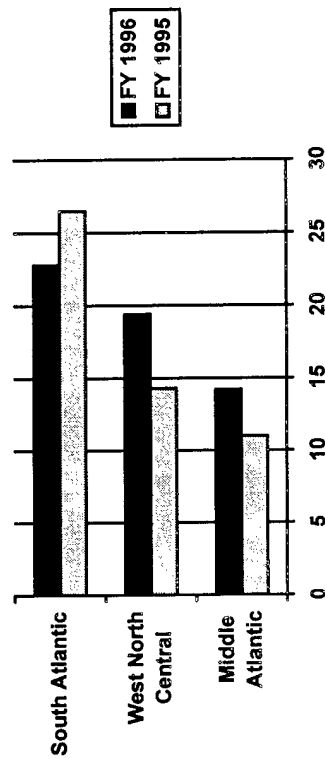
REGIONS WITH THE HIGHEST PROPORTION OF PRIME CONTRACT AWARDS OVER \$25,000

Percent of U.S. Total

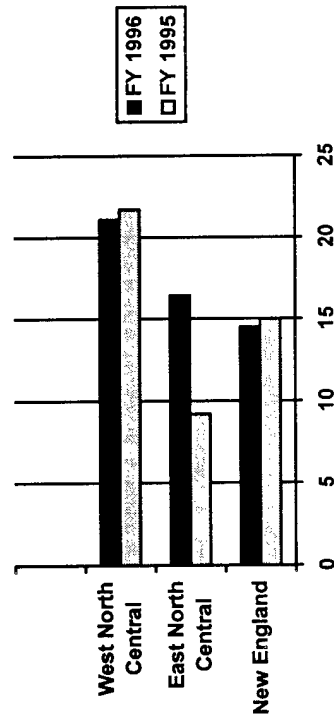
TANK - AUTOMOTIVE

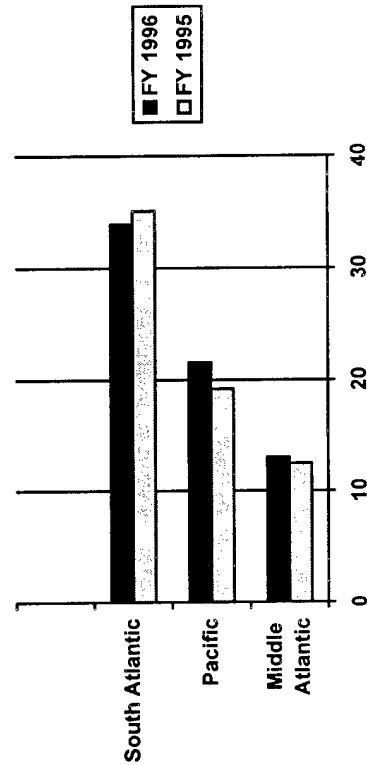

PART III

NET VALUE AND PERCENT DISTRIBUTION OF DoD PRIME CONTRACT AWARDS OVER \$25,000, BY STATE

The net value and percent distribution of awards in each of the 25 major procurement programs for FYs 1994 through 1996 for individual states are provided in Table III-1, beginning on page 17. Table III-2, page 69, shows the five leading states in each of these 25 procurement programs for FY 1996. While both California and Virginia ranked first in 5 of the programs, there was a broad representation of other states in the top five rankings. A total of 34 states appears in the table, one state less than appeared in FY 1995. In FY 1996, 13 states ranked first in one or more of the programs compared with 11 states in FY 1995.

PART IV

NET VALUE AND PERCENT DISTRIBUTION OF DoD PRIME CONTRACT AWARDS OVER \$25,000 FOR RESEARCH, DEVELOPMENT, TEST, AND EVALUATION

As shown in Table IV-1, page 72, RDT&E awards totaled \$19,801 million in FY 1996, a decrease of \$1,138 million, or 5.4 percent from the FY 1995 figure. The percentage of RDT&E awards to total prime contract awards showed a slight decrease during FY 1996 (18 percent) when compared to FY 1995 and FY 1994 (19 percent). The three year comparison in Table IV-1 shows the RDT&E percentages for the three types of contractors also remained relatively consistent over this time interval.

Table IV-2, page 73, shows the net value and percent distribution for both total awards and RDT&E awards, by region, and the percentage of distribution for RDT&E awards within each region for FY 1996 and FY 1995. Six of the nine regions received less RDT&E awards in FY 1996 than in FY 1995. The South Atlantic region had the largest RDT&E dollar decrease, \$506 million, or 8.5 percent less than in FY 1995. In terms of the distribution of RDT&E awards, the New England region showed the most significant percentage change. In FY 1995, 10.3 percent of RDT&E awards were in this region; however, in FY 1996, this percentage increased to 12.4 percent.

Regional RDT&E awards as a percentage of regional total awards decreased from 19.2 percent in FY 1995 to 18.1 percent in FY 1996. Seven regions experienced a decrease, while two regions showed an increase. New England showed the largest percentage of increase, 3.6 percent more in FY 1996 than in FY 1995.

Tables IV-3, IV-4, and IV-5, on pages 74, 77, and 80, respectively show the net value and percent distribution of prime contract awards for RDT&E work, by region and state, according to type of contractor (educational institutions, other nonprofit institutions, and business firms), for FYs 1996, 1995, and 1994. As shown in Table IV-3, pages 74 through 76, the three states receiving the largest share of RDT&E awards in FY 1996 were California, 18.1 percent; Georgia, 9.4 percent; and Massachusetts, 8.7 percent.
