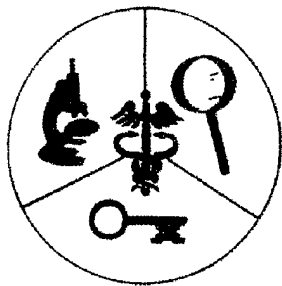

ABSTRACT (Continue on reverse if necessary and identify by block number) This report presents in Appendix A the CHAMPUS Catastrophic Quarterly Payment Reports for the Fourth Quarter Fiscal Year (FY) 1997 for thirty-four of the Army TRICARE catchment areas. Each Payment Report lists Privacy Act protected hospitalization patient cases having CHAMPUS claims totaling more than the catchment area's specific FY 1997 catastrophic cutoff amount either at the end of the reported quarter or the prior quarter. The difference between the current and previous quarter's net claim payments equals the catastrophic net payment made for each patient during the quarter. Table 1 at the end of the Summary contains the CHAMPUS Catastrophic Quarterly Payment Schedule, summarizing for each catchment area the catastrophic case cutoff limit, the number of catastrophic cases comprising these Fourth Quarter FY 1997 payment differences, the net claim totals for each of the two quarters, and the payment total between the quarters. The report provides an excellent recap of catastrophic CHAMPUS cases for review by Managed Care, Utilization Management, Comptroller and Deputy Commander for Clinical Services personnel.

## Executive Summary

This report presents in Appendix A (see pp. A-1-48) the CHAMPUS Catastrophic Quarterly Payment Report for the Fourth Quarter Fiscal Year (FY) 1997. The report provides an excellent recap of catastrophic CHAMPUS cases for review by Managed Care, Utilization Management, Comptroller and Deputy Commander for Clinical Services personnel.

For each of thirty-four HQ Medical Command (HQ MEDCOM) TRICARE catchment areas, Privacy Act protected patient cases having CHAMPUS claims totaling more than the catchment area's specific FY 1997 catastrophic cutoff amount are listed with the changes in their net claim payments between the reported and prior quarters. Each Payment Report includes the following for each patient: (1) the patient unique Inpatient Record Number; (2) the last hospital ending date on record; (3) the last hospital and professional services voucher payment dates; (4) an indicator of whether the case involved a consolidation of hospital stays due to FI adjudication action; (5) the DRG and diagnosis codes and their shortened descriptions; (6) the number of days spent in the hospital; (7) the number of professional services; (8) patient age, sex and beneficiary category; (9) the catastrophic amounts above the site's specified catastrophic cutoff amount on the first and last days of the reported quarter; and (10) the difference of these two catastrophic totals which equals the catastrophic net re-insurance payment made for each patient during the quarter. Dollar amounts are summed over all patients to total within a catchment area for each Payment Report. Table 1 at the end of this Summary (p. 3) contains the CHAMPUS Catastrophic Quarterly Payment Schedule which lists the quarterly summary totals of each catchment area's number of catastrophic cases and catastrophic total amounts from the Payment Reports, summing these totals over all catchment areas for the quarter.

Only cases with CHAMPUS claim payment totals exceeding the catchment area's catastrophic threshold amount are presented. Each cutoff amount is noted in the footnote area on the catchment area's output on its quarterly Catastrophic Payment Report (Appendix A; pp. A-1-48) and on the CHAMPUS Catastrophic Payment Schedule (Table 1; p. 3). The specific case limit amounts used for each of the TRICARE sites and the methodology used to derive them were reported in the HQ Army Medical Command Publication Fiscal Year 1997 CHAMPUS Catastrophic Case Limits, TRICARE Catchment Areas, RP 97-002, DTIC: Not Yet Known, Feb 1997. Quarterly catastrophic re-insurance payment amounts are the differences between the most recent and the prior quarters' CHAMPUS catastrophic claim totals. A negative payment amount represents net recoupment actions/adjustments during the quarter. Third Quarter FY 1997 quarterly catastrophic payment amounts for the TRICARE sites were reported in the HQ Army Medical Command Publication CHAMPUS Catastrophic Payments For The Third Quarter, Fiscal Year 1997, TRICARE Catchment Areas, RP 97-005, DTIC: Not Yet Known, July 1997.

Finding the status of any catastrophic patient case from quarter to quarter is accomplished by comparing the Inpatient Record Numbers (INPT RCD #) for a catchment area from a previous quarterly report with those on the most current Catastrophic Payment Report (Appendix A). If the Inpatient Record Number is on both the prior quarter's report and the current one, that catastrophic patient had net positive or negative claims in at least one of those quarters and is a continuing catastrophic case. Otherwise, a catastrophic case can appear to be newly added or dropped when compared with a previous report depending on whether the case's total government payment amount surpasses or drops below the catastrophic cutoff threshold for that catchment area, and whether or not claim payment activity took place during the reporting quarter. An example which examines catastrophic case quarter to quarter activity is presented in the Summary of the HQ Medical Command Publication CHAMPUS Catastrophic Payments For The First and Second Quarters, Fiscal Year 1996, TRICARE Catchment Areas, RP 96-004, DTIC: Not Yet Known, May 1996. A patient case showing a total government payment amount of \$0 for the previous or current quarter's catastrophic total infers that the payment amount added to less than the catchment area's case cutoff limit.

Table 1 at the end of this Summary (p. 3) contains the Fourth Quarter FY 1997 CHAMPUS Catastrophic Quarterly Payment Schedule and lists the summary totals of each catchment area's number of catastrophic cases and quarterly catastrophic total amounts from the Payment Reports for the quarter. Additionally, each site's FY 1997 cutoff amount is listed. Table 1 shows that CHAMPUS catastrophic re-insurance payments for the Fourth Quarter positioned Fort Wainwright MEDDAC as the catchment area with the lowest amount in catastrophic re-insurance payments, with a \$96,500 cutoff amount and \$-396 in Fourth Quarter payments for their one catastrophic patient case. Fort McClellan MEDDAC had the next lowest in catastrophic payments with one patient case totaling \$31 in catastrophic payments over McClellan's \$47,500 threshold amount. At the high end of the range, Fort Belvoir MEDDAC with a \$27,000 cutoff amount had forty-five cases on its Payment Report and catastrophic re-insurance payments of \$1,096,544, while Fort Leavenworth MEDDAC had \$618,351 in payments and six patient cases at its \$57,500 case limit. Fort Monmouth had no active catastrophic patient cases during the quarter. Quarterly catastrophic payments for the Fourth Quarter FY 1997 totaled to \$7,009,726 over all Army TRICARE sites and included care for a total of 481 catastrophic patients.
