The Taean Work System Is a Revolutionary Work System Which Has Thoroughly Embodied the Socialist Principle in Economic Management

[Text] Thoroughly embodying socialist principles in economic management is one of the important problems influencing the success of socialist economic construction.

If we are to successfully carry out socialist economic construction, we must correctly carry out the economic management work of guiding and directing people's production activities and their labor activities so as to meet the demands of socialist principles. Of course, there may be various kinds of specific methods of organizing and directing people's production activities and labor activities. However, inasmuch as socialist economic construction is the work of firmly constructing the material bases of the economic foundations of the socialist system and the material base of the socialist society, the revolutionary principles and stand of the working class socialist principles—must always be firmly embodied in managing and operating the socialist economy.

To embody socialist principles in economic management means solving all problems in the direction of displaying the superiority of socialism, based on socialist principles. In other words, it means firmly embodying collectivist principles, which form the basis of socialism, in managing and operating the socialist economy.

The basic thing in embodying socialist principles and collectivist principles in economic management is to thoroughly implement the revolutionary mass line in economic management and operations, firmly guaranteeing the leadership of the party over economic construction.

Only by firmly embodying socialist principles in economic management is it possible to carry out economic management in conformity with the intrinsic demands of socialist society and the inevitable laws of socialist economic development and to highly display its superiority and vitality.

If socialist principles are not firmly embodied in economic management, we cannot manage and operate the socialist economy in conformity with the interests and demands of the toiling popular masses, and all sorts of outmoded vestiges in the economic management field will penetrate and dilute socialist economic construction. Therefore, embodying socialist principles in economic management emerges as an important problem relating to the operation of socialist economic construction.

If we are to go ahead embodying socialist principles in economic management, we must set up a revolutionary economic management system that suits the intrinsic nature of the socialist system and the requirements of socialist economic management development. That is because economic management is carried out and achieved by means of a specific economic management system and method.

Even after the socialist system is established, the vestiges of outmoded economic management remain for a certain period in the field of economic construction, and they impose not a few impediments to socialist economic construction.

The vestiges of outmoded economic management do not disappear, nor do socialist principles become embodied automatically in economic construction just because the socialist revolution has triumphed and the socialist economic system has been established. Only through the wise leadership of the party of the working class is it possible to purge the vestiges of outmoded economic management and go on establishing a new socialist economic management order.

The great leader Comrade Kim II-song created the chuche theory of socialist economic management and created the Taean Work System by brilliantly embodying the immortal chuche thought in the field of economic management. By so doing, he illuminated the clear-cut path that can firmly embody the socialist principle in socialist economic management.

The great leader Comrade Kim Il-song taught as follows:

To correctly achieve such intrinsic demands of socialist economic management, there must be established an economic management system and methods that will enable the broad producer masses to actively participate in economic management. In the management-by manager-only system, which has many outmoded capitalistic economic management elements even though it is a socialist-type management system, the broad producer masses are unable to perform their responsibility and role as the masters of economic management.

The Taean Work System, which was created by our party—a revolutionary management system of our own style, which embodies the immortal chuche thought and

the revolutionary mass line—is the form of economic management that most dynamically organizes and mobilizes the producer masses.

The Taean Work system is not one in which any single individual decides and disposes of all problems arising in economic management and operation or moves the broad producer masses by administrative methods, giving orders, and handing down instructions and shouting commands. Today, all the work in our factory—from planning work all the way down to production guidance, materials

The period from 1961 until last year, during which our factory was managed and operated according to the Taean Work System, our factory's manufacturing gross output value increased 40-fold, and each year during this period production grew at the high rate of 125 percent per year. Our factory, which used to make small and medium transformers and electric motors, today makes 125,000-kilovolt hydroelectric transformers and bipolar 10,000-kva high speed electric motors, 200,000-kilovolt special high voltage transformers and many other heavy machinery facilities.

Improving Financial Management Is an Important Way To Mobilizing Hidden Resources

It is particularly important to lay the groundwork for financial management work.

In other words, it is the work of planning the formation and utilization of financial resources so as to accord with the lines and policies of the party and guaranteeing the funds necessary for economic construction and national defense construction and raising the people's living standards by mobilizing gross social product and national income in the form of cash according to a financial plan. Also included in financial management work is the work of instituting controls so that cash savings are increased and state funds are utilized economically.

Today, when the scale of today's economy has grown incomparably and the consumption linkages among sectors and production units is becoming very close, if we are to achieve great successes in socialist economic construction by mobilizing and utilizing inner reserves of the people's economy to the maximum, we must see to it that we accurately calculate the cost and profitability of products in all sectors and all units and insure that production is expanded with less expenditure.

Laying the groundwork for financial management work has major significance in particular for expanding production and construction by mobilizing inner reserves.

Improving financial management work serves as an important means of mobilizing inner reserves is above all linked to the fact that by improving financial planning work to meet the policies and lines of the party it becomes possible to raise investment effectiveness to the maximum.

Today, when major construction projects are being extensively carried out under the wise leadership of the party and the struggle to create a new "speed of the 90's" is being waged vigorously in all sectors of production and construction, correctly fixing investment targets, increasing the effectiveness of investments, and effectively utilizing state capital in every sector and every unit of the people's economy to the maximum emerges as an urgent requirement in order to complete economic construction ahead of schedule.

Only by correctly fixing investment priorities to conform to party lines and policies and focussing first on guaranteeing funds for those targets that can boost investment effectiveness is it possible to carry out even more production and construction with the funds provided and advance the socialist economic construction at a fast rate of speed.

If we are to correctly determine the expenditures and directions of utilization of state funds, we must do a good job of financial planning. Financial planning is the important work of building up the necessary capital and determining the scale and direction for disbursements based on the people's economic plan.

Only by commendably carrying out financial planning does it become possible to soundly set up fund disbursement plans so to ensure the successful accomplishment of the people's economic plan and, by correctly determining the limits of funds disbursement, to correctly establish investment targets and investment scale and maximize the investment effectiveness. If we do a good job of financial planning work, it is possible to calculate specifically all the elements of production starting with labor, facilities, and materials, and accurately mesh them together and overfulfill the people's economic plan by mobilizing all the various reserves and potentials.

Only by properly formulating the financial plan on the basis of the party's line and policy is it possible not only to specify the most effective investment direction, but also to make production grow at a high rate of speed by mobilizing all reserves and potentials that have not been calculated in the people's economic plan.

Improving financial management work is an important means of mobilizing inner reserves makes it possible to eliminate all kinds of wasteful phenomena and strengthen economization.

Eliminating the phenomenon of waste and strengthening economization is one of the basic methods for mobilizing inner reserves.

Eliminating waste is an important means of mobilizing inner reserves because the additional reserves that must be mobilized derive from economization.

The matter of how we mobilize inner reserves is linked to various factors—the development of science and technology and the introduction of new technology, for example—but to a great extent it depends on the economical use of facilities, labor, and capital.

Therefore, strengthening economization is a basic principle of socialist economic construction and a method for creating and mobilizing inner reserves.

If we want to eliminate waste in socialist society and improve economization, we must reinforce financial discipline and financial controls according to the rules and provisions of the state laws.

Waste is a manifestation of the outmoded ideological vestiges remaining in people's heads. It is related to the fact that discipline and order in economic management are in confusion and are not being properly observed.

If we want to eliminate waste, it is important on the one hand to vigorously carry out ideological indoctrination and ideological struggle while insuring that laws, rules, and regulations in financial activities are strictly observed and that we do our utmost to frugally use each drop of oil, each gram of coal, and each piece of cloth. If we improve financial management work, it is possible to strengthen plans and contract regulations and satisfactorily guarantee the material conditions of production and strictly conform to the disbursement standards of raw materials, materials and other goods and labor and to continuously lower them.

Only by tightening financial discipline and financial controls is it possible to increase production by utilizing most effectively existing facilities, labor, and capital.

Bolstering financial discipline and financial controls by improving financial management makes it possible raise efficiency in the utilization of state funds and to more vigorously advance economic construction ahead of schedule.

Effectively utilizing state funds is a firm guarantee for more production and construction with limited funds on a societal scale—not to mention individual enterprises—and serves as an important form of inner reserve mobilization.

The effective utilization of state funds is achieved by the use of financial measures aimed at the economical utilization and more rapid turnover of facilities, materials, and labor.

Therefore, if we tighten financial discipline and controls by improving financial management work, it will be possible to mobilize and utilize inner reserves of the people's economy to the maximum by economically utilizing state funds and speeding up their turnover.

Improving financial management is an important way to mobilize inner reserves because it makes it possible to rationalize business management by correctly carrying out the independent economic accounting system.

The independent economic accounting system is a rational method of economic management and operations in which an enterprise carries out economic activities with relative individuality under the centralized guidance and control of the state, while benefiting the state by reimbursing by itself the expenses incurred in production.

Only by correctly instituting the independent economic accounting system is it possible to better guarantee the planned and balanced development of the people's economy under the centralized, planned guidance of the state and to repay the disbursements from their own revenues and give even more profits to the state.

If we want to correctly institute the independent economic accounting system in socialist state-managed enterprises, we must do a good job of financial management organization and effectively manage the funds received from the state according to type.

Only by performing financial management so that we accurately plan the scale of assets by type—fixed assets, liquid assets, and circulating assets—and accurately build up the funding sources necessary for them and smoothly accomplish planning for the cost and profit margin of products, transaction income, sales income and the like is it possible [for enterprises] to repay the expenditures with their own revenues and to make a profit while fully displaying the superiority of the independent economic accounting system. In other words, the superiority of the independent economic accounting system in factories and enterprises is demonstrated through scientific and rational financial management.

If we want to expand internal savings in factories and enterprises and guarantee the financial budget revenues of the state by commendably instituting the independent economic accounting system and improve management activities by rationally utilizing state funds, we must of necessity carry out financial management scientifically and rationally.

Indeed, here—in improving financial management—is a firm guarantee for mobilizing and utilizing to the maximum various kinds of reserves and potentials and meticulously carrying out the nation's economic life and more vigorously hastening socialist economic construction.

From the first period of socialism-building, the great leader Comrade Kim II-song keenly perceived the significance and importance of financial management work in managing the socialist economy and clearly elucidated the direction and methods for laying the groundwork for financial management work and expediting production and construction.

Therefore, the work of financial management in our country has been steadily improved and the superiority of socialist financial management has been immensely enhanced and great innovations raised in production and construction.

In particular, today, when socialism building is being vigorously pursued, by the further improvement of financial management work in the various sectors and units of the people's economy it has become possible to rationalize business management and make operations scientific.

By improving financial management work, many factories and enterprises including the 5 October Automotive Consolidated Factory and the 25 March Factory, and the Pyongyang Textile Machinery Factory are providing much benefit to the state while making their own enterprises profitable by systematically lowering unit cost of production and increasing profit margins.

Functionaries and laborers of the Yonggang Electric Motor Factory, by greatly overfulfilling the production plan even while they lowered production prime costs by 4-5 percent, were able to satisfactorily guarantee electric motors and transformers and other electric equipment to important construction projects.

During the single month of February last year, the 5 October Consolidated Automotive Factory put into

effect some 145 economization proposals and saved 2,300-plus man-units of labor and a large amount of electricity and saved 10-15 percent of non-ferrous metals, steel materials, and plastic powder, and carbon steel plate, and provided much profit to the state.

All of these successes show that the more we plan and organize financial management and effectively utilize facilities, labor, and materials, and vigorously carry out mass technical innovations movements, the more we can seek out and mobilize any amount of internal reserves and effectively utilize them in expediting production and construction.

All functionaries and workers must bear in mind that planning and organizing financial management work in the present period is an important means for aggressively mobilizing internal reserves and bringing about a great leap forward in socialist economic construction and must actively struggle to improve financial management work.

An important thing in improving financial management work is first of all for all functionaries and workers to participate spontaneously in financial management with the attitude of a master toward the nation's economic housekeeping.

Comrade Kim Chong-il, member of the Presidium of the Political Bureau and Secretary of the Central Committee of the WPK, pointed out as follows:

"In a socialist society the toiling popular masses, who are the subject of the revolution, are the masters of finance. In the socialist society, financial problems must also be considered with the toiling popular masses as the focus and must be solved by raising their voluntary enthusiasm and creative positivism."

The masters of financial management in socialist society are the toiling popular masses.

When the toiling popular masses plan and organize financial management work with a high level of selfawareness as the real masters of society, financial management work can be further improved and all the reserves of increased production and economization can be mobilized and utilized to the maximum.

If we want to improve financial management work, the workers must have a standpoint and attitude like that of the master toward the nation's housekeeping and particularly financial management.

Only by having a standpoint and attitude like that of the master toward the nation's housekeeping do we put our energies into strengthening the country's financial foundations and expanding the state's financial revenue and conserve and care for the property of the state and the society and devote all of our energies into further increasing them. And we come to struggle actively in order to frugally use every single cent of state funds and to utilize them effectively, and struggle actively to oppose the phenomenon of wasting, carelessly managing, or damaging the property of the state or the society.

Therefore, all functionaries and workers must assume the standpoint and attitude of a master toward the nation's housekeeping and struggle actively in order to further increase the nation's wealth by voluntarily participating in financial management.

The next important thing in improving financial management work is to tighten financial discipline and financial controls.

Correctly setting up financial discipline and tightening financial controls is a basic method for improving socialist financial management.

Only by strengthening financial discipline and financial controls is it possible to uproot the outmoded ideological vestiges remaining in people's heads and manage the nation's housekeeping more frugally, more meticulously.

The top priority in tightening financial discipline is to tighten the state's budget discipline.

The budget of the socialist state is the basic financial plan of the state and the yardstick that determines the overall national housekeeping.

If we are to reinforce state budget discipline, we must correctly set up financial plans in all sectors and all units of the people's economy and see to it that operations activities are carried out directly in conjunction with the state budget.

Also, factories and enterprises must concretely calculate all the elements of production such as facilities, labor, and materials, and set up financial plans in minute detail while establishing strong discipline, so that the plan that has been set up is strictly accomplished.

Therefore, all factories and enterprises must thoroughly perform their duty of paying into the state budget and eliminate the phenomena of hoarding or wasting funds and insure that funds are utilized in the most rational and effective manner.

An important thing in strengthening financial discipline is to strengthen financial and banking institutions' control over the execution of the state budget.

Financial and banking organs have the duty of routinely taking command and exercising control so that all sectors, organs, and enterprises faithfully perform their duty of paying into the budget in a timely fashion. In insuring that factories and enterprises overfulfill their quotas in the production plan and utilize their prime cost economically, the role played by financial and banking organs has a major significance.

Financial and banking organs must tighten controls so that state funds are disbursed according to the item and scale envisioned in the plan and that these are rationally utilized to the maximum, and they must thoroughly set up a system of regular financial inspections.

Also, all factories and enterprises must maintain financial inspection committees and properly set up accounting systems and put their operational activities on a scientific and rational basis.

The next important thing in improving financial management work is to thoroughly establish a financial summation or critique system.

Carrying out financial summation substantively makes it possible to accurately analyze and evaluate standards of financial activity and to set up effective measures for mobilizing inner reserves to the maximum.

In setting up a financial summation system, normalizing the system for daily summation of production and finance is of great significance.

The system for daily summation of production and finance created by our party is a unique financial summation system of our own style that firmly transforms the nation's housekeeping and financial management into the routine work of the masses themselves.

Functionaries and workers must deeply understand that the system for daily summation of production and finance is a unique financial management system that makes it possible to elevate the position and role of the producer masses and to make operational activities scientific and rational by thoroughly implementing the revolutionary mass line in economic management according to the demands of the Taean work system, and they must thoroughly institutionalize it and make it part of their lives and carry it out in a substantive manner.

If we want to normalize the daily summation of production and finance, we must correctly establish summation units and summation indices to suit the characteristics of the organs, enterprises, and social cooperative groups according to the sector of the people's economy and enhance the role of the workteam chief and personnel in charge on the social level.

The daily summation of production and finance should summarize and evaluate production and the accomplishment of economization tasks and other forms of inner reserves mobilization by index and individually and, on the basis of this, give priority to political evaluation while blending material incentives appropriately.

The daily summation of production and finance should be carried out by closely linking it with a model workteam movement for increased production and economization. Only by doing so will it be possible to dynamically launch the internal reserve mobilization work as a mass movement and to manage the nation's housekeeping more frugally.

If we want to improve the financial management system, we must do a good job of financial summation in enterprises and work-sites as well. Carrying out financial summations by the 10-day period, by the month, by the quarter, by the half-year, and by the year is an important method for improving the nation's housekeeping and financial management work.

All work-sites, factories, enterprises, and state administrative economic organs should thoroughly institutionalize and regularize 10-day, monthly, quarterly, semiannual, and annual financial summations. Ten-day, monthly, quarterly, semi-annual, and annual financial summations must prepare well and accurately analyze the reasons for excellence and deficiencies that show up in financial management and fully display the collective wisdom of the producer masses, do a substantive job along the lines of straightening out measures to improve financial management.

In addition, the results of financial summations of factories, enterprises, work-sites, and workteams must be made public and the concern of the producer masses toward financial management work must be boosted.

All functionaries and workers must profoundly study the historic letter of the dear Comrade Kim Chong-il, "On Improving and Strengthening Financial and Banking Work" and positively contribute to successfully accomplishing the task of socialist economic construction by further improving the work of financial management to meet the demands of the developing reality.
