ABSTRACT

Suicide bombers are today's weapon of choice. Terrorists are using suicide bombers because they are a low cost, low technology, and low risk weapon. Suicide bombers are readily available, require little training, leave no trace behind, and strike fear into the general population. The success of suicide bombers is dependent upon an element of surprise, as well as accessibility to targeted areas or populations. Both of these required elements have been successfully employed in the recent use of women as suicide bombers. Female suicide bombers were used in the past; however, the recent spate of female suicide bombers in different venues, in different countries, and for different terrorist organizations forces us to study this terrorist method.

This research paper reviews historical female suicide bombers, focuses on female suicide bomber characteristics, analyzes recent changes in application by various terrorist organizations, and provides implications of change within a strategic assessment of future female suicide bombings.

FEMALE SUICIDE BOMBERS

“I have to tell the world that if they do not defend us, then we have to defend ourselves with the only thing we have, our bodies. Our bodies are the only fighting means at our disposal...”

- Hiba, 28-year old, mother of five, Suicide Bomber Trainee

Suicide bombers are today's weapon of choice. An action that was once so surprising, horrific, and terrifying, has now become the daily fare of the nightly news. “From Jerusalem to Jakarta and from Bali to Baghdad, the suicide bomber is clearly the weapon of choice for international terrorists.”¹ The raw number of suicide attacks is climbing² with bombs now used by 17 terror organizations in 14 countries.³ “In terms of casualties, suicide attacks are the most efficient form of terrorism. From 1980 to 2001, suicide attacks accounted for 3 percent of terrorist incidents but caused half of the total deaths due to terrorism – even if one excludes the unusually large number of fatalities of 9/11.”⁴ Into this boiling cauldron of terror a new element has been added – women as suicide bombers. The success of suicide bombers is dependent upon an element of surprise and accessibility to targets. Both of these required elements have been met successfully by using women. The recent spate of female suicide bombers in different venues, different countries, and different terrorist organizations impels study of this strategic weapon.

Prior to 11 September 2001, the use of suicide bombers was not seen by the U.S. public as a major threat; however, this weapon now evokes a visceral response. The Department of Homeland Security (DHS) Alert 03-025 provided warnings of male and female suicide bombers⁵ and New York City was on heightened alert in December 2003 over fears of an attack by a female suicide bomber.⁶ Jessica Stern, a terrorism expert, recently criticized DHS procedures and warned of the dangers of ignoring female terrorists: “The official profile of a typical terrorist – developed by the DHS to scrutinize visa applicants and resident aliens – applies only to men. Under a program put in place after 11 September 2001, males 16-45 are subject to special scrutiny; women are not.”⁷ Of concern is that terrorists seek out vulnerabilities in the enemy government's countermeasures and lack of scrutiny of women entering the U.S. could cause Al Qaeda to use women.⁸

This research reviews the history of female suicide bombers, focuses on bomber characteristics, analyzes recent changes in application, and provides implications of change within a strategic assessment of future female suicide bombings. As a caveat and as noted by a terrorist expert, “this research is particularly demanding as there are not enough reports with

descriptions of the cases, there is not enough documentation on how these women are treated in terrorist groups, there are not enough testimonies, and it is difficult to profile these murderers.⁹ Most chilling, however, is that those who could tell us their stories – those who went through with this death act – cannot share their thoughts and motivation.

HISTORY OF SUICIDE BOMBING

“A long view of history reveals that suicide terrorism existed...as early as the 11th century. The Assassins (*Ismalis-Nizari*), Muslim fighters, adopted suicide terrorism as a strategy to advance the cause of Islam. These perpetrators perceived their deaths as acts of martyrdom for the glory of God.”¹⁰ “The Assassins’ aim, like that of Islamist extremists today, was to spread a “pure” version of Islam. Like contemporary suicide bombers, they considered their own lives to be sacrificial offerings. Unlike today’s suicide bombers, the Assassins murdered particular individuals rather than randomly targeting people whose only crime is to be in the wrong place at the wrong time.”¹¹

Female suicide bombers are relatively new. The first attack was in 1985 when a 16-year-old girl, Khyadali Sana, drove a truck into an Israeli Defense Force convoy and killed two soldiers. Since then, women have driven bomb-laden vehicles, carried bomber “bags,” and strapped massive explosives and metal implements on their bodies in Lebanon, Sri Lanka, Chechnya, Israel, and Turkey. Known terrorist groups which have publicized their use of females include the Syrian Socialist National Party (SSNP/PPS), the Liberation Tigers of Tamil Eelam (LTTE), the Kurdistan Workers Party (PKK), Chechen rebels, Al Aqsa Martyrs, Palestinian Islamic Jihad (PIJ), and, most recently, Hamas.

There are many “firsts” in this listing of organized feminine terror. While the SSNP has the distinction of having the first female suicide bomber, the “LTTE became the world’s foremost suicide bombers and proved the tactic to be so unnerving and effective that their methods and killing innovations were studied and copied, most notably in the Middle East.”¹² The LTTE has committed the most attacks, close to 200, with women involved in 30-40 percent. The largest number killed (170) was in Moscow, October 2002, when Chechen rebels (including a high percentage of women) held hostages in the Theater Center and the police killed 129 captives and 41 rebels. Recently, during the last 2 years, Palestinian suicide bombers have carried out the largest number of attacks.

Not all bombers are known nor are all the data known to be correct. The youngest appears to be either Khyadali Sana (SSNP/PPS, 1985), 16, or Laila Kaplan, 17, (PKK, 1996); the oldest was Shagir Karima Mahmud (SSNP/PPS, 1987), 37. The first LTTE bomber, Dhanu,

successfully killed Prime Minister Rajiv Gandhi in May 1991. The first female PKK suicide bombing (June 1996), which may also be the first instance of the bomber appearing pregnant, killed six Turkish soldiers; the bomber's name is unknown. The first Russian "Black Widow" or *saliheen*, Hawa Barayev, appeared on behalf of the Chechen rebels in June 2000 and killed 27 Russian Special Forces soldiers. In January 2002, the first *istish-hadiyat* (female martyr) in Israel, representing the Al Aqsa Martyrs' Brigade, was Wafa Idris, a paramedic who detonated a 22-pound body bomb, filled with nails and metal objects, in a shopping district. Wafa killed an 81-year-old man and injured more than 100. The first PIJ bomber was a 19-year-old student, Hiba Daraghmeh, who detonated a bomb in a shopping mall killing three. The PIJ second bomber, 29-year-old lawyer Hanadi Jaradat, also received much publicity as she strolled into a highly frequented restaurant in October 2003 and killed 21 Israeli and Arab men, women and children. The most recent "first" was the first female Hamas bomber, 22-year-old Reem al-Reyashi, who on 14 January 2004 killed four Israeli soldiers at a checkpoint. Of particular note is that Reem was also a mother who left behind a husband, a three-year-old son and a one-year old daughter. A "first" yet to be experienced is the first female suicide bomber representing Al Qaeda (See Tables 1 and 2.)

SUICIDE BOMBERS

A suicide bomber, someone willing to die for a cause, is puzzling. What is a suicide bomber? Why use suicide bombers? Who becomes a suicide bomber? Most importantly, why would one voluntarily die in order to kill other innocent people?

WHAT IS A SUICIDE BOMBER?

The Institute for Counter-Terrorism (ICT) defined suicide bombing as an "operational method in which the very act of the attack is dependent upon the death of the perpetrator. The terrorist is fully aware that if she/he does not kill her/himself, the planned attack will not be implemented."¹³ "Suicide bomber" is an emotionally-laden term. Some describe these individuals as "homicide bombers" or "suicide terrorists" to emphasize the murder and terror brought about by this act; others deem these individuals as "martyrs" who have died for their faith.

WHY USE SUICIDE BOMBERS?

Terrorism has been defined as “a synthesis of war and theater.”¹⁴ This descriptor aptly applies to female suicide bombings. Suicide bombing is used because:

- It is a simple and low-cost operation (requiring no escape route or rescue mission).
- It guarantees mass casualties and extensive damage (since the bomber can choose the exact time, location, and circumstances of the attack).
- There is no fear that interrogated terrorists will surrender important information (because their deaths are certain).
- It has an immense impact on the public and the media (due to the overwhelming sense of helplessness).¹⁵

Others note that suicide terrorism “inflicts profound fear and anxiety and produces a negative psychological effect on an entire population and not just on the victims of the actual attack.”¹⁶ Finally, a “suicide attack attracts wide media coverage and is seen as a newsworthy event.”¹⁷ Female suicide bombers (youngest, oldest, mother, Red Cross worker, jilted fiancé, avenger of dead family members) have an added media aspect which encourages terrorists to capitalize on the sensationalism.

Organizations which routinely use suicide bombers “have utilized the notion of martyrdom and self-sacrifice as a means of last resort against their conventionally more powerful enemies.”¹⁸ These groups believe that suicide bombs are successful in bringing notice to their plight and contend that suicide bombers are the only effective weapons they have as they enumerate their enemies’ much larger wealth, weapons, soldiers, and political means. Abu Shanab, a Hamas leader, stated that “all is required is a bomb, a detonator, and a moment of courage and courage is the scarce resource.”¹⁹

WHY USE FEMALE SUICIDE BOMBERS?

The use of women as suicide bombers poses a clash between some fundamental religious leaders’ beliefs and the tactical need for a stealthier weapon. In January 2002, Sheikh Ahmed Yassin, the spiritual leader of Hamas, “categorically renounced the use of women as suicide bombers.”²⁰ In March 2002 after the second Fatah bombing, he reported that “Hamas was far from enthusiastic about the inclusion of women in warfare, for reasons of modesty.”²¹ That position dramatically shifted on 14 January 2004 with the first Hamas female suicide bomber. Why was she used? Yassin defended this change as a “significant evolution in our fight. The male fighters face many obstacles²² and, therefore, women can more easily reach the targets. He concluded his statement by noting that “Women are like the reserve army –

when there is a necessity, we use them."²³ Terrorist organizations use women as weapons because it provides:

- Tactical advantage: stealthier attack, element of surprise, hesitancy to search women, female stereotype (e.g., non-violent).
- Increased number of combatants.
- Increased publicity (greater publicity = larger number of recruits).
- Psychological effect.

"It is the ultimate asymmetric weapon," explained Magnus Ranstorp, director of the Center for the Study of Terrorism and Political Violence. "You can assimilate among the people and then attack with an element of surprise that has an incredible and devastating shock value."²⁴ In the words of a commander in charge of training future suicide bombers, "The body has become our most potent weapon. When we searched for new ways to resist the security complications facing us, we discovered that our women could be an advantage."²⁵ One trainer even boastfully described them as the new "Palestinian human precision bomb."²⁶ Those who study Middle East cultures cite another reason: "The use (of female suicide bombers) by Palestinian militant groups is designed to embarrass the Israeli regime and show that things are so desperate that women are fighting instead of men."²⁷ Suicide bombers provide the low-cost, low-technology, low-risk weapon that maximizes target destruction and instills fear – women do that even more with increased accessibility and media shock value.

WHO BECOMES A SUICIDE BOMBER?

The answer to this question is elusive for males and females. Some suggest there are definite trends, others dispute that conclusion, and still others maintain that a profile cannot be developed as it is "unlikely that the search would be successful in creating a set of common denominators that could span several continents, time periods, cultures, and political configurations."²⁸ Some of the factors assessed included age, education, economic status, and socialization toward violence.²⁹ The only factor that "all the experts seem to agree on is that suicide bombers are primarily young people."³⁰ "The positive attitudes toward political violence – already well entrenched in persons under 17 years of age (14.5 percent) – actually increases in the population up to the age of 24 (14.9 percent) and decreases thereafter (6 percent at 64 years of age)."³¹ In addition to age, it appears that education plays a role as "the percentage increases with the level of education: 8.3 percent among those with an elementary school diploma versus 12.8 percent among those with a university degree."³²

Profiles may be developed for specific sets of suicide bombers. For example, Jessica Stern profiles the typical male Palestinian suicide bomber (young, unmarried, mosque attendee, etc.) and this assessment is agreed upon by other experts such as Ariel Merari, a leading Israeli authority on suicide terrorism³³ and Boaz Ganor, Executive Director of the ICT.³⁴ Additionally, most suicide bombers tend to be of average economic status (although a disproportionate number come from refugee camps)³⁵ and “as logical as the poverty-breeds-terrorism argument may seem, studies show that suicide attackers are rarely ignorant or impoverished.”³⁶ Two other critical findings were that more than half had spent time in Israeli prisons³⁷ and “had expressed the desire to avenge the death or injury of a relative or a close friend.”³⁸

WHO BECOMES A FEMALE SUICIDE BOMBER?

“The reasons for women’s participation in deadly attacks vary greatly, and it is hard to generalize for this phenomenon is too recent and the attacks have been too few. Either not enough research has been conducted yet or the sample size is too small to make effective generalizations.”³⁹ Although the data are limited, female suicide bombers, just like male suicide bombers, have one characteristic which typifies all – they are young. The average age varies from 21.5 (Turkey) to 23 (Lebanon), a small differential. Other characteristics do not hold. Some are widows and others have never been married; some are unemployed and others are professionals; some are poor and others are middle class. Most analysts can easily compare the Black Widows in Russia with the Palestinian suicide bombers as these both appear to be “struggles of national identity”⁴⁰ with religious overtones. Additionally, as is true of the male counterparts, several female suicide bombers have experienced the loss of a close friend or family member. The selection of women for suicide operations and the methods used to persuade them are generally similar to those employed for men. The recruiters take advantage of the candidates’ innocence, enthusiasm, personal distress and thirst for revenge.⁴¹

Finally, the question of when to recruit comes into play. Some believe that the recruiting strategy for female suicide bombers is to “get them while they are young as the LTTE leaders personally brainwashed preadolescent boys and girls, many of them orphans.”⁴² Russian authorities seem to believe that “you need complete control of all their conditioning usually from the time they are 11 or 12”⁴³ At the same time, however, the Russians obviate their own argument by noting that the Chechen insurgency hasn’t been going on long enough to “grow” the number of female suicide bombers they are experiencing.⁴⁴ Other Russians believe that the female suicide bombers are “sold” to terrorist organizations, drugged to perform such acts, and/or raped and blackmailed if they do not participate. Finally, as one journalist describing the

Black Widows concluded, "There are so many theories to explain the women's motivation that it is impossible to sort through them."⁴⁵

WHY BECOME A SUICIDE BOMBER?

The answer is that there are "religious, nationalistic, economic, social and personal rewards" for suicide bombers.⁴⁶ Researchers believe there are "few differences between a man and a woman carrying out such a mission. It may be a surprise but motivations are the same: they do believe, they are committed, patriotic, and this is combined with a religious duty."⁴⁷

Religious terrorism is a particularly potent form of violence in that it claims the moral justification for committing seemingly immoral acts. Nationalistic fanatics court suicide bombers and use rhetoric to stir up feelings of patriotism, hatred of the enemy, and a profound sense of victimization.⁴⁸ Suicide bombers then see their own actions as being driven by a higher order and these acts provide rewards for them in the afterlife.⁴⁹ Devout Muslims believe that in death every martyr, male or female, is welcomed by a minimum of 70 apparitions (*hour-el-ein*) of unnatural beauty who wipe away the martyrs' sins, open the gates of heaven, and provide them with all the pleasures that God has given to mankind.⁵⁰

In addition to religious faith and patriotic fervor, a suicide bomber may receive large sums of money, improve her family's social status, and enhance her reputation. After her death, the family is showered with honor and receives substantial financial rewards.⁵¹ Additionally, the suicide bomber sees herself as one who is admired and envied by those left behind. Photographs are taken of her in heroic positions and these photos will be used as recruitment posters.⁵² In fact, a "study of world attitudes by the Pew Research Center showed ever-rising support for "martyrs" and recruiters tell researchers that volunteers are beating down the door to join."⁵³

Finally, many organizations are deliberately targeting women for strategic purposes because female suicide bombers receive more media attention. Research has shown that "public perceptions of the level of terrorism in the world appear to be determined not by the level of violence but rather by the quality of the incidents, the location, and the degree of media coverage."⁵⁴ This use of media is both an advertising and recruitment tool for terrorist groups. Analysts noted that when the first Palestinian female bombing occurred the "news was given great prominence...far more than any male suicide bomber would have received. Women who kill or threaten to kill are hot news. It is a reaction that knows no state or religious boundaries."⁵⁵ Experts worry that "if this catastrophe leads to more women following suit, this will attract

disproportionate publicity.”⁵⁶ The disproportionate publicity, in turn, may induce worldwide sympathies for suicide bombers and can also serve as a terrorist recruitment tool.

HOW ARE FEMALE SUICIDE BOMBERS TRAINED?

Until recently, very little has been known about the female suicide bombers’ training. In February 2003 the ICT published an article which stated that Palestinian female bombers were not trained nor prepared psychologically for suicide attacks.⁵⁷ However, the most recent information, which came from women who have either backed out or been unsuccessful in bombing attempts, proved that wrong. Russian Security Forces captured at least two potential female suicide bombers and the Israeli Army is said to have 17-20 in custody.⁵⁸

Russian officials maintain that the female suicide bombers “were trained abroad by Islamic fundamentalists outside of Russia, are paid for abroad, and are organized by the head of the Arab agents of Al Qaeda.”⁵⁹ All potential bombers “are thoroughly trained by Arab psychologists and demolition experts”⁶⁰ and “clandestine training centers have become a conveyor belt in turning out female cannon fodder.”⁶¹ Zarima Muzhikhoyeva, the first live *shakhidka* (martyr), was captured when her purse filled with 1.5 kilograms of military-issue explosives failed to detonate.

Ms. Muzhikhoyeva’s husband was killed in the first war in Chechnya when she was pregnant with her daughter. A female friend offered to help her and agreed to pay her debts, give her grandparents money, and provide for her daughter – all that was required was that she choose the true road to Allah. She was taken by rebel fighters to the mountains for one month. While there, she cooked and washed the fighters’ clothes, prayed daily, and listened to the atrocities of the Russian troops in Chechnya. When her training was complete, she went to Moscow and was housed with the two young women who later blew themselves up at a rock concert. After her capture, she led police to the house and yard where they found a buried metal container filled with explosive belts.⁶² The Russians released little information from her interrogation or from interrogation of another unsuccessful female suicide bomber, Mareta Dudeyeva.

In Israel, 25-year-old Tawriya Hamamra from the Al Aqsa Martyrs Brigade discussed the training she received in May 2002 before she decided to abort her mission. Two weeks before her mission, she was sent to Nablus, met by a Fatah official, placed in a student flat, and began training. Four people trained her in two 45-minute sessions on Friday and Saturday. On Saturday she told the trainers that she had changed her mind, and although they were angry,

they allowed her to leave. She was arrested the next day in an Israeli raid in the nearby city of Tulkarm.⁶³

The most recent and in-depth look at Palestinian training of female suicide bombers was published in December 2003. The reporter met the commander in charge, trainers, and nine future Palestinian female suicide bombers:

...women were handling explosives and familiarizing themselves with Kalashnikov sub-machineguns. Girls are taught to assemble and dismantle their AK-47 assault rifles and target practice follows – as do hours of theory about the “enemy and its tactics.” The details and outcome of each attack are dissected, revised, debated and discussed. The women spend as much as six hours a day familiarizing themselves with explosives. They are introduced to the bomb belts that will rip their flesh while killing and maiming those around them. Finally, the girls have to practice moving around with the weight of the explosive belts strapped to their bodies. Sometimes the explosives are distributed around the body; some strapped to their legs, others to their backs or abdomens. “It all depends on the build and shape of the woman and how best to strap her without over-bulging parts of her body,” a male handler explained.⁶⁴

IMPLICATIONS OF CHANGE

In March, 2002, after an 18-year-old female killed two innocent people in a supermarket in Israel, a professor of Middle East Studies, commented: “I have a great fear that if this continues, they will pull in younger and younger women. Once they break the boundaries of what is accepted on a human level, there are no boundaries.”⁶⁵ For female suicide bombers, there appears to be few boundaries left to cross.

From a strategic perspective, the most significant change has been the clergy's approval of female martyrs. Suicide bombers believe they are martyrs and are told they are the “true defenders of the oppressed and dispossessed.”⁶⁶ Many experts perceive the problem to be the “blurring of differences and the increased confusion between nationalism and religiosity.”⁶⁷ Until the Chechen terrorist campaign, “the use of female suicide bombers was a clear indicator of secular terrorism. The growth in the number of Chechen female suicide bombers signaled the beginning of a change in the position of fundamentalist Islamic organizations regarding the involvement of women in suicide attacks.”⁶⁸

Some fundamentalist clerics expressed theological dilemmas in sanctioning suicide bombing,⁶⁹ as Islam explicitly forbids suicide (*inithar*). The Koran states: “And do not kill yourself for God is indeed merciful to you.”⁷⁰ Others note that the Prophet Mohammed explicitly forbade suicide and stated, “He who drinks poison and kills himself will carry his poison in his hand and drink it in Hell for ever and ever.”⁷¹ Militant religious leaders have argued that these attacks are acts of martyrdom (*istishhad*) as a means of last resort.⁷² And while God punishes

those who commit suicide, he rewards the martyr. The Koran states: "Think not of those who are slain in the cause of God as dead. Nay, they are alive in the presence of the Lord and are granted gifts from him."⁷³

"According to the level of religiosity, terrorist organizations have different policies concerning women suicide bombers. Saudi Arabia originally refused to legitimize female suicide bombings as martyrdom; however, in August 2001, the High Islamic Council in Saudi Arabia issued a fatwa encouraging Palestinian women to become suicide bombers."⁷⁴ A Lebanese Muslim cleric, Sheikh Mohammed Hussein Fadlallah, said, "It is true that Islam has not asked women to carry out jihad (holy war) but it permits them to take part if the necessities dictate that women should carry out regular military operations or suicide operations."⁷⁵ The Koran states that jihad can be carried out by women as well as men and "most contend that women can serve as combatants only after the male ranks have been depleted. This is the demarcation that had kept Hamas from recruiting women."⁷⁶ In January 2004, that demarcation disappeared.

A second strategic indicator is the implication that female suicide bombing is being supported, financed, and directed by a global terror network. Some believe that the "resort to martyrdom can be explained by an increasing level of internationalization between groups in terms of contact, similarity of causes and examples of strategies."⁷⁷ In the Chechen terrorist campaign, "while the groups involved act in the name of an ethnic-nationalist ideology, they are thought to be cooperating with global jihad organizations connected to Al Qaeda and count several "Afghan alumni" among their commanders."⁷⁸ Additionally, in March 2003, "the Saudi-owned *Asharq Al-Awsat* published an email interview with a leader of the female mujahedeen of Al Qaeda. She told them her instructions came from Al Qaeda and the Taliban, mainly via internet."⁷⁹ The woman went on to state that the organization was planning "a new attack which would make the U.S. forget 11 September and that the idea came from the martyr operations carried out by the Palestinian women."⁸⁰ She further outlined training methods and potential locations. This communiqué was of interest because currently Al Qaeda has "refrained from including women in their operations except in supporting roles. The religious and ideological leap required (to use female suicide bombers) apparently represents a daunting challenge for Al Qaeda. But if the outcome seems worthwhile, there is a real prospect that Al Qaeda, too, will cross the Rubicon, and then find some religious justification for it."⁸¹

STRATEGIC ASSESSMENT

“Although profiling suicide bombers may be a fascinating academic challenge, it is less relevant in the real-world struggle against terrorism than understanding the modus operandi of terrorist leaders.”⁸² “The most important factor is the organization: almost nobody does this as an individual.”⁸³ “Since suicide terrorism is an organizational phenomenon, the struggle against it cannot be conducted on an individual level.”⁸⁴ Most importantly, “organizations only implement suicide terrorism if their community approves of its use.”⁸⁵ “A careful study of all the organizations that have resorted to terrorism since 1983 suggested that the most meaningful distinction among them involves the degree to which suicide bombing is institutionalized.”⁸⁶ Brian Jenkins, a terrorism expert, agrees. “I think we’d all agree that suicide bombing is abnormal. The fact that abnormal behavior is applauded in the community reflects abnormal conditions. If normal conditions are restored, then normal behavior should return – at least they would be less tolerant of abnormal behavior.”⁸⁷

Why would a community view suicide bombing as normal behavior? Some blame military occupation and/or deplorable economic and social conditions.⁸⁸ While those may be valid considerations, why haven’t all cultures that have had similar experiences supported suicide bombers? Brian Barber, a psychologist, interviewed 900 young adults from Gaza and a comparison group of Bosnian Muslims “who had also suffered through violence but had not become a source of suicide bombers. Faith was the largest difference: the Palestinians routinely invoked religion to invest personal trauma with social meaning, whereas Bosnians did not consider religion significant to their lives.”⁸⁹ “The strictly hierarchical nature of religious terrorist groups with a highly disciplined structure and obedient cadre means not only that the main clerical leaders command full control over the political as well as military activities of the organization, but also the strategies of terrorism are unleashed in accordance with general political directives and agendas.”⁹⁰

Even if the community supports this weapon which is legitimized by the religious hierarchy, why are suicide bombings increasing, especially among the young? One explanation is that suicide bombers are seen as successful because their service is for a higher cause⁹¹ and that success “incentivizes those who recruit and send the suicide bombers on their lethal missions.”⁹² Jessica Stern proposes the answer might be “social contagion”:

Ordinary suicide has been shown to spread through social contagion especially among youth. Studies have shown that a teenager whose friend or relative commits suicide is more likely to commit suicide himself. Suicide bombing entails a willingness not only to die, but also to kill others. The situation in Gaza suggests that suicide-murder can also be spread through social contagion. “Martyrdom operations” are part of the popular culture. For example, on the

streets of Gaza, children play a game call *shuhada*, which includes a mock funeral for a suicide bomber. Teenage rock groups praise martyrs in their songs. Asked to name their heroes, young Palestinians are likely to include suicide bombers.⁹³

Research indicates that terrorist organizations will continue to use suicide bomber tactics and employ female suicide bombers. A comprehensive counter-terrorism plan should recognize the increasing potential for use of suicide bombers, including females. Specifically, the U.S. must continue to lead the way in this fight with terrorism. The U.S. has the capabilities (diplomatic, economic, information, military) to provide leadership in combating these problems.

Diplomatically, the U.S. should continue to obtain international and United Nations (UN) support in public designation of terrorists, as well as improved information sharing, tightened border security, and reduction of terrorist financing. The UN Security Council adopted Resolution 1373 which requires all states to prevent and suppress the financing of terrorist acts to include freezing funds and financial assets. In the words of the U.S. Secretary of State, "Diplomacy helps us to take the war to the terrorist, to cut off resources they need and depend upon to survive."⁹⁴ Reducing the funding and tightening worldwide controls should reduce the global reach of terrorist organizations that employ suicide bombers. Additionally, as the most recent bombings have occurred as a result of the Israeli-Palestinian conflict, the U.S. needs to push for peaceful resolution of problems in that area.

Worldwide terrorism uses people as bombs under the guise of addressing human problems and "prevention will require a great improvement in the social conditions that produce, beget or trigger terrorist acts."⁹⁵ Economically the U.S. should help develop an "effective counterterrorist strategy that would seek to reduce the terrorist group's base of support through development programs."⁹⁶ This aid would provide economical, material, and psychological support to those who have identified with terrorist groups. One major reason Hamas has been so successful is because it provides "social aid" that assists the poor, provides medical care, and educates the children. However, it has also been proven that many of these organizations are merely fronts for the funneling of money to terrorist organizations. "Fundraising, training, indoctrination, and criminal activities are usually covered by all kinds of harmless organizations ranging from religious to humanitarian institutions."⁹⁷ These fronts need to be identified and the funding streams eliminated; at the same time, the true humanitarian need can be met by recognized and authentic relief agencies.

On the information front, there are several actions that can be taken. First, as noted above, suicide bombers are part of a larger organization. These organizations and their support of suicide terrorists should be made known and roundly castigated by the international

community. The myth of striking for religious reasons needs to be debunked. The attacking of noncombatants and the overwhelming viciousness of the attacks needs to be visible to all. The suicide bomber should no longer be seen as the “victim” but as the “aggressor.” The key is to change peoples’ perceptions and, therefore, their support of suicide bombers. Changes in behavior will occur when the community no longer views suicide bombings as accepted, normal behavior. The U.S. and the humanitarian organizations should review the education of younger children in schools that are supported by terrorist organizations as “pictures of training camps showing small children learning to become suicide bombers have had great impact on public opinion in the international audience.”⁹⁸ “Goals of a long-range policy should include deterring alienated youth from joining a terrorist organization in the first place. A counterstrategy could be approached within a framework of advertising and civic-action programs which would help to discredit the terrorist group and have a negative impact on their recruitment efforts.”⁹⁹ As has been evidenced, without popular support, a terrorist group cannot survive.”¹⁰⁰

The U.S. should not move militarily unless it has specific, credible information that directly links the organization to terrorists and suicide bombers; however, given that suicide bombers want to die, attacking them militarily may only incentivize others to take up the cause. Finally, Israel has repeatedly struck militarily against the Palestinians – destroying suicide bombers’ homes, displacing their families, militarily retaliating – and, thus far, this action has only engendered an ever-escalating, ever-intensifying hostile reaction. Most importantly, “the question of the moral legitimacy of counterterrorist activities must be analyzed accordingly. How far can a state go in combating terrorism without risking endangering its democratic structure?”¹⁰¹

Operationally the U.S. must improve its intelligence capability using human and technical information gathering. “Intelligence is the first link in the chain of thwarting any terror attack, but is of the utmost importance in thwarting suicide attacks before they are put into practice.”¹⁰² When dealing with suicide attacks, the U.S. should rely on “more and better human intelligence enabling us to penetrate the movement’s armies, monitor its recruitment drives, and predict its evolution – including the type of personnel it will recruit.”¹⁰³ Our counterterrorism strategies should not “rely on standard operation procedures such as race and gender-based profiling”¹⁰⁴ for to do so “is to put the safety of the American people at risk.”¹⁰⁵

Given the globalization of terror from non-state actors, experts believe that suicide bombings, which will include female suicide bombers, will increase. The next “first” will be the “first” Al Qaeda female suicide bomber. The Federal Bureau of Investigation (FBI) has acknowledged that Al Qaeda is actively recruiting women¹⁰⁶ perhaps for just this role.

International terrorist organizations will assess U.S. security vulnerabilities and exploit weaknesses. While this terrorist weapon may not change the political outcome for the U.S. or its allies, it will negatively and emotionally impact American lives, beliefs, and morale.
