ABSTRACT Development and fielding of the F-35A represents one of the priority defense programs for the U.S. The F-35 program was initiated in the early 1990s to provide the premier strike fighter aircraft to the Air Force, Marine Corps, and Navy, as well as international partners for the next several decades. Currently, the Air Force is scheduled to acquire and field over 1,700 F-35As over the next several decades; this basing action is only a part of the Air Force's program to assure availability of combat-ready pilots and maintenance personnel in the most advanced fighter aircraft in the world. This Environmental Impact Statement focuses on the analysis of alternative locations for and the Records of Decision for the Air Force's initial operational wing locations.

Dear Mr. Germanos,

I oppose in the strongest possible terms the basing of the F-35 in Burlington, because, according to the DEIS, the World Health Organization, and the dictates of common decency, the proposed basing would result in unacceptable harm to our community. We have a residential community here with many vulnerable people--children, elderly, recent immigrants from war-torn regions, people struggling with PTSD, people of very modest means among others. My opposition is based on the following considerations.

1. The revised DEIS fails to include reference to the past decade of scientific research on the health effects of F-35 level noise pollution, and thereby greatly underestimated the ill effects of the F-35.
2. This community is already struggling to cope with the heavy impact of F-16 noise and will have great difficulty with a plane that is much louder,
3. In response to an outpouring of citizen opposition, the Winooski City Council in a 5-0 vote on July 12, 2013, asked that Burlington be removed from consideration on the first round of basing decisions.
4. Children's health and cognitive abilities will be negatively impacted with life-long consequences (WHO Burden of Disease from Environmental Noise, 2011), thereby placing the Guard in direct, unending conflict with parents whose primary responsibility is to protect their children.
5. Numerous studies have shown that children are at especially high risk for hearing loss when chronically exposed to extreme noise.
6. There will be an increased risk of cardio-vascular disease for children and adults. (WHO, Burden of Disease from Environmental Noise, 2011). As WHO explains, this means increased risk of loss of healthy years of life, of loss of productivity, and increased risk of premature death for those in the noise zone.
7. Data provided by a respected professional real estate appraiser has demonstrated an average 15% decline in property values for those homes newly placed in the 65 dB DNL contour and thus stigmatized as "unsuitable for residential use". That amounts to an average loss of \$33,500 per home. One select group-- those unfortunate enough to live in the noise zone (most of whom are of modest means)--would alone suffer this huge loss. Wealthy neighborhoods by contrast would suffer no loss in value because they are located outside the noise contour. The Air Force has made no offer of compensation to those subject to great financial loss as a result of the basing.
8. The area subject to the greatest impact contains most of the locally available affordable housing.
9. The crash risk of a new, little tested plane is far too great for a densely populated residential area.
10. The economic benefits, as explained in the DEIS, are very modest and are vastly outweighed by the loss in property values and tax base (approximately \$100 million), the destruction of neighborhoods, loss of quality of life, and by the human and economic costs associated with the health impact.
11. It strains credulity to argue, as some do, that the air defense of the the North Eastern portion of the United States must of necessity be based at a commercial airport surrounded by densely populated residential communities in Burlington Vermont.

The harm to the people of this community that would result from basing the F35 here is so significant and so obvious and so out of proportion to any imagined benefit to the community, that only a breakdown of responsible, rational decision making could have led to the designation of Burlington as a preferred location. It is widely suspected here that improper political influence is responsible for this otherwise incomprehensible designation.

Therefore, for all the stated reasons, I ask the Air Force to remove Burlington from consideration from this and all future rounds of basing decisions for the F-35.

I also urge the Air Force to extend the comment period because a significant part of the revised DEIS was initially omitted.


Dear Mr. Germanos,

I am writing to you to express my deep concerns regarding the potential basing of the F-35A at the Burlington Air Guard Station in Vermont. As the Environmental Impact Statement and the most recent reports on the feasibility of this project have clearly demonstrated, the purported benefits of the F35A being based here have been exaggerated, while the problems it will bring have been underestimated and in most cases, ignored altogether.

Upwards of 6-7 thousand families will find their homes unlivable due to the noise impact of these jets, and the Burlington and Winooski infrastructures have no viable plans—in a housing market that is already at zero vacancy—for replacing these lost homes. Further, the surrounding areas are already negatively impacted by noise from planes. As a Community College of Vermont instructor, I repeatedly have been forced to halt class discussions or lectures while planes passed overhead. The basing of the F-35's in Burlington, will only make this situation more unbearable.

It is particularly disturbing that our local and regional elected officials have, for the most part, flagrantly ignored the overwhelming outcry of a majority of the citizens and that important information was either covered up or neglectfully misrepresented by earlier reports on the possible impacts of these jets. It seems clear that a few politicians are engaged in selling the livability of Burlington and Winooski, destroying thousands of people's lives, for some negligible personal or political gain.

Dear Mr. Germanos,

The Vermont Natural Resources Council (VNRC) is the state's oldest environmental advocacy organization, with a 50-year history of advocating for Vermont's environment, sustainable communities, and a strong economy. We are writing to express our opposition to basing F-35 fighter jets at the Burlington International Airport for the following reasons:

***Impacts from F-35s would undermine the region's supply of affordable housing.***

The Revised Draft EIS (May 2013) states that a significant number of households near to the airport would be affected if the F-35 fighter jets were based at the Burlington International Airport: a total of 2,963 under Scenario 1, and 3,410 under Scenario 2, increasing the number of affected households by 51% and 73%, respectively.<sup>2</sup> These homes, many of which are owner-occupied, single family dwellings, represent an important part of the affordable housing supply in this area – supply that would diminish if residents had to be relocated due to increased noise or safety concerns.

***Chittenden County has a limited supply of affordable housing, and low-income area residents will be disproportionately affected by either basing scenario.***

Affordable housing is essential in Chittenden County, where the median value of owner-occupied housing is 24% higher than in the rest of Vermont.<sup>3</sup> Furthermore, over 30% of homeowners, and well over half of renters, pay more than 30% of their income on housing expenses – making them “housing burdened” according to the U.S. Department of Housing and Urban Development.<sup>4</sup> Compromising the quality of the affected housing by basing the F-35s at Burlington International Airport would exacerbate affordability issues – in the process, impacting those with the least financial room to spare.

Low income residents would be disproportionately impacted by decibel levels exceeding 65 dB DNL in either Scenario 1 or 2; this further underscores the impact on affordable housing. The Revised Draft EIS (May 2013) states that under Scenario 1, there would be a 45% increase in the number of people affected among the general population, but a 130% increase in the number of the area's low income residents affected. Under

Scenario 2, there would be a 68% increase in the general population affected, but over double that – 164% - among the area's low income population.<sup>4</sup>

***Basing the F-35s near existing neighborhoods runs counter to state goals and policies.***

The state of Vermont has long promoted compact land use, affordable housing, energy efficiency, and the development of strong communities through its goals and policies. (Indeed, the city of Burlington's model for affordable housing, developed under then-mayor Bernie Sanders, is replicated worldwide.<sup>5</sup>) This is more than tradition: the promotion of Smart Growth is codified in state statute, and reinforced by state investments. The potentially affected areas represent some of the few compact, urban neighborhoods in an otherwise rural state, and basing fighter jets nearby undermines the land use pattern that we, as a state, are trying to promote.

Furthermore, making these neighborhoods unsuitable for residential use runs counter to the state's transportation, affordable housing and energy goals: neighborhood residents who currently walk, take transit, or whose children walk to school will likely be forced into their cars, leading to more driving, less exercise, and increased carbon emissions.

***Maintaining compact, affordable housing options has environmental benefits.***

A healthy environment and strong communities go hand in hand: compact settlement in the tradition of Vermont's downtowns and villages reduces residential sprawl into undeveloped areas, ensures lower-carbon transportation options, and allows residents to build equity and financial security through homeownership. It also takes pressure off of natural resource areas, ensuring their continued existence for farming, forestry, and recreation – key elements of Vermont's economy.

We recognize the importance of jobs in this region, as well as the many positive contributions of the Vermont Air National Guard to our economy, our communities, and our security, but, on balance, oppose the addition of F-35s to the Vermont Air National Guard Base.

We cannot have a strong environment, strong communities or a strong economy unless people have access to decent, affordable housing. Basing F-35 fighter jets at this location risks undermining the region's supply of affordable housing that is accessible to jobs and transit. Because of this, and for the reasons mentioned above, we oppose the basing of F-35 fighter jets at the Burlington International Airport.

**RE: Why basing the F-35 at Burlington Airport is Illegal under US and International Law Regarding Human Shields**

Dear Mr. Germans and Ms. Ferguson:

In a letter dated July 13, 2013, I stated that basing the F-35 at Burlington Airport is illegal under the Geneva Conventions prohibition against use of civilians as human shields. In the present letter I provide further legal basis from the US Supreme Court and from a law review article in *Military Review*.

The US Senate ratified the [Geneva Conventions](#) in 1955.

In [Hamdan v. Rumsfeld](#), the US Supreme Court said, "For the reasons that follow, we conclude that the military commission convened to try Hamdan lacks power to proceed because its structure and procedures violate both the UCMJ and the Geneva Conventions."

Thus, the Supreme Court recognized the Geneva Conventions as part of US law. There can be no question that ratified treaties and customary international law are recognized as part of US law under Article VI of the US Constitution.

An article, "[Targeting Decisions Regarding Human Shields](#)," by Captain Daniel P. Schoenekase, U.S. Army National Guard, published in *Military Review*, September -October 2004, incorporated herein by reference, describes the law regarding human shields and the requirement for US military personnel to observe the law. After the following extended excerpts from the article I present some conclusions:

**Definition and Classification**

Human shields are noncombatants whose presence protects certain objects or



areas from attack. The use of human shields is illegal under international humanitarian law. Considering the political ramifications of striking targets where human shields are present, it might be beneficial to specify the types of human shields employed.<sup>1</sup>

**Proximity human shields.** Proximity human shields, by their proximity to a legitimate military target, present such likelihood for collateral damage that a military planner would have to consider their presence before striking a target, **as for an example, Iraqi air defenses located in an otherwise civilian neighborhood.** Usually, proximity human shields have not been coerced to participate or have not volunteered to shield defenses. Sometimes, the enemy accomplishes countertargeting **by bringing the potential object of the attack to areas where human shields are present.**

...

#### **Applicable International Humanitarian Law**

Various provisions of treaties and protocols under international humanitarian law prohibit the use of human shields by a party to a conflict. . . .Article 28 of Geneva Convention IV, relative to the Protection of Civilian Persons in Time of War, makes the practice of employing human shields illegal as a matter of international humanitarian law, stating that “the presence of a protected person may not be used to render certain points or areas immune from military operations.”<sup>19</sup>

Additional Protocol I to the Geneva Conventions, Article 51(7)–Protection of the Civilian Population, which contains the key rule regarding human shields, states, **“The presence or movements of the civilian population or individual civilians shall not be used to render certain points or areas immune from military operations, in particular in attempts to shield military objectives from attacks or to shield, favor or impede military operations.** The parties to the conflict shall not direct the movement of the civilian population or individual civilians in order to attempt to shield military objectives from attacks or to shield military objectives.”<sup>20</sup> This provision applies to passive and active human shields whether they are considered proximity, involuntary, or voluntary human shields. Article 51 notably does not excuse considering the presence of human shields during the targeting process.<sup>21</sup>

Article 52(2), General Protection of Civilian Objects, states that attacks shall be limited strictly to military objectives and defines military objectives as “those objects which by their nature, location, purpose or use make an effective contribution to military action and whose total or partial destruction, capture or neutralization, in the circumstances ruling at the time, offers a definite military advantage.”<sup>22</sup> Article 52(1) says, “Civilian objects are all objects which are not military objectives as defined in paragraph 2.”<sup>23</sup>

**Article 58, Precautions Against the Effects of Attacks, creates a duty against the passive creation of proximity human shields:** “Parties to a conflict, to the

extent feasible, shall remove the civilian population and material under their control from the vicinity of military objectives, **avoid locating military objectives within or proximate to densely populated areas**, and take other necessary precautions to **safeguard the civilian population** and civilian objects under their control against the dangers of military operations.”<sup>24</sup>

The United States is not a signatory to Additional Protocol I and, thus, not bound by it, but the United States has accepted many of its provisions as customary international law and, therefore, adheres to its norms.<sup>25</sup> In 1987, U.S. State Department Deputy Legal Advisor Michael J. Matheson enumerated many of the principles in Additional Protocol I that the U.S. considers customary international law, including Articles 51 and 52.<sup>26</sup> The 1998 Rome Statute of the International Criminal Court (ICC) has the jurisdiction to prosecute **war crimes**, including “utilizing the presence of a civilian or other protected person to render certain points, areas, or military forces immune from military objectives.”<sup>27</sup>

### **Targeting Principles**

Given the modern nature of war and the transition of most societies to an industrialized economy with urban centers as their focal point, it seems likely that legitimate military targets will be located near civilians or civilian objects simply out of efficiency or because of urban growth. The Geneva Conventions and Additional Protocol I still mandate a duty on a party to a conflict to remove civilians from such an area, but that might not be practical in all situations.

...

Targets protected by human shields might still be attacked subject to the attacking party’s obligations under international law to minimize collateral damage. Collateral damage usually occurs when attacks targeting military objectives cause civilian casualties and damage to civilian objects. It often occurs when military targets are located in urban areas.<sup>29</sup>

...

The Rome Statute for the ICC lists “extensive destruction and appropriation of property, not justified by military necessity and carried out unlawfully and wantonly” as a grave breach.<sup>32</sup>

**Principle of discrimination (distinction).** Commanders must distinguish civilians and civilian objects from combatants and military objects under the principle of discrimination. Civilians enjoy immunity insofar as they “enjoy general protection against dangers arising from military operations” and “shall not be the object of attack.”<sup>33</sup> The principle of discrimination is codified in Additional Protocol I, Articles 51(4-5) and 57(2)(a)(i), which prohibit indiscriminate attacks.<sup>34</sup> Attacks must be directed at specific military objectives and cannot “employ a method or means of combat which cannot be directed at a specific military objective.”<sup>35</sup> Examples of indiscriminate attacks are carpet bombing and Iraqi Scud launches during Operation Desert Storm.



...

**Principle of proportionality.** The U.S. Army's definition of the principle of proportionality states that the "anticipated loss of life and damage to property incidental to attacks must not be excessive in relation to the concrete and direct military advantage expected to be gained."<sup>37</sup> This definition is clearly based on Additional Protocol I, Article 51(5)(b), which states that when collateral damage is expected or unavoidable, it must be proportionate to the military advantages of striking the target.<sup>38</sup>

### **Conclusions**

It is not out of the question that when a country is engaged in wars that it may find its own territory under attack at some point. In view of the recent use of currently based F-16s in Burlington to attack other countries, the Vermont Air National Guard Station became a military target in the ongoing global war in which both sides are targeting the other in various places.

The basing of more first-strike attack weapons, like the stealth F-35, at the Burlington airport would make the airport a more important military target and would make the airport a target for a wider range of potential enemies than it is now. The kind of enemies for which stealth is a factor may have substantially greater military capabilities than for an aircraft that lacks stealth. Military facilities in the US equipped with such stealth first-strike attack weapons must be considered to be military targets.

The basing of the stealth first-strike F-35s at the Vermont Air National Guard Station would make the Burlington airport a legitimate military target for potential enemies. Because of the dense population adjacent to the Burlington airport, this basing of the F-35 would violate provisions of international and US law, including Article 28 of Geneva Convention IV and Articles 51 and 58 of Additional Protocol I that make the use of human shields a war crime.

The Air Force EIS should be further revised to address the environmental, health, safety, and legal consequences of making families in neighborhoods adjacent to the Burlington airport into human shields. It should also be revised to include the consequences to them of being collateral damage if the Burlington airport is targeted with a military attack in the ongoing wars in which the US is engaged. It should also describe the economic effects in the aftermath of such an attack. The time for considering these consequences is now, in the Air Force draft Environmental Impact Statement, before a basing decision is reached.

Dear Mr. Germanos and the U.S. Air Force:

I am writing to highlight significant flaws in the F-35A Operational Basing Environmental Impact Statement, May 2013. Specifically, I will be addressing the proposed basing of the F-35A at Burlington International Airport. I would also like to go on record as opposing the basing of these planes at this location (BIA) because the environmental, health, and housing implications are excessive for the community.

It is worth noting that the effects upon both the number of residents and the number of housing units are far greater at BIA than at all other basing options by a very wide margin.

I would like to mention three important flaws in the EIS:

Health Impacts of Aircraft Noise:

During the last 13 years there has been a great deal of research regarding the health affects of noise, and most specifically aircraft noise. Why none of these studies are cited in the EIS is baffling and troubling. These studies are both domestic and European, and include the World Health Organization. For reasons I can't understand, only studies from many years ago were included. There is much more information available today.

The EIS has used outdated information, which makes this statement in the EIS false:

**"In summary, there is no scientific basis for a claim that potential health effects exist for aircraft time average sound levels below 75 dB. The potential for noise to affect physiological health, such as the cardiovascular system, has been speculated; however, no unequivocal evidence exists to support such claims (Harris 1997)."**

Significant health affects of noise, particularly aircraft noise, are a given and accepted by both the medical and scientific community. As recently as two days ago in a NY Times article, this was stated:

NYTIMES article July 12, 2013

**"Beyond harming hearing, chronic exposure to noise increases the risk of cardiovascular disease. Children in classrooms buffeted by outside noise lag behind, and their teachers report lower job satisfaction. Pervasive background noise may damage the hearing center of babies' developing brains, research has found, possibly leading to auditory and language-related development delays. And though people may assume they have grown accustomed to noise, a constant din, even at low frequencies, often takes a heavy physiological toll. Noise can cause stress even when a person is sleeping.**



**"There's definite clearly defined cardiovascular impacts such as hypertension," said Robyn Gershon, a professor in epidemiology and biostatistics at the [University of California, San Francisco](#), who has heavily researched urban noise, with a focus on New York City. "Also learning impairment in children, impacts on attention, memory, and worker productivity." Sleep disturbances are also linked to excessive noise, with higher production of stress hormones, which, she noted, can adversely affect the immune system"**

On a personal note, I would like to add that I suffer from a medical condition called "hyperacusis". Basically, I am unable to tolerate loud noise and suffer severe and lasting pain from at high-decibel levels. I also often must sleep during daytime hours. Without question, the recent increase in noise of the current F16 operations have severely impacted my own health, and my home is just outside of the 65db DNL contour. Quite frankly, I am suffering by this recent increase in noise level, and have now had to put my own home on the market.

#### Housing Impacts:

As you probably know, the updated EIS shows significant increases to the impacted housing totals from the original dEIS. The current EIS now uses information from the 2010 Census, while the original dEIS used 2000 data. Nevertheless, it is my observation that these figures are still inaccurate and below actual totals. Having served on the South Burlington Planning Commission until March, 2013, I believe these numbers remain low and population is being undercounted. The EIS also does not account for recent development projects during the last three years, not to mention others that are in the pipeline for approval in South Burlington, Burlington, and Winsooki. This will easily be more than 1,000 additional individuals who will be in the 65db zone.

This region is the most densely populated area in the entire State of Vermont, and it continues to grow by large numbers. Limiting housing growth in this area will have a major impact upon the local economy. Yet other basing options remain that are more rural, and offer population densities that are much less significant. In my opinion, the F-35A should be based at other locations to minimize negative impact, not maximize it.

#### Use of Flawed FAA Part 150 Data:

But to me the most important item is that the EIS uses the FAA Part 150 2011 "projected" db DNL contours for comparison with the F-35. This 2011 study was viewed as a "projection", and never accepted as either accurate nor acceptable. These DNL lines show huge increases encompassing many more homes than the 2006 FAA Part 150 report, which only showed 65 db DNL barely around the actual perimeter of the airport. The 2006 report was used for the Airport Acquisition Program. By all accounts, including testimony from the Air Force themselves, the Air Guard has increased noise levels the last few years due to takeoffs with F-16 afterburners, which is likely why this 2011 study shows possible additional impacts. But just because they are making more noise the last few years does not mean it is an acceptable level of noise. When the South Burlington City Council first saw the "projected" 2011 db DNL contour lines, many members were aghast. But now the EIS somehow has taken the position that this is "accepted levels", even though no EIS was done at the time on those increases. The failure of local government and its officials at the time to adequately understand, research, and analyze the 2011 data does not in any way ratify it as being acceptable or endorsed, and it should not be used in the F-35A comparison.

In my opinion, the EIS should be comparing the 2006 FAA Part 150 db DNL noise contours with the F-35A, not the "projected" 2011 study, which has never been studied fully. And noise levels should go back to the 2006 study, because that is what was used when the Councilors approved the Airport Buyout Program.

In simple conclusion, I urge you to base the F-35A elsewhere, at a location which will have much less significant impacts upon the community. I am an 8th generation Vermonter who lives in South Burlington, where the Air Force is threatening to base their new incredibly costly F-35 jets. I am a librarian who works at the public library in Burlington, Vermont, and the mother of two children. My husband works at the University of Vermont as a physics lecturer. We love our community. It is a beautiful place where people really care about each other.

I firmly oppose the basing of the F-35s here, and will continue to do so. At every level, including the process by which they are being forced on us, the basing of the F-35's here stands in direct contrast to the values of due process, transparency, healthfulness, economic justice, and egalitarian cooperation by a concerned citizenry that have characterized Vermont for the past 200 years.

Frankly, I'm disgusted. This is not what we want here. We're a state that doesn't even allow billboards. Why would we want a bunch of wildly overpriced, wasteful, environmentally unsound, incredibly disruptive, potentially damaging war tools flying around ruining our quality of life and possibly hurting our children? Burlington, VT and Vermont as a whole have been repeatedly named in national rankings as places with high standards of health for women and children, and as places with some of the best quality of life in the country. I don't believe that will continue to be the case if the F-35s come here, to the most densely populated area in the state.

I'm not really sure why the Air Force continues to push the issue of basing the (untested, potentially dangerous, definitely deafening) F-35s in our community when the majority of people here and in the greater Burlington area - again, the most densely populated area in the state- have been in opposition to it. Certainly, it wasn't that long ago that they closed the nearby Plattsburgh, NY air force base stating reasons of economy and the need for greater efficiency. Are we really that much more "strategically favorable" to them such a short time later? None of this seems logical.

Oh, wait - unless you take into account the money to be made by local and national developers once they destroy the oldest and most defined residential community in South Burlington, seeded with our tax-funded buyout money. If this happens, it will mean nothing less than a total collapse of trust in our local government and military. This could be devastating for our community, which is already struggling economically and feeling cynical about the government.

The jobs that will be brought here by the predictable commercialization of the area around the airport are not the kinds of jobs we need. We don't need more low-wage service positions so that we can continue to barely keep our head above the water while catering to the whims of the wealthy. However, the people of Vermont are passionate and vocal, and we don't care for it when someone tries to pull the wool over our eyes. If the Air Force continues to press the F-35s on us in collusion with the local developers who stand to gain from its placement here, they will be in for a strong fight.

Greetings Mr. Germanos,

I am writing to you regarding the basing of the F35 in SOUTH BURLINGTON, VERMONT. I am strongly OPPOSED to the base being placed in such a congested residential area. Every other option for this basing will affect considerably fewer people and to my knowledge the few folks who wrote to you during the first statement period concerning the basing at places other than South Burlington were all in favor of those places. Most of the previous statements were about South Burlington and of those the majority were against basing the F35 here.

You may have received a number of postcards from folks who support the basing. Postcards that required nothing more than a stamp. No thought required. The statement sent out with those postcards said that the F35 would be no more noisier than the F16 but the impact statement says otherwise. Did those who sent the postcards in really look into the matter? Do they really understand what basing the F35 here will do to our community?

There are so many reasons why the F35 is wrong for our community.

\* Noise levels will increase to a level (3-4 times that of the F16) not compatible for residential use over a large area. That area covers a region that is densely populated with low and moderate income families, including 3300 households for a total of 7700 people. These are folks who can least afford to move out of the zone and with the metro area here having a very low rate of available housing there is no place for them go. Studies cited by the newest DEIS show proof that health problems from exposure in 65+ dB areas include READING, HEARING, MEMORY-RETENTION AND ACADEMIC PERFORMANCE PROBLEMS. This includes South Burlington's Chamberlain school where the noise level is expected to be 68-70dB. According to a 2010 World Health Organization report 50% of children in high noise areas will suffer cognitive impairment. Health affects for adults have also been shown. This first point alone should be reason enough not to base the F35 in this dense residential area.

\* Safety concerns are still a big issue with the F35. It's track record is, at this point, abysmal. It is estimated to be 11 times more likely to crash and because of its design doesn't fly but rather falls when it loses power. Around here that means that it will crash in a residential area ]

\* There will be a negative environmental impact on the area. Even the DEIS states that basing the F35 here would NOT be "ENVIRONMENTALLY PREFERABLE."

\* The economic impact of basing the F35 in South Burlington would be negligible or minor. It appears that not basing the F35 here would probably not have much of an impact either. The second statement cannot be confirmed as easily as the Vermont Air National Guard refuses to release that information. However based on the extension of the F16 program for 20 years you can project that if the F35 never comes then the current guard employee level will not be reduced until a considerable number of years in the future. On the other side, if the F35 were to arrive in South Burlington in 5 years then over 7,700 local residents will suffer from:

- \* Decrease in quality of life ]
- \* Decrease in home values

\* Homes will be labeled unsuitable for residential use by our own federal government and thus undesirable and perhaps even unsalable. ]

The Air Force has said that the F35 basing will not happen where it's not wanted. I believe you've heard loud and clear that we do NOT want the F35s here. The question is whether the Air Force is independent or under the gun of Mr Patrick Leahy. We know how powerful our senior senator is and our fear is that the choice is not yours, it is his, no matter what the citizen have provided for input.

Based on the DEIS alone there is no clear case for the basing of the F35 jets in South Burlington, Vermont. Coupled with the citizen response a decision to base the jets here cannot, in good conscience, be made.

Please enter my opposition and statement into the permanent record.
