EXECUTIVE SUMMARY

As part of the Data Reduction and Computer Group (DR&CG) Task-32 (DR-32), this document contains the Growth and Migration Plan for the Data Insight code base. This document describes the areas of Data Insight that need to be developed in order to make it, with MATLAB, the software platform of choice for post-test telemetry data reduction analysis. The document also discusses the manner in which to acquire Data Insight and the cost for the consulting engagement to continue developing Data Insight.

The background for DR-32 is described in the DR-32 Final Report at <u>Appendix A</u>. An excerpt from the Final report is shown below:

"The goal of DR-32 was to begin the initial phase of providing a common telemetry data reduction system that can be used DoD-wide. Given the parameters of several members data reduction/analysis systems, leveraging a replacement for DataProbe, which was common among many members, was viewed as a good start for the initial phase. To that end, this initial phase was successful. However, to the overall goal of providing a common telemetry data reduction system, follow-on tasking was required to go further. The follow-on tasking request to RCC was denied for reasons that the tasking was outside the DR&CG charter. When the follow-on tasking was denied, a modified scope was adopted that maximized the initial phase vice the ultimate goal.

In light of maximizing the initial phase, those members who have embraced MATLAB as its foundation for data analysis and, for those members who needed to find a bridge from DataProbe to MATLAB, both Data Insight and the Telemetry Toolbox provide a "first base" solution. Members can purchase maintenance of Data Insight from MathWorks directly via a GSA Reseller. Members can also contract Raytheon Missile Systems to modify the Telemetry Toolbox to fit their data analysis requirements. The adjective, "first base" denotes that both systems are immature. Much work and funding is required to get them to what one would consider a robust, performing system. Several user communities are using both systems.

Per the deliverables of the modified scope (approved by the DR&CG board), an operable beta release of Data Insight with a Growth & Migration Plan for members to follow was delivered. The definition of operable, however, is somewhat of a misnomer. No member should think that they would, necessarily be able to take the Data Insight version delivered here and proceed to use it effectively without help from MathWorks Consulting Division. Further, participating members are continuing to fund updates via maintenance contracts and, as such, the delivered beta system is not something one should invest time or effort into adopting. The recommendation of this report is that if you want to view the best Data Insight has to offer, contact MathWorks for a beta release of the most recent release. Telemetry Toolbox, and a Growth & Migration Plan for it, was not delivered as the modified scope limited the focus to only Data Insight.

The deliverables of this task do not provide a growth and migration plan to a common telemetry data reduction system that can be used DoD-wide, i.e., a plan that discusses how to bridge from DataProbe to Data Insight/Telemetry Toolbox to a common, open source, telemetry data reduction system. To understand why, it is critical to remember that this task was always viewed as the first step to a lengthy process. The lofty goal of providing a beta system that actually worked to bridge DataProbe users to a PC based system using MATLAB was extremely successful given a \$100K investment vice the 10 million dollars originally invested in creating DataProbe. Hence, the Growth & Migration Plan delivered with this task is focused at the granular level of the bridge of DataProbe to Data Insight. It was originally planned to use a portion of the funds to provide a Growth and Migration Plan that addressed the global common picture, but as was stated, a decision was made to maximize the initial phase given the decision by the RCC to not continue this line of tasking."

INTRODUCTION

The Data Reduction and Computer Group (DR&CG) of the Range Commanders Council (RCC) put forth an initiative (DR-32) to determine the feasibility of using the Data Insight code base, written in MATLAB, to help transition DataProbe users to MATLAB. Data Insight is a set of MATLAB M-files used for importing data from a data source via a DataProbe dictionary. Data Insight has many capabilities, including production of basic plotting routines for time-series objects as well as report generation compatible with Microsoft Word and Microsoft Excel documents. This document fulfills the requirements of the modified scope of Task DR-32 to provide a Growth and Migration Plan for Data Insight.

To accomplish the DR-32 initiative, members of the DR&CG entered into a contract with MathWorks Consulting to acquire, develop, test, document, deploy, train, and support Data Insight. This contractual arrangement provides two unique opportunities. First, it allows interested parties to immediately have access to Data Insight, thereby allowing them start migrating from DataProbe. This arrangement is different than most consulting engagements where the user would need to start from scratch with requirements, development, testing, etc. Second, the MathWorks Consulting group will use tested development approaches towards the development efforts of Data Insight. This approach will allow Data Insight to have a common look and feel of other toolboxes as well as being able to take advantage of a tight coupling with MathWorks Development. In other words, this approach will provide input on Data Insight for development of features needed in the MATLAB language.

The recommended approach is that development of Data Insight be carried out in two phases. The first phase will include creating a vehicle for acquiring Data Insight and providing immediate support for the code base as is, making structural changes where needed, making improvements to the documentation, and providing an updated Data Insight demonstration model. The second phase is a longer term approach to the development of Data Insight, including writing a requirements document, writing a design document, possible support for non-DataProbe dictionaries, improving the MATLAB core features as well as add-on toolboxes, and perhaps a graphical user interface (GUI).

INTENDED USERS OF DATA INSIGHT

3.1 Categories of Intended Users

There are three types of intended users of Data Insight; the first two types are post-test engineers¹ and the third type is the System Administrator (SA).

3.1.1 <u>Post-test engineers (non power users of MATLAB)</u>. The first type of intended user is the engineer who is familiar with using a test exercise analysis tool. The user:

- a. Typically uses an in-house tool such as Boeing's QuickView to import data, perform analysis, plot and annotate, and create reports.
- b. May be familiar with MATLAB, but is not a power user.
- c. Is looking for a Commercial Off-The-Shelf (COTS) package that offers the option of minimal usage of the MATLAB Command Window.

3.1.2 <u>Post-test engineers (comfortable with MATLAB)</u>. The second type of intended user is the engineer who performs the same functions as the first, but is much more comfortable using MATLAB. The user:

- a. Will most likely want to add to and increase the Data Insight functionality.
- b. Will have a solid understanding of the back-end functionality of Data Insight.
- c. Does not require a "canned" application due to familiarity with MATLAB, and in many cases, will not use a specific graphical user interface (GUI) application.

3.1.3 <u>System Administrator (SA)</u>: The third type of intended user is the Systems Administrator (SA) for Data Insight. Specifically, the SA:

- a. Will be responsible for creating a FileDef structure for a specific DataProbe data dictionary.
- b. Should be very familiar with the layout of the dictionary and has at least minimal knowledge of MATLAB in order to write scripts.
- c. Could also be one of the above post-test engineers, but most likely the second one.

¹ Data Insight does, however, have the capability to work with growing data sources (i.e. the data is being acquired in real-time).

DEVELOPMENT PLAN FOR MATURING DATA INSIGHT

4.1 Planned Actions

The following section is not an exhaustive development plan, but it outlines specific technical issues and plans for the development of Data Insight. MathWorks Consulting has been engaged in research since September 2002 in preparation for supporting Data Insight. Based on code investigation and user feedback, the following subparagraphs describe immediate actions (in priority sequence) that need to be completed.

4.1.1 <u>Develop unit tests</u>. Unit tests will be written and executed via a test harness², thereby automating the regression testing process. Both the unit tests and the test harness will be written in MATLAB, a practice that is similar to how MathWorks Development executes Quality Engineering. These tests will ensure no regression bugs are introduced and also determine structural and usability issues. The unit tests will be more beneficial to the user site if real data from the test site is used for testing. The data should be non-classified and nonproprietary so that the data can be shipped as part of the test suite.

4.1.2 <u>Re-architect the code base</u>. After an initial evaluation of Data Insight, several key underlining pieces need to be enhanced. Specifically, Data Insight makes use of the MATLAB *assignin* and *evalin* functions, mutates base workspace variables, does not have key functionality of MATLAB classes, and immediately dumps all of the variables into the MATLAB workspace when opening a data source. Before adding additional features, these and other issues will be addressed by looking at the architecture to determine if any pieces need to be redesigned.

4.1.3 <u>Add missing key features</u>. Requirements are still being gathered in order to determine missing features and their order of importance. At this juncture, the following list outlines possible areas that need to be addressed.

- a. Auto convert DataProbe dictionary to MAT-files: Rather than reading a data source via a dictionary, use a MAT-file to improve the speed of loading.
- b. Remove latency code: Determine and remove bottlenecks in the source code.
- c. Improve helper functions: Perform error handling and write code to improve the robustness of dictionary and utility functions.
- d. Add Dictionary Tools: Add, delete, and modify variables in a DataProbe dictionary.
- e. Add Time Series math: Add math function to a Time Series object.
- f. Improve report generation: Improve the robustness of generating Microsoft Word and Microsoft Excel documents: Consider other report formats, such as PDF and XML.

4.1.4 <u>Rewrite documentation</u>. The current documentation will be updated to reflect new features as well as the re-architecture. The first pass of the update will modify the document to have the look and feel of MathWorks documentation. This will enable integration of the online document into the MATLAB Help Browser.

4.1.5 <u>Create installer</u>. Currently, Data Insight is installed via a ZIP file. After the installation, the MATLAB path is not updated, and so the user must modify the path. The path modification is done typically through a MATLAB script. Immediate plans would include using InstallShield to create a user friendly, polished installer that would also update the MATLAB path.

4.1.6 <u>Create training material</u>. The current training material consists of documentation and the demonstration script. Training material will be developed using Microsoft PowerPoint for educating the user on creation of a FileDef structure, opening data sources and dictionaries, manipulating raw data vectors, performing time series analysis and associated plotting, generating reports, and other tasks.

4.1.7 <u>Write Requirements and Design Documents</u>. MathWorks Consulting needs to write a formal requirements document for importing telemetry data into MATLAB via a DataProbe dictionary. Several sites have already sent requirement documents, including:

- a. Tyndall Air Force Base.
- b. Redstone Arsenal Army.
- c. Cessna Aircraft.
- d. Patuxent River, Naval Air.
- e. China Lake, Naval Air.

Collating the requirements and writing the document is imperative to ensure all features and constraints are considered prior to full development of Data Insight.




Figure 4-1. Bug and enhancement submission process.

Once the features have been identified and added to the Data Insight Requirements document, the designs for specific components need to be written. The designs will be reviewed by the Data Insight Review Team (RT) and added to the Data Insight Design ("Design") document (see Figure 4-1).

4.2 **Prioritizing Features and Bug Fixes**

All feature requests and bug reports will be sent to MathWorks Consulting (<u>datainsight@mathworks.com</u>) and tracked using Microsoft Excel. The following section describes the process for handling development requests.

4.2.1 <u>Features</u>. After reviewing the request, MathWorks Consulting will advise the requestor whether the feature will be added to the Requirements Document or whether it will be deferred. If the request is accepted, MathWorks Consulting will inform all members of the RT that a request has come in and added to the Requirements Document. The requestor will then work with MathWorks Consulting to write a specification for the feature. If any members wish to add sub-requirements to the proposal, they may do so. Once written, the specification will be

submitted to all other RT members for review. Once approved by the RT, the specification shall be added to the Design Document. The approval process is outlined at <u>Figure 4-1</u>.

If MathWorks Consulting determines that the feature will not be added to Data Insight and the requestor wishes, the consulting team can let the RT decide if the feature shall be added or not. If the RT decides in favor of the requestor, then the request will be added to the Requirements Document and the process shall continue as normal. If, however, the RT declines the immediate need for the feature, the feature will be postponed indefinitely.

Once processed, all features will be assigned a priority as decided by the RT.

4.2.2 <u>Bugs</u>. Similar to features, when a bug is submitted, the request shall be sent directly to MathWorks Consulting. Once MathWorks Consulting has reviewed the request, it will contact the requestor, stating whether or not the bug will be fixed in the near future. If MathWorks Consulting determines that the bug will not be fixed, the requestor can submit the request to the RT.

Once processed, all bugs will be assigned a priority as decided by the RT.

4.2.3 <u>Priorities</u>. All feature requests and bugs will be assigned one of four priorities.

A - Signifies that the feature or bug <u>must</u> be added or fixed prior to the release of the next major or minor (but not necessarily beta) release.

B - Signifies that the feature or bug has <u>major</u> priority for the next major or minor release.

C - Signifies that the feature or bug has minor priority for the next major or minor release.

D - Signifies that the feature or bug will not be addressed in the foreseeable future.

As features are added and bugs become fixed, periodically, a conference call will be held to update the RT the status of the bugs and enhancements. The Microsoft Excel spreadsheet will be sent out prior to the conference call to be reviewed. Once work becomes finished, the bugs and enhancements will become reprioritized. In addition, as a release date becomes closer, bugs and enhancements will be triaged in order to maintain a reasonable development cycle.

4.3 Data Insight Review Team

The Data Insight Review Team (RT) is responsible for reviewing requirements and toplevel design (specifications) for Data Insight. The team is comprised of:

- a. Team Leader (Project Leader of Data Insight, MathWorks Consulting).
- b. Data Analysis Tool Development Lead (NUWC, Keyport.)
- c. Technical point of contact (TPOC) at each site.

Prior to joining the RT, the TPOC must provide a requirements document outlining features and constraints that the site is looking for in a test exercise analysis tool. The site's requirement document will be reviewed by the Team Leader and brought to the RT if needed. Once reviewed, the requirements will be collated with the Requirements Document. Both the Requirements and Design Documents will be placed under source control, but not shipped with the Data Insight documentation.

The RT is responsible for reviewing new features requests, helping to prioritize features and bug fixes, and reviewing designs for specific features. This will make certain that a feature or bug feature is useful for the entire community not just one site. Conference calls will be held from time to time to discuss the status of the project with the team. The RT will also advise MathWorks Consulting timeframes for releases of Data Insight.

A "majordomo" software program to automate the management of Internet mailing lists will be created for the team.

4.4 Migrating from DataProbe to MATLAB

One of the key capabilities of Data Insight is the ability to use a MATLAB data structure to mimic the open_dat.prb file. The structure was intended to ease migration from DataProbe to MATLAB by assigning the structure's field names to that of characteristics of the DataProbe Dictionary. For example characteristics would include the length of the file header, the units of the record length, and the frame id, etc.

4.5 Connectivity to Third Party Applications

If necessary, capabilities to interface to other applications may be added. These capabilities include, but are not limited to:

a. Data transfer - Once the data has been imported to MATLAB, functionality may be added to export the data to MATLAB-based data files, proprietary or non-proprietary data formats. Examples of data formats include:

- 1) MATLAB MAT-files,
- 2) Microsoft Access,
- 3) Microsoft Excel, and
- 4) XML

b. Data streaming - MATLAB is capable of calling third party applications via several methods, including, MEX-files, Java, and COM. Therefore, if a third party application has a C/C++/Fortran/Java interface, data could be streamed from MATLAB to it.

Note: Data Insight is an application that runs on MATLAB and requires MATLAB to run.

4.6 MathWorks Consulting's Need to Obtain Copy of NTProbe³

A key objective of Data Insight is to help transition DataProbe users to MATLAB. Therefore, it is imperative that MathWorks Consulting be provided a legal copy of NTProbe as well as all relevant documentation in order to:

- a. Determine missing features in Data Insight (and MATLAB).
- b. Create benchmark test vectors to ensure that Data Insight performs as well, if not better, than DataProbe.
- c. To help determine how DataProbe performs Time Series math.

³ NTProbe is the PC equivalent of DataProbe.

PROJECT MANAGEMENT

5.1 Configuration Control

All source code and support files, such as unit tests, training material, and documentation, will be maintained under revision source control. The revision tool used will be CVS, (<u>http://www.cvshome.org</u>). Although under source control, Data Insight will not be shipped with the CVS repository.

5.2 Release Schedule

First and foremost, the release schedule is dependent on (a) funding and (b) user requirements. Each development cycle will produce a major update and two minor update/bug fix releases. The current <u>tentative</u> schedule as follows:

September 30, 2003:	Ship Data Insight 0.6 beta (minor release)
January 26, 2004:	Ship Data Insight 1.0 (major release)
April 26, 2004:	Ship Data Insight 1.1 (minor release)

The remainder of FY04 will be determined after the release of Data Insight 1.0.

PRODUCT AND MAINTENANCE PLAN

6.1 Product and Maintenance Provided by MathWorks Consulting Group

This chapter discusses specifically what is and what is not covered under the Product and Maintenance Plan. The service offering consists of the Data Insight software and a yearly maintenance plan for Data Insight. The software is free of charge, does not run under a license manager, and does not expire. However, the yearly maintenance plan does have a site charge (see <u>Chapter 7</u>) that begins at the start of the fiscal year. The fiscal year starts October 1st of the current year and ends September 30th of the following year. A site is defined to be a group of end users not to exceed 30 users. The group of users must select one person to be the technical point of contact (TPOC). All technical and business questions shall go to and come from the TPOC.

The maintenance shall include the following:

- a. <u>Product updates and enhancements</u> Non-expiring M/P/MEX-file for all source code. The source code may come in the form of M-files, P-files, MEX-files, or other forms such as C and Java. MEX-files will ship for all platforms that Data Insight was developed for (i.e. the current shipping version of MATLAB).
- b. <u>MATLAB based test suite</u> The test suite will contain unit tests for each of the functions (unless deemed unnecessary by MathWorks Consulting) as well as system tests based on beta user-supplied data sources and dictionaries. The tests and test harness will be written in MATLAB.
- c. <u>Documentation updates and enhancements</u> Documentation will be provided for both the source code as well as the test suite. Documentation will be provided in two formats (PDF and HTML). The HTML shall be fully integrated into the MATLAB Help Browser. For the source code, a programmer's manual and a reference guide will be provided.
- d. <u>Known bugs and issues</u> Each release of Data Insight will include a list of known bugs and issues as well as bugs from previous releases that were fixed. The RT will decide the granularity of which bugs are listed; however, it is likely that from a priority range of **A**, **B**, **C**, and **D** (**A** being the highest priority to fix), that only bugs assigned priorities **A** and **B** would be listed. It is noted that the members of the RT would have a complete list of all bugs and issues.
- e. <u>Demos and examples</u> Demo files, written in MATLAB, will be shipped outlining the key features of Data Insight. In addition, any examples provided in the documentation will be shipped.
- f. <u>Access to technical support for Data Insight</u> The TPOC will be provided support for Data Insight. All Data Insight requests should go to <u>datainsight@mathworks.com</u>. All other MathWorks licensing and product-related issues should continue being sent to <u>support@mathworks.com</u>

g. <u>Training</u> - Any presentations, examples, and exercises used for training will be shipped with Data Insight. Services also include one day of onsite training based on the training material. Though the site is expected to have a working knowledge of MATLAB⁴, a quick overview may be shown. The training will last for the duration of one day. The price of the maintenance shall <u>not</u> be changed regardless of whether or not the site uses onsite training. All training material (slides, examples, exercises, etc) will be maintained with each major release and distributed with Data Insight.

All deliverables listed above will be bundled into an InstallShield or similar installer.

6.2 Additional Available Consulting Services

The following sub-paragraphs describe services that are available as an additional consulting engagement and are not part of the core consulting engagement for the development of Data Insight.

6.2.1 <u>Creation of FileDef structure</u>. In order for Data Insight to use a DataProbe dictionary, the site must create a FileDef structure that describes the dictionary. The Data Insight documentation describes in detail how to create this MATLAB structure. A service may be provided to create a specific FileDef structure for the site.

6.2.2 <u>Conversion of DataProbe scripts</u>. Many sites have existing DataProbe scripts. There is no plan to support automatic or manual conversion of these scripts to MATLAB scripts. A service may be provided to translate DataProbe scripts to MATLAB.

6.2.3 <u>Onsite support</u>. Maintenance support does not include onsite support (with the exception of a one-day training which is included in the maintenance plan). A service may be provided for onsite support.

PRICING & PURCHASING

7.1 Plan

There is no cost for the installation and use of Data Insight software, including all source code. Data Insight will not expire its software usage and will continue to work with users in good standing depending on changes made to future versions of MATLAB.

Each site is required to subscribe to at least one year of maintenance. The one-year maintenance plan will provide the site with technical support for Data Insight and provide all software updates throughout the U.S. Government fiscal year (October 1 through September 30). Support and usage of Data Insight does <u>not</u> require the site to be on a current subscription plan to MATLAB; however, features <u>and</u> bug fixes will be developed on the latest public version of MATLAB. This does not imply that newer versions of Data Insight will not work on older versions of MATLAB, but that there is no guarantee of backward compatibility. Although no testing will be done on prior versions of MATLAB, if a version of Data Insight is known not to work on a specific version of MATLAB, this fact will be stated in the documentation.

The Review Team (RT) shall be made aware of all known bugs in Data Insight and MathWorks Consulting shall make every reasonable attempt to fix those bugs identified by the largest general population.

7.2 Cost

The cost for one year of software maintenance is \$50K per site.

7.3 Purchasing Data Insight Maintenance Plan

A Data Insight maintenance plan can be purchased either by going directly to MathWorks or by using a GSA Schedule. If the capabilities exist, the plan/subscription can be purchased directly through a site's MathWorks Sales representative⁵. A GSA Schedule has been set up with Lyme Computer Systems (<u>http://www.lyme.com</u>) to purchase software maintenance for Data Insight.

Once the purchase order has been received (either directly or via Lyme Computer Systems) all deliverables will shipped either via email or CD to the TPOC. The TPOC should send the contact information shown at <u>Table 7-1</u> to <u>datainsight@mathworks.com</u>. In addition, the TPOC should send a list of requirements for a data analysis tool.

SOFTWARE RIGHTS AND WARRANTEES

MathWorks owns all intellectual property and software rights to Data Insight. At no time shall these rights be passed on during any deliverable of Data Insight. The warrantees for Data Insight are to be determined (TBD).

LONG TERM DIRECTION

The long-term direction of Data Insight clearly points to two commitments. The first commitment is that the MathWorks will continue working with the telemetry community. This commitment is made clear in part by its investment into the continued development of Data Insight. MathWorks Consulting will be using standard development practices of MathWorks, providing a common look and feel of other products developed by MathWorks.

The second commitment is to provide the user with non-expiring source code that currently allows them to use DataProbe dictionaries. Should MathWorks Consulting decide to stop supporting Data Insight, the user will be able to continue with developmental efforts, without the need to rely on MathWorks or MathWorks Consulting.

The two above commitments (MathWorks supported development efforts and immediate availability to non-licensed source code) provide the user with a strong development team for the improvement of Data Insight. These commitments also will dramatically minimize the risk while simultaneously minimizing future risk of any stoppage.

APPENDIX A

DR-32 FINAL REPORT DR&CG OF RCC, JUNE 22, 2004

This is the final report for DR-32 Task.

The goal of DR-32 was to begin the initial phase of providing a common telemetry data reduction system that can be used DoD-wide. Given the parameters of several members data reduction/analysis systems, leveraging a replacement for DataProbe, which was common among many members, was viewed as a good start for the initial phase. To that end, this initial phase was successful. However, to the overall goal of providing a common telemetry data reduction system, follow-on tasking was required to go further. The follow-on tasking request to RCC was denied for reasons that the tasking was outside the DR&CG charter. When the follow-on tasking was denied, a modified scope was adopted that maximized the initial phase vice the ultimate goal.

In light of maximizing the initial phase, those members who have embraced MATLAB as its foundation for data analysis and, for those members who needed to find a bridge from DataProbe to MATLAB, both Data Insight and the Telemetry Toolbox provide a "first base" solution. Members can purchase maintenance of Data Insight from MathWorks directly via a GSA Reseller. Members can also contract Raytheon Missile Systems to modify the Telemetry Toolbox to fit their data analysis requirements. The adjective, "first base" denotes that both systems are immature. Much work and funding is required to get them to what one would consider a robust, performing system. Several user communities are using both systems.

Per the deliverables of the modified scope (approved by the DR&CG board), an operable beta release of Data Insight with a Growth & Migration Plan for members to follow was delivered. The definition of *operable*, however, is somewhat of a misnomer. No member should think that they would, necessarily be able to take the Data Insight version delivered here and proceed to use it effectively without help from MathWorks Consulting Division. Further, participating members are continuing to fund updates via maintenance contracts and, as such, the delivered beta system is not something one should invest time or effort into adopting. The recommendation of this report is that if you want to view the best Data Insight has to offer, contact MathWorks and get a beta release of the latest and greatest release. The current MathWorks contact, as of 2004 is Raymond Norris, 508.647.7372, rayn@mathworks.com.

Telemetry Toolbox, and a Growth & Migration Plan for it, was not delivered as the modified scope limited the focus to only Data Insight.

The deliverables of this task do not provide a growth and migration plan to a common telemetry data reduction system that can be used DoD-wide, i.e, a plan that discusses how to bridge from DataProbe to Data Insight/Telemetry Toolbox to a common, open source, telemetry data reduction system. To understand why, it is critical to remember that this task was always viewed as the first step to a lengthy process. The lofty goal of providing a beta system that actually worked to bridge DataProbe users to a PC based system using MATLAB was extremely successful given a \$100K investment vice the 10 million dollars originally invested in creating DataProbe. Hence, the Growth & Migration Plan delivered with this task is focused at the granular level of the bridge of DataProbe to Data Insight. It was originally planned to use a portion of the funds to provide a Growth and Migration Plan that addressed the global common picture, but as was stated, a decision was made to maximize the initial phase given the decision by the RCC to not continue this line of tasking.

ORIGINAL SCOPE STATEMENT

The following scope statement was from the original statement:

4.1. SCOPE AND SPECIFIC OBJECTIVES: This task will provide a common telemetry data reduction system that can be used DoD-wide. This reduction system will be built with an eye towards a follow-on task of making it generic across any tools platform. In Phase I, as covered by this task, the reduction system will be based on MATLab to leverage off two existing data reduction systems: Data Insight and Telemetry Toolbox. A follow-on task, if so desired, will expand the toolboxes into a generic system. This task will produce the following deliverables:

- Growth & Migration Plan: This document will determine the capability of Data Insight and Telemetry Toolbox in meeting the data requirements of most DR&CG members for telemetry analysis. Discussions will include:
 - How can these toolboxes be matured to provide a stable product line for RCC Members?
 - How can the toolboxes allow multiple analysis platforms to provide data to and receive data from the toolboxes.
 - Migration Roadmap for RCC Members
 - Software Rights & Configuration Control
 - Software Distribution
 - Funding, Costs, Schedule
- **Telemetry Toolbox & Data Insight Usable Demonstration Systems:** RMS and TREX will provide unclassified demonstration packages that provide the following functionality:
 - Data Dictionary (add, delete, edit)
 - Data Dictionary Conversion (capability of converting or reading Probe Dictionaries)
 - Data Induction Process/System (akin to Probe Flexible File Server or Probe "FIX" Templates).
 - Documentation. RMS & TREX will provide documentation that details the use and interface to the toolboxes such that member ranges can interface and use their own data sources with the toolboxes.

Demonstration: RMS and TREX will provide demos of the systems at either the November 2002 or May 2003 DR&CG Meeting as appropriate.

MODIFIED SCOPE

Due to the lag time between when the task was proposed and when funds were actually given, a key event changed the complexion of the task. When the contract for DR-32 was being written, we received word that Pt. Mugu, Tyndale AFB, and Edwards AFB were more interested in Data Insight than Telemetry Toolbox. Further, at the DR&CG meetings, the interest level was dramatically in favor of

Data Insight. After conferring with the DR&CG board, it was decided to only fund the MathWorks portion of the deliverable (~\$67K).

Second Change to Tasking: It was recommended and approved by the DR&CG board that we use the remaining funds to address some of the significant beta release issues to make Data Insight more robust. Based on that approval, Jim Tedeschi, the task funds manager, approved and extended the funding date. This proposal and decision was in line with the original scope of the task, i.e., a working beta release product. NUWC Keyport, NUWC Newport, and Redstone Test Arsenal are currently using Data Insight in production. Tyndal AFB is in negotiations. Programmatic issues diminished Edwards AFB's requirements for DataProbe capability. Other sites, Eglin AFB, Pt Mugu, China Lake, and Patrick AFB among them, originally expressed interest in Data Insight and may or may not use it.

FUNDING

\$100K of CTEIP ARTM funds was received in April '03 for DR-32. Per the scope above, MathWorks (they bought Data Insight from TREX) and RMS were to receive funds to create a Growth and Migration Plan and a viable beta release of both systems.

DELIVERABLES

- The Growth & Migration Plan was delivered on schedule at the August 2003 DR&CG meeting at NUWC Keyport.

- Two releases of Data Insight were delivered, one in September 2003 and one in December 2003. In September, an Issues and Performance Report was delivered by MathWorks with respect to the original beta release of Data Insight.

- This report, The Growth Migration Plan, a zip file of the Beta Data Insight, the September and December Issues & Performance Report have been submitted to the DR&CG Secretary, Susan Wood.

COST SAVINGS

Each participating member may report cost savings equal to the cumulative funding of Data Insight. To date, each member except NUWC Keyport may claim \$225K in savings. NUWC Keyport has claimed \$100K in savings.

CONCLUSION

An operable beta release of Data Insight with a Growth & Migration Plan for members to follow was delivered per DR-32 requirements. Three members, NUWC, Redstone Arsenal, and Tyndall AFB are currently active. Others may follow...for some members the need for DataProbe replacement has been overcome by events.

APPENDIX B

MIGRATION FROM VAX/PROBE AND NTPROBE TO DATA INSIGHT

1.1 Creating a New File Definition

The following is an excerpt from the Chapter 4 of the Data Insight User's Guide.

1.1.1 <u>New file definition.</u> Data Insight is designed to handle arbitrary data file formats. When connecting to a new data source, a file definition structure (FileDef) that describes the file format must be created. This section describes how to create a new FileDef and connect to a new data source. Once a FileDef is created it can be used for any data source that conforms to the file format described by the FileDef.

- 1.1.2 <u>Data Insight features</u>. Some of the key features of Data Insight are:
 - a. Ability to connect to a data file that contains many types of recorded data,
 - b. Ability to connect directly to your data files without having to reformat or restructure the data, and
 - c. Ability to access the data without loading the complete data file into the MATLAB workspace.
- 1.1.3 <u>File structure overview</u>. Data Insight can access data sources that conform to the generalized notion of recorded frames and records. The FileDef structure identifies the particular format that the data source uses. Figure B-1 shows an outline of the file structure and <u>Table B-1</u> shows the field definitions.

1.1.4 <u>Creating a FileDef</u>. It is usually convenient to create a function that returns a FileDef. An example of a FileDef script (samplefiledef) can be found in the *DataInsight\Data* directory. The details of the FileDef are described in the next section.

2.1 FileDef Detailed Description

2.1.1 <u>Function Definition and Include File</u>. The first section of the FileDef function simply defines the function and calls includefileopendef. The includefileopendef module defines constants to simplify the creation of FileDef. The following is an excerpt of the samplefiledef:

2.1.2 <u>General Information about the Data File</u>. The first section of the FileDef structure specifies general information about the data file, including the type of file (static or dynamic) and the machine format that the file is recorded in. The following subparagraphs explain.

 ϖ *FileDef.Static_File*: The static file field specifies whether the file is static (i.e. the file is no longer being recorded to during analysis) or growing (i.e. the file is still being recorded to while be analyzed real-time).

2.1.3 <u>Source and EventID</u>. Each recorded data file needs to have a source (the source specifies the origin of the file) and an event ID (the run or experiment number of the file). These fields allow for simultaneously opening multiple data files and referencing variables by the source and event ID. Both the source and event ID can be hard-coded (i.e. user specified at file open) or can be read from the file header. If the source or event ID is read from the file header, the standard extract information must be specified. A description of the extract information can be found in the <u>Standard Extract Information</u> paragraph.

 ϖ *FileDef.Source.Specified*: The Source.Specified field indicates whether the source of the data file is specified by the user at file open, or specified in the header of the data file.

7.1 Fixed Frame Files

Data Insight allows for a complex record and frame structure. For very simple files containing fixed frame sizes (without a Record/Frame hierarchy), the methods described above are not efficient. For fixed frames, define your frame length as describe below. Synchronization and frame validation do not apply to this case. Unlike the normal case the whole file is mapped at once.

π FileDef. FixedFrames Header. Length: Specifies the length of fixed data frames.

8.1 Standard Extract Information

Many of the FileDef descriptions refer to the Standard Extract Information. Data Insight uses the same extract information when specifying a file definition as it does for extracting data. The fields commonly needed for file definition extraction are shown here.

Start_Word: Specifies the location of a variable within a frame, counting from zero in sixteen bit words.

-Word zero is referenced from the start of the file when extracting Source and EventID from the file header.

-Word zero is referenced from the start of the Record Header when extracting Record Length.

-Word zero is referenced from the start of the Frame Header when extracting Frame Length, Frame ID, and Time.

Start_Bit: Specifies the *starting* bit of the variable relative to the start word. Bit 0 is considered the least significant bit (LSB) and coincides with the word boundary. <u>Creating Custom File Mapping Routines</u>: While Data Insight provides a flexible means to interface with data files, some data files may need custom mapping routines. A custom mapping routine is required when the FileDef structure cannot describe the file, or if the performance of the Data Insight mapping routine is not satisfactory.

To use a custom mapping routine, you must first create your own mapping routine using an m-file or a mex file. This file must parse through your data file and identify the following information about each frame of data:

Sample Time of the Frame
Frame ID
Position (in bytes) of the start of frame data
Length of frame (in bytes)

This information should be stored in a four by N array (where N is the number of frames) named FILEMAP.mapfile

Additionally the following information must be set
FILEMAP.status = -1;
FILEMAP.endtime = Last time recorded in the file in seconds.

The FILEMAP structure must be saved in a .MAT format. The data file can then be opened using the openDIData command, with the mapfilename option se
