# FOREWORD

***Military Manpower Statistics (MMS)*** is a quarterly publication generated from an integrated data base containing Department of Defense (DoD) work force information. The MMS report consists of 28 statistical tables providing a variety of information on various aspects of military personnel. In addition to summary data, detailed data are provided by Military Service or Defense Component, type of personnel (officer, enlisted), grade, and location. Selected tables also provide data on women in the military.

## GENERAL NOTES:

Excluded from all total DoD military strength figures for fiscal year 1997 are approximately 65,000 full-time military personnel who are paid from other than active duty military personnel appropriations. This group is funded from appropriations for reserve components.

Selected Reserve strengths ordered to active duty by the President under Title 10, United States Code 12304, are also excluded, except where noted, from total DoD strength figures for fiscal year 1997.

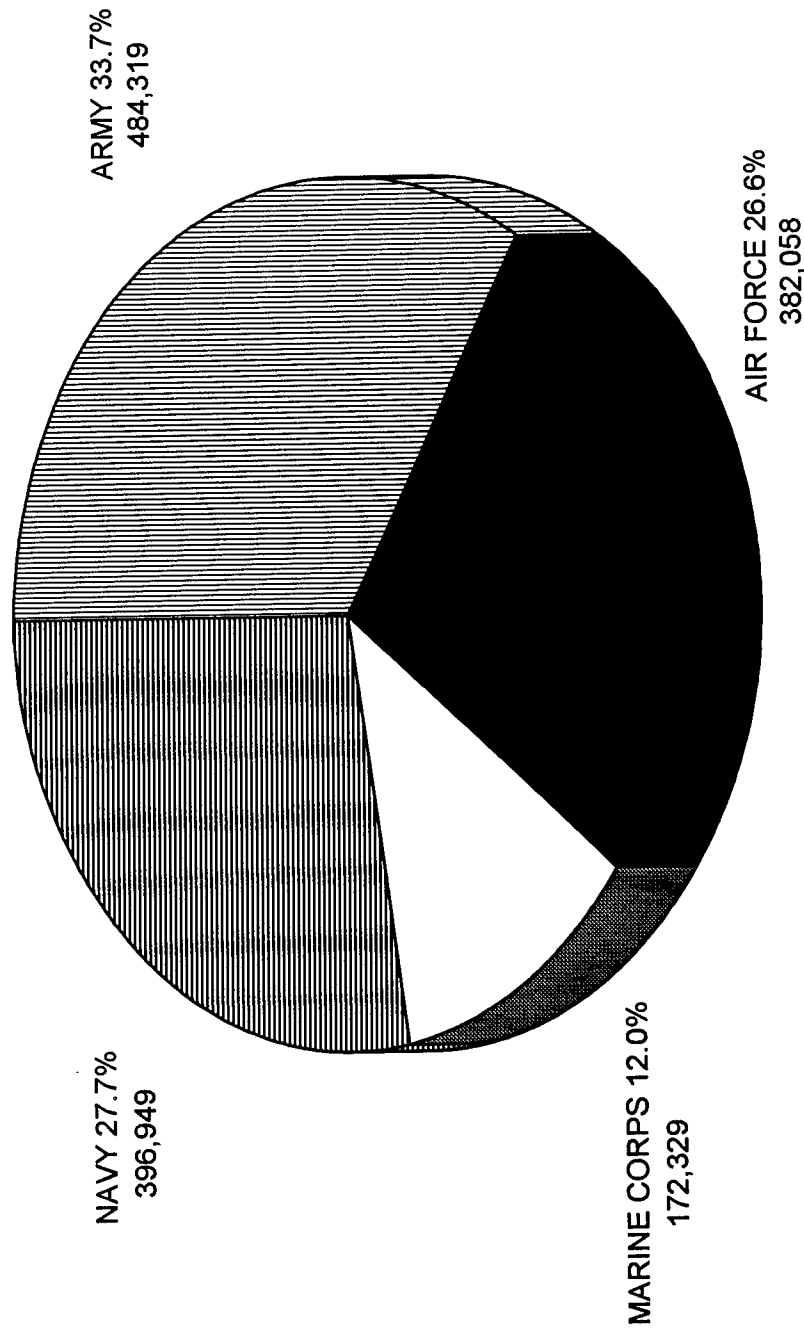

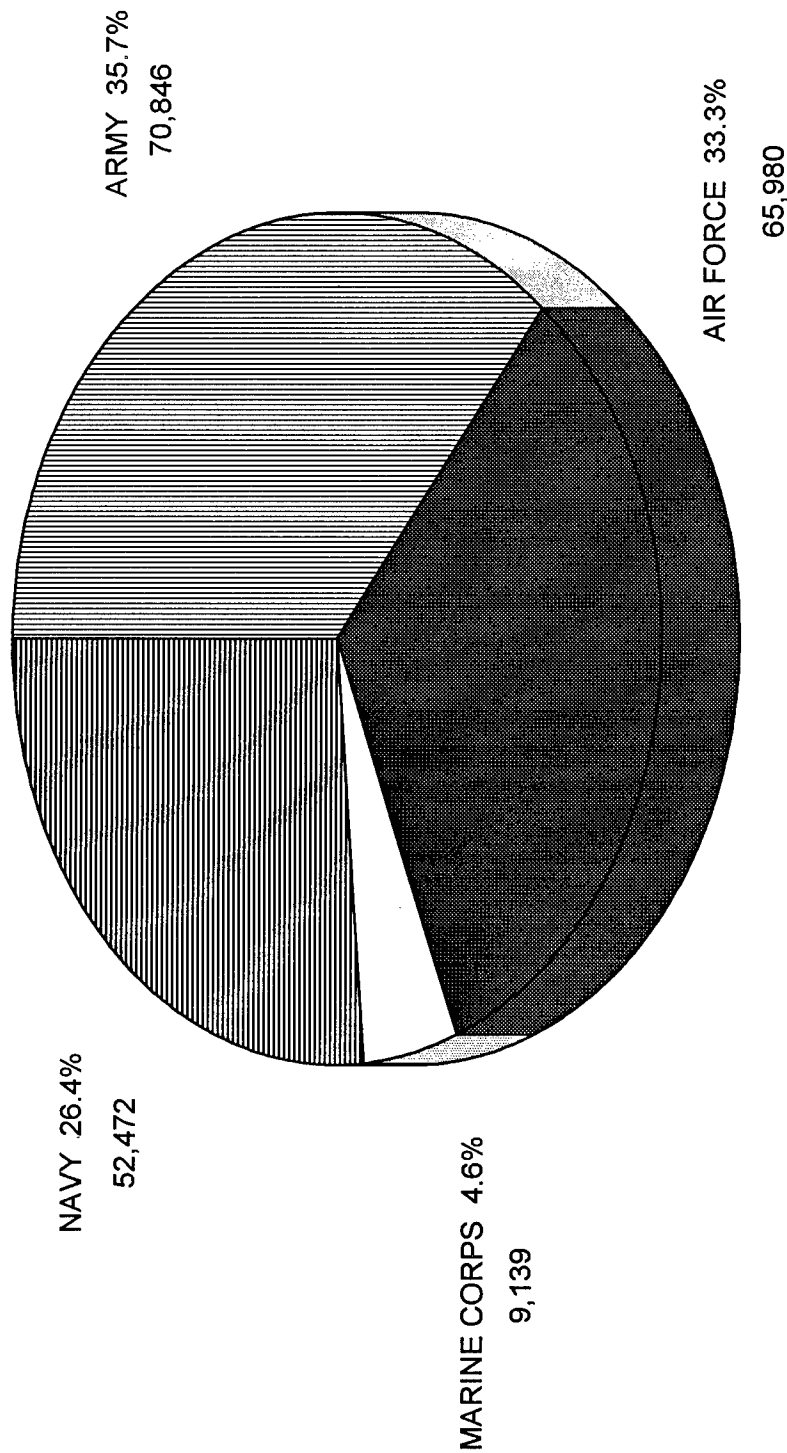

# GLOSSARY OF TERMS

**Active Duty:** Full-time duty in the active service of a uniformed service, including duty on the active list, full-time training duty, annual training duty, and attendance while in the active service at a school designated as a service school by law or by the Secretary concerned.

**Armed Forces of the United States:** Includes the Army, Navy, Air Force, Marine Corps, and Coast Guard, and all components thereof.

**Career Regular:** Individual serving on active duty in the regular component for a second or subsequent term of service or on an extended tour for which a reenlistment bonus was paid. An individual serving on an initial term of service in the regular component of a Service with at least 24 months of prior active duty with another Service will be considered a career regular.

**Civil Functions:** Functions primarily associated with the Civil Works program of the Army Corps of Engineers. This program encompasses planning, programming, designing, constructing, and operating Federal water resource projects for navigation, flood control, hydroelectric power, water supply, recreation, and related activities. Civil Functions also includes cemeterial workers (Army) and conservation management employees (Air Force).

**Continental United States:** Unless otherwise qualified, means the 48 contiguous states and the District of Columbia.

**Direct Hire Civilians:** Employees hired directly by an agency of DoD. Includes Foreign Nationals hired by DoD to support DoD activities in their home countries.

**Early Separations for Reenlistment:** Separations prior to expiration of term of service for purpose of immediate reenlistment, as provided under service regulations.

## Enlistment:

1. A voluntary entrance into military service under enlisted status, as distinguished from induction through Selective Service.
2. A period of time, contractual or prescribed by law, which enlisted members serve between enrollment and discharge.

**Enlisted Member:** A person enlisted, enrolled, or conscripted into the military service. Also includes enlisted personnel currently enrolled in an officer training program.

**First Term Regular:** Individual serving on an initial term of service in the regular component of a Service, including those with prior active duty in a nonregular component of the same Service (e.g., as a reservist or inductee). An individual serving on an initial term of service in the regular component of a Service who has less than 24 months of prior active duty with another Service will also be considered a first term regular.

**Forward Deployment Pacific Theater.** Total of all personnel in the East Asia and Pacific Regional Area plus shore-based personnel in the following countries: Bangladesh, Diego Garcia, Guam, India, Johnston Atoll, Madagascar, Maldives, Mauritius, Midway Islands, Nepal, Pakistan, and Sri Lanka.

**Indirect Hire Civilians:** Foreign Nationals assigned to support U.S. forces through contracts or agreements with foreign governments (or agencies thereof). These personnel are employees of the foreign governments involved.

**Officer:** A commissioned or warrant officer.

**Other Department of Defense Organizations:** See next page.

**Reenlistment:** Entry into active duty in the regular component of individuals with prior military service, either as regulars or as inductees of the same Service, either immediately or within 90 days after separation from a prior tour of active duty.

**Reserve Components:** The Army National Guard of the United States, Army Reserve, Naval Reserve, Marine Corps Reserve, Air National Guard of the United States, Air Force Reserve, and Coast Guard Reserve.

**Separations, Eligible to Reenlist:** Separations of individuals who, under current Service policies, are eligible (or available) for reenlistment in the regular components.

**Service Academy Cadet or Midshipman:** A person in training at one of the Service academies to become a commissioned officer.

**Warrant Officer:** A person who holds a commission or warrant in a warrant officer grade.
