





The masters of revolution and construction are the masses of working people. Only by their own struggle can the masses of working people crush the agressors and oppressors, win freedom and liberation, and build a new affluent and civilized life.

The masses of working people have in them the strength capable of remaking nature and society. It is none other than the masses of working people who conquer nature and create material wealth and so are the masses of working people who smash the outdated society and build a new society.

The revolutionary struggle and construction tasks are a struggle which the masses of working people wage to enjoy an independent and creative life as the true masters of nature and society freeing themselves from enslavement of every description, a task which they prosecute to work out their destiny.

This being so, the masses of people must necessarily become masters in revolution and construction and acquit themselves fully of their responsibility and role as masters.

The inexhaustible strength of the masses of working people who remake nature and society and shape history, comes to manifest itself in the form of tremendous material strength when they, realizing their position as the masters of revolution, maintain an attitude and stand befitting masters. Only when the masses of working people, maintaining a stand and heightened revolutionary consciousness befitting the masters of revolution, vigorously launch into the struggle to work out their destiny, can they display inexhaustible wisdom and creativity and move revolution and construction forward at an extraordinarily high rate of speed. The attitude and heightened consciousness of the masses of working people befitting the masters of revolution constitute the inspiring force energetically pushing forward the revolutionary struggle aimed at building a new life, an important guarantee for all victories.

Maintaining an attitude befitting the masters of revolution is an indispensable requirement of the intrinsic nature of the socialist system and its development.

The masses of working people come to become the true masters of the country and society for the first time only under socialism.

Even though the masses of people are the shapers of history, it does not necessarily follow that they become the masters of nature and society in any society.

As long as they do not possess state sovereignty and means of production, they cannot become the masters of nature and society nor can they engage in independent and creative activities.

In a capitalist society where the means of production and state sovereignty are held in the hands of no more than a handful of the exploiting class, it is the capitalist scoundrels who are behaving as masters while the masses of working people, placed outside the framework of history, outside the framework of political activities, are being made the target for exploitation by capital.

But in a socialist society it is the masses of working people who become the masters of the country and society, independent and creative social beings.

The establishment of the socialist system represents a revolutionary event of providing an independent life for millions of the oppressed, exploited masses of working people, putting an end to the several-thousand-year old class society where all kinds of social evils such as exploitation and oppression, hunger and poverty, swindle and fraudulence, prevail.

By the establishment of the socialist system the masses of working people, for the first time in history, come to be liberated from class exploitation and oppression of every description and become the masters in command of their destiny, masters of the country and society.

In a socialist society there is neigher a specific group of masters nor a specific group of people running errands. The only thing varying in a socialist society is the revolutionary duties and outposts, and all members of the society are masters who all struggle for the one goal and ideal of socialism and communism. Therefore, in a socialist society the masses of working people come to devotedly launch into the struggle to remake nature and society, maintaining an attitude befitting the masters of revolution. The intrinsic superiority of socialism, the great vitality of socialism, lies above all in that the workers, liberated from exploitation and oppression, unite solidly in the common goal and interest, closely cooperative in camaraderie, and work displaying creative initiative and self-awakened fervor. For all workers to live and work on the communist principle of "one for all, all for one" is the intrinsic demand of the socialist system.

In order that all people may live and work in keeping with the intrinsic demands of the socialist system, they must possess heightened consciousness as masters of this society.

A socialist society is maintained, consolidated, and developed by the creative labor and self-awakened fervor of the masses of working people who have become the masters of nature and society.

Therefore, in order to continue revolution to the end, it is imperative to promote awareness as the masters of revolution among workers so that they may perform all work in a manner befitting masters. In order to standardize production at a high level and further improve national housekeeping, all branches, all units, must energetically press on with the struggle to commendably manage and effectively utilize facilities and materials.

Always creditably performing inspection and maintenance work for equipment and machines, we must operate them with full load, and improving facilities more efficiently, we must positively launch the struggle to ceaselessly improve labor productivity. At the same time, we must energetically launch the mass movement, too, to meticulously manage and conserve to the utmost all raw materials, fuels, and supplies such as electricity, coal, cement, oil, and water, and to produce and build more with less supplies and raw materials.

Also, we must exert every possible effort to organize our work sites and vicinity hygienically and tidily and to improve the quality of products.

Just as a doctor writes the prescription, taking into account the physical conditions and the state of illness of a patient, we must plan political work accordingly, deeply grasping the degree of preparedness and characteristics of a target, and rack our brains and find a way to make identical prescriptions more palatable to each particular person.

To bring broad forces into political work is one of the important ways to energetically launch political work.

The great leader Comrade Kim Il-song taught as follows:

"...inasmuch as ours is a party that has seized the ruling power and leads all tasks, it is a fact that there must necessarily be paid party functionaries. But by no means does this mean that party work must be performed only by party functionaries. All functionaries must perform party work, all functionaries must perform political work." "We must make new regulations where necessary and also review all existing regulations with a view to revising all that which does not correspond to today's reality." ("On the Question of Socialist Economic Management," Vol 3, p 536)

Laws and regulations are criteria for action and as such, are the cornerstone of legal control, a prerequisite.

Inasmuch as legal control is control over the observance and execution of the laws, legal control is unthinkable without the laws which are the criteria for action.

Therefore, the People's Committee, strengthening legislative work in its capacity as an organ of sovereignty, must amend and supplement the laws and regulations of all sectors in keeping with the demands of developing realities, based on the socialist constitution, and must also make new regulations where necessary.

To resolve all military questions with people as the basics means to subordinate all military questions to people, to gear the resolution to protect the independent stand and attitude of the masses of people.

To people, independent stand and attitude is life, the basic conditions for their existence and their overall development. For the masses of people to struggle to protect and defend their independent stand and attitude is their sacred right; and to protect and defend oneself is the intrinsic demand of a social being who holds his independent stand and attitude as life.

People, the most energetic and dignified social beings who hold independent stand and attitude as life, want no enslavement to others and absolutely tolerate no encroachment on their independent stand and attitude. That is why the masses of people wage bloody revolutionary struggle to protect and defend themselves and come to demand their revolutionary military thought as theoretical and practical weapon for winning victory in arduous revolutionary war.

A revolutionary military thought which proceeds to resolve military questions with people as the basics must necessarily hold it as its basic goal to protect and realize the independent stand and attitude of the masses of people. Therefore, the revolutionary military thought of the working class must necessarily become a theoretical and practical weapon in the revolutionary struggle to liquidate national and class oppression which seeks to constrain, violate, and rub out the independent stand and attitude of the masses of people.

In order that the military idea of the working class may become a military thought which thoroughly protects the independent stand and attitude of the masses of people, it must become one through which runs a revolutionary antiimperialist character in uncompromising struggle against the imperialists and all kinds of class enemies.

In order that the masses of people may protect, defend, and realize their independent stand and attitude, they must resolutely struggle to liquidate the social factors which constrain the independent stand and attitude.

Today in our era the major social factors which constrain the independent stand and attitude of social beings are exploitation and oppression by reactionary ruling circles and aggression and enslavement by the imperialists. Therefore, in order to protect, defend, and realize their independent stand and attitude, the masses of people must crush by revolutionary violence the rule of reactionary exploiting classes and imperialist aggression which violate and encroach on the independent stand and attitude.

The chuche-oriented military thought founded by the great leader is the most revolutionary and anti-imperialist military ideology which has been brought into being reflecting the demands of the chuche era in which the masses of people are struggling to independently and creatively work out their destiny, freeing themselves from enslavement of every description, and is a military idea which holds it as its basic mission to protect and defend the independent stand and attitude of the masses of people.

The great leader's military thought founded reflecting the pressing demands of the times gives scientific answers to all the questions which the chuche era presents in the military sphere and comprehensively enunciates the principles and ways and means capable of thoroughly protecting and realizing the independent stand and attitude of the masses of people. The military thought enunciated by the great leader is an encyclopedic military ideology that provides the most precise principles and ways and means which the working class and its party must tightly grasp invariably in resolving all types of revolutionary war and military questions that may arise throughout the historical period of protecting to the end and thoroughly realizing the independent stand and attitude of the masses of people.

"...people fighting with such weapons as aircraft, cannon, and warships against the enemy, that is, troops and commanding officers constitute the armed might. Here too it goes without saying that it is people who are the basic armed might." ("On the Question of Socialist Economic Management," Vol 1, p 232)

People, the most energetic beings who are the masters of nature and society and resolve everything, are the basic element in the composition of armed might, masters who operate weapons and technical combat equipment and are in actual charge of military actions.

Weapons and technical combat equipment are the material and technical means worked out by people to protect and defend themselves, and these come to display their might only by the independent and creative actions of the troops.

People, the chuche who cognize the laws of the armed struggle and purposefully utilize them, work out the form and method of the armed struggle in keeping with their class demands and aim and in accordance therewith, organize and execute the armed struggle and win victory. The objective laws of the armed struggle, too, become cognized, manifest, and operative only through military activities mounted by the purposeful action of the masses of troops.

From such doctrine of the chuche ideology, the great leader's military thought lays it down as the invariable principle in proceeding to resolve all military questions with people as the basics.

The great leader's military thought elucidates anew that the decisive factor in the victory of revolutionary war lies in the strength of man, the masses of people, not in material and technical things such as the means of struggle.

The basic armed might in weapon and man, the two component elements of armed might, is man. No matter how powerful modern weapon may emerge, it is man with ideological consciousness who makes it and operates it. Without man no modern weapon is of great importance nor can it display its potential might. Consequently, national defense might, the combat might of troops, is determined by the ideo-mental state of man, the masses of troops, who make weapons and operate them.

The great leader, scientifically analyzing on the basis of the chuche ideology the roles played by man and weapon, politico-ideological factor and military technical factor in war and the mutual relationships, laid down the unique thought that the decisive role in revolutionary war is played by the revolutionary army conscious of its lofty mission in struggling for the freedom and liberation of people and possessed of the mental preparedness and revolutionary spirit to fight to the end with invincible faith in the justness of its cause and in victory.

With the dominant position and decisive role of man in the armed struggle enunciated by the great leader's chuche military thought, the intrinsic characteristics of various factors in the armed struggle came to be clearly defined, the erroneous views holding that the outcome of war is determined and all actions of man are governed by some kind of powerful modern strategic weapon came to be eliminated, and a new viewpoint came to be established that everything to resolve military questions is either created by man or provided through the purposeful actions of man and that with people as the basics, all military factors must be integrated into a coalescent whole.

The great leader's chuche-oriented military thought on resolving all military questions with people as the basics is a genius thought which illuminates the guiding compass in strengthening national defense might, an outstanding thought which has declared bankrupt the reactionary thought which holds weapon as the military panacea, absolutizing the means of struggle and military techniques alone at the expense of the decisive role of the masses of troops, the masses of people in revolutionary war.

The great leader's military thought elucidates the theory on people-centered self-defensive national construction with people, the masses of troops and the masses of people, as the basics through and through in building revolutionary armed forces and strengthening national defense might as well.

The all-people, all-state defense system enunciated by the great leader's military thought is a superior defense system in terms of military strategy which makes the masses of people most widely and most positively participate in national defense task in keeping with the all-people character of modern war, revolutionary war.

The military thought on the all-people, all-state defense system enunciated by the great leader is a great military idea which, by enhancing the role of people, the decisive factor in the victory of war, in every possible way on the one hand and comprehensively strengthening all the other factors, weapons and military position, in keeping with the demands of modern warfare, makes it possible to turn national defense might and self-defensive military forces invincible and convert all potentialities of the country to one military strength, integrating weapons and military theater as one with people as the basics.

Thus the great leader's military thought is a people-centered military ideology which proceeds to resolve, with people as the basic, all military questions ranging from the question of war, the question of defense construction, military strategies and tactics to the method of command.

Next, what makes the military thought enunciated by the great leader of revolution Comrade Kim Il-song a unique military ideology with people as the basics lies in that it proceeds to resolve military questions enhancing the creative actions of people in every possible way based on the role of people from beginning to end.

The respected and beloved leader Comrade Kim Il-song taught as follows:

"The combat strength of an army is influenced in large measure by the mental state of the troops and commanding officers, in other words, the morale of the army and their skills in operating weapons. No matter what wonderful weapons they may possess, if the combat consciousness of the army is low bereft of skills to operate them, then such weapons are of no use. In order that an army may win victory in battle, their weapons must be good of course but their combat consciousness, ideological consciousness, and technical standard must be high. In particular, ideological consciousness is of decisive importance." (Ibid., p 232)

The decisive role in armed struggle is played not by weapons but by people, the energetic beings who are the masters of everything and resolve everything, the masses of troops.

People, the masses of troops, come to play the decisive role in armed struggle because they possess ideological consciousness.

All actions of people are taken toward specific objectives in a specific direction determined by ideological consciousness, come to abide by the ways and means selected by consciousness and produce the result projected by consciousness.

Revolutionary ideological consciousness makes it possible for people to have a scientific cognition of nature and society and inspires their thorough mental preparedness to vigorously launch into the revolutionary struggle with an indomitable will unbending whatever the adversity. The ideological consciousness of troops not only imparts purposeful consciousness to combat actions but also makes it possible for them to cognize the laws of armed struggle, to utilize them in keeping with their class demands and aim and to ceaselessly gain new practical experiences and improve the form and method of struggle. Therefore, the resolution of military questions must necessarily start from such decisive and active role of people; only then can the military thought become an invincible military ideology thoroughly relying on the strength of the masses of people, the masses of troops.

The chuche-oriented military strategies and tactics which hold the respected and beloved leader's military thought as the guiding compass are based on the decisive roles of the masses of troops and the masses of people bearing arms in the fight against the enemy, and hold it a basic principle to further enhance their active activities.

At the same time, the revolutionary military strategies and tactics of the working class must become such ones as capable of crushing the technical and numerical superiority of the imperialist aggressive army with the politico-ideological superiority and strategic and tactical superiority of the revolutionary army.

Victory in war is not determined by any weapon or military technique but by the state of ideological consciousness and political morality of the revolutionary army, the masters who operate weapons and military techniques.

The basic principles of military strategies and tactics enunciated by the great leader are based on a scientific analysis of the intrinsic superiority

of the revolutionary army over the imperialist aggressive army and the laws of the revolutionary war, and as such, are a programmatic compass which mak & it possible for the masses of working people to victoriously prosecute the revolutionary war.

"The question to which major attention must be directed in labor administrative work in the present period is energetically pressing on with technical revolution." ("On the Question of Socialist Economic Management," Vol 3, p 277)

Technical revolution is a decisive guarantee for rapidly increasing labor productivity resolving the strained labor situation in the country and for liberating workers from backbreaking labor.

The creativity of people is inexhaustible but there is a limit to their physical strength. Therefore, without utilizing the means of science and technology it is impossible to solidly lay the material and technical foundations of socialism nor to completely liberate workers from the constraint of nature.

This bespeaks that in conducting labor administrative work we must responsibly grasp the question of energetically pressing on with technical revolution.

Most important in this connection is for guidance functionaries to thoroughly establish the revolutionary attitude of precisely formulating technical innovation task such as the plan for technical development with the proper attitude and stand toward technical revolution and of thoroughly carrying it out.

It is imperative to formulate by collective discussion the technical development plan such as the mechanization of labor-consuming and heavy work and automation of production process and to precisely reflect the labor so saved in the labor plan. At the same time, it is important to properly organize assignments for the technical development plan, to thoroughly adopt measures for the realization, to carry them out without fail by strengthening creative cooperation with workers and technical personnel and to energetically launch the movement for creative designs and rationalization.

Important in energetically pressing on with technical revolution is expanding the ranks of technicians, specialists, and skilled workers possessed of modern science and technology and enhancing their standards of technique and skill.

By decisively strengthening the work of improving workers' techniques and skills through the system of teams to study techniques and skills and individual training in skill it is imperative to make them positively contribute to the prosecution of technical revolution, enhancing their standards of technique and skill.

At the same time, it is important to thoroughly carry through the principle of training with foresight the skilled workers on one's own for his own branch.

One of the basic links which economic guidance functionaries must tightly grasp in further improving labor administrative work in the present period is ceaselessly increasing the production volume per employee.

The per-man production volume in a socialist society is an important economic index characterizing the degree of prosecution of technical revolution and the achievement in labor administrative work. Only by increasing the peremployee production volume is it possible to strengthen the economic might of the country and constantly improve the standard of living for the people, manufacturing more products with less labor.

Our economic guidance functionaries, giving concrete assignments to workers and technicians and enhancing their creative fervor, must increase the utilization rate of machines and equipment, widely adopt the fruits of modern science and technology and continue to increase the per-man production volume, positively adopting even a small technical innovation design.

Energetically pressing on with technical revolution on the one hand and seeking out and mobilizing the labor potential in every possible way and rationally utilizing it is an important guarantee for successfully resolving the question of strained labor.

It is one of the laws of socialism that labor is in short supply as the scope of the economy grows and new production branches are created but it becomes possible to seek out a great labor potential as technology develops, the political consciousness of workers and their standards of technique and skill grow and economic management work improves.

Part of the greatest potential for conserving labor in the present period lies in improving labor planning and labor organizational work.

It is imperative to formulate a realistic and dynamic plan based on a correct work quota and labor quota, creditably taking labor into account in accordance with the line enunciated by the great leader on formulating the plan in detail on the one hand and properly meshing them with other elements in production.

In particular, properly setting the work quota arises as an important question in formulating labor planning and labor organizational work.

Work quota is the basis for labor plan and wage schedule and is a measure for evaluating the results of labor. Important to labor deployment is insuring a correct labor balance of productive and nonproductive branches on the principle of properly setting labor for nonproductive branches in keeping with the level of economic development while increasing the number of employees for productive branches with priority. Within their own branches the productive branches must lower the labor ratio of indirect branches while increasing the labor of primary productive branches, especially the labor ratio of direct branches within them.

At the same time, with the sexes, physique, and level of technique and skill of workers taken into consideration in deploying labor the principle of the right worker in the right place must be observed so that all workers may work displaying their abilities to the full potential.

If on such principle labor deployment is reviewed by the post, shop, and production process then it will be possible to seek out a greater labor potential and to make the necessary reassignments by seeking out youthful workers deployed to posts which can be well manned by females or workers of weak frame and technicians working in nonspecialized branches.

In order to positively seek out and mobilize the labor potential and rationally utilize it, it is imperative to improve labor organizational work.

Under conditions in which new techniques are being ceaselessly adopted and production linkages are becoming closer in all branches of the people's economy, constantly improving labor organizational work comes to the fore as an important question.

In organizing labor it is important that with the characteristics of production branches and organizational forms of production taken into consideration, work teams, shifts, rest periods be well organized and clearly defined work assignments be given each worker. At the same time, by improving labor organizational work such as organizing dual-post jobs and multi-machine jobs or rationalizing shops it is important not only to effectively utilize labor but also to seek out a greater potential.

Functionaries and workers of the city management branch, with deep cognition of the importance of the revolutionary duties assigned to them, must exert every possible effort to still better protect the country's dwellings, the country's facilities, the country's properties and to provide a happy life for the people. At the same time, they must become commendable indoctrinators of the entire workers in protecting and managing the priceless properties of the country.

To meticulously manage buildings and facilities, to maintain them on a routine basis and to beautify cities and villages with tree planting is the primary duty of socialist city management.

Again, only then will it be possible to conserve materials, funds, and labor in city management and to preserve the buildings and facilities for a long time to come as the priceless assets of the country, extending their life span.

In order to creditably perform maintenance work on buildings and facilities, it is imperative that planning economic organizational work and precisely grasping the state of the buildings and facilities, maintenance work be performed on a planned basis and the necessary materials be procured and delivered on time.

Functionaries of the city management branch, based on observing and grasping in detail on a routine basis the state of all buildings and facilities such as dwellings and schools, must do planning work drawing up maintenance blueprint ahead of work and most effectively utilize materials, funds, facilities, and labor. Also, they must responsibly procure and deliver the materials necessary for maintenance work, exercise strict control to prevent the materials necessary for maintenance work, exercise strict control to prevent the materials from being diverted to other use, and decisively improve the quality of maintenance work.

The struggle for democracy, independent and peaceful fatherland reunification is also being strengthened with each passing day among our overseas compatriots in the United States, Japan, France, and Canada, and the voice of the world society denouncing the Pak Chong-hui puppet gang's fascist dictatorship, violation of human rights, ugly scandals of bribing leaders in the United States and Japan is also growing louder.

Thus the struggle of the people resisting the most vicious, barbaric "revitalization" fascist dictatorship is developing into a fierce struggle in direct confrontation, and is moving closer to a new explosion point.

The anti-fascist democratization struggle being steadfastly under way in South Korea is an inevitable product stemming from the violent repression maneuvers, the national division plot, the war machination of the Pak Chong-hui puppet gang, the all-time traitors, and from the South Korean society filled with the wrath and resentment of the people against them.

At the incitement of U.S. imperialism, the Pak Chong-hui puppet gang have been committing all the criminal acts of treason against the country and the people for the past 16 years. Flustered by the ever growing demand for democracy and fatherland reunification, the Pak Chong-hui puppet gang set up the notorious "revitalization" system and more thoroughly turned South Korea into a land of medieval darkness, into an imperialist colonial military base.

Today in South Korean society even the most elementary demands for the right to a living and for improved living conditions, not to mention democratic freedoms and rights, are being mercilessly trampled on, all people in all walks of life being the object of violent repression.

Faced with an extreme political crisis, the Pak Chong-hui puppet gang are viciously challenging the will of the people and the demands of the times while ever more clinging to fascist violent repression and reliance on outside forces. While pleading for the long-term occupation of South Korea by the U.S. imperialist aggressive troops, the scoundrels are arresting at random, incarcerating, and executing patriotic people, youths, students, democratic personalities, religious personalities demanding social democratization and human rights, among them being those involved with "Democratic National Salvation Declaration," the sponsors of "Democratic National Salvation Charter," the subscribers and those engaged in collecting signatures, and are meting out harsh punishment even to the Koreans residing in Japan on the trumped-up "charges of espionage." Today when many countries in the world and hundreds of millions of people strongly demand the respect of human rights, peace keeping, and sovereignty, South Korea alone is being turned into a land where acts of strangling democracy are being committed at will, along with the most vicious violation of human rights.

Under such circumstances the South Korean people cannot help vigorously launching into the struggle to protect their independent stand and attitude against the vicious rule and tyranny of the fascist executioner.

It is in the scheme of things that resistance is inevitable where there is oppression, the worse the violent repression of oppressors, the more resolute the resistance of the masses against it. It is only natural that the South Korean people should be struggling to demand democracy against fascism, to realize the reunification of the country.

The respected and beloved leader Comrade Kim Il-song taught as follows:

In order to successfully realize fatherland reunification, it is imperative that the political framework be created which can insure the freedom of social and political activities in South Korea and achieve national unity.

The freedom of thought and political activities, great national unity represent the first step toward independent and peaceful reunification.

Under conditions in which the fascist rule as ruthless as at present is being enforced in South Korea and the people and democratic personalities demanding freedom and democracy and aspiring to reunification are being bestially suppressed, there can be no free exchange of thought among the people nor can the broad masses of people in all walks of life freely participate in the reunification movement. The puppet gang of traitor Pak Chong-hui, a scoundrel who knows of neither the nation nor human beings, are mouthing as if their fascist violent repression racket, committing the barbaric act unprecedented in history of butchering human beings were necessary for reunification, as if there existed no question of human rights in South Korea. But the scoundrels' brazen-faced sophistry no one will buy. It is only too self-evident that in South Korea where human rights, even the elementary right to a living, are being trampled on, the broad masses of people cannot freely participate in the reunification movement.

The reason why the North-South talk which was brought about after such great labor is in a stalemate, also why our people's reunification cause has come to be faced with a serious situation all lies in that the South Korean puppet gang, at the incitement of U.S. imperialism, are bestially suppressing the advance of the people aspiring to freedom, democracy, and fatherland reunification. The way the situation has been developing in South Korea shows that as long as the fascist dictatorship of the Pak Chong-hui puppet gang is left alone, neither the talk nor any reunification proposal can be success fully realized.

The question is to achieve great national unity by rallying and uniting all people desirous of reunification by putting an end to the fascist, splittist, violent repressive system currently existing in South Korea and realizing the democratization of the South Korean society. Fascism and great national unity are absolutely incompatible. Only when in South Korea the outrageous military fascist dictatorship is overthrown and social democratization is realized will it be possible for the broad circles of people in all strata of the North and South to solidly unite transcending differences in ideology, political view, religion, party and organizational affiliation, to promote good mutual understanding of thoughts and opinions, and to participate in the reunification cause with heightened patriotic fervor on an all-nation basis.

Also, to energetically launch the anti-fascist democratization struggle in South Korea presents itself as a very pressing question in advancing the reunification of the country, foiling the maneuvers to split the nation, machinations to unleash another war, which the Pak Chong-hui puppet gang are viciously perpetrating under "anti-communist" slogans.

Being more isolated internally and externally and driven into a predicament, the Pak Chong-hui puppet gang are going berserk in staging "anti-communist" racket and war racket under the pretense of "threat of aggression from the North," desperately seeking a way out in their policies of fascist violent repression and military adventures unprecedented in history.

The Pak Chong-hui puppet gang are strengthening the armament of their military forces and are building and expanding military bases, continually bringing war material into South Korea, begging their U.S. and Japanese masters for what they claim "all-out security" and "posture on a wartime footing" in violation of the peaceful reunification principle agreed upon in the North-South Joint Statement. The scoundrels proclaimed "a state of war" over the entire region of South Korea, fabricated various kinds of vicious wartime laws, and are accelerating the "war capabilities" of "militia" and are forcing youths, students, and inhabitants to undergo wartime military training, forming civilian military organizations such as "student defense corps" and

The Pak Chong-hui puppet gang, by intensifying the acute tension in the situation through such "anti-communist" racket and war racket and deceiving the internal and external press, are trying to create an excuse for prolonged occupation of South Korea by the U.S. imperialist aggressive troops, to perpetuate national division under their aegis, to repress the inhabitants' spirit of struggle and to shore up the shaky base for their rule. Internally, the South Korean puppet gang are enforcing the fascist dictatorship rubbing out democracy and even the elementary right to a living, and externally, they are stepping up their political, economic, and military collusions with U.S. imperialism and Japanese reactionaries, selling out the country and people to the outside forces. Because of these criminal acts, the South Korean people are being subjected to untold misery and suffering and our people's cause for fatherland reunification is faced with a serious obstacle.

Only by energetically launching the democratization struggle can the South Korean people foil the machinations of internal and external splittists to fabricate "two Koreas" and their maneuvers to unleash war, overthrow the present military fascist dictatorship in South Korea, and create a situation favorable to fatherland reunification.

Moreover, through the anti-fascist democratization struggle it will be possible to further strengthen the chuchg-oriented forces for reunification in South Korea as well.

Revolutionary forces cannot be prepared spontaneously without struggle; only through arduous struggle can they grow and become strengthened. Amid positive struggle the masses of people come to heighten their political awakening, to accelerate their organizational solidarity and the core elements of revolution come to grow.

When the South Korean people rise to positively struggle against the military fascist dictatorship of the traitor Pak Chong-hui puppet gang, they will come to be further awakened, tempered, to grow up as invincible revolutionary forces along with the socialist forces of the northern half, and the chuche factor in fatherland reunification will come to be further ripened.

The people in all strata of South Korea must unanimously launch into the mass struggle for democratization of the society against the tyranny and fascist suppression of the traitor Pak Chong-hui puppet gang who are trying to perpetuate national division and permanently hold the ruling power, relying on the U.S. and Japanese aggressive forces.

One of the basic conditions for democratization of the South Korean society is realizing the freedom of the press, combination, assembly, and demonstration. Without this it is impossible to speak about any kind of freedom, democracy, and human rights.

The South Korean people must launch dynamic struggle to oppose all the vicious fascist laws and atrocities of violent repression, to demand the release of the arrested and incarcerated political offenders such as patriots, youths, students, democratic personalities; they must resolutely fight to win the freedom to study and disseminate advanced thought, the freedom of formation and activities of political parties and social organizations.

A basic question in the struggle for democratic freedoms and rights is overthrowing the fascist dictatorship.

Social democratization is achieved through the struggle of the masses of people; it can be realized in practice and consolidated only by the progressive political power won by struggle.

The South Korean people, by more valiant struggle, must mete out stern punishment to the Pak Chong-hui military hooligans and positively struggle to establish a democratic united government embracing democratic forces in all strata, sweeping away the scoundrels' fascist dictatorship.

In order to realize the democratization of the South Korean society, the people in all strata of South Korea must launch a mass, joint struggle.

The respected and beloved leader Comrade Kim Il-song taught as follows:

"The struggle for democratic rights and freedoms can win victory only when it develops into a mass struggle embracing all the revolutionary forces of South Korea and all the other forces opposing the military fascist dictatorship. Even though at present the Pak Chong-hui puppet gang are committing all kinds of acts of treason against the country and the people and all the tyranny, subserviently hanging on to their U.S. and Japanese masters, these can never be a means of the scoundrels' survival.

The U.S. imperialists must withdraw from South Korea at the earliest possible date their aggressive armed forces and all means of war including nuclear weapons and stop their futile effort to back up the Pak Chong-hui traitor gang with dollars and weapons.

The Japanese authorities too must stop their shameless, impertinent acts of siding with the South Korean puppets and imprudently interfering with the Korean question.

If the internal and external splittists, going against the demands of our people and the current of the general trend of the times, try to get something out of the maneuvers of violent repression, splittist plot, war machinations, then it is a big mistake.
