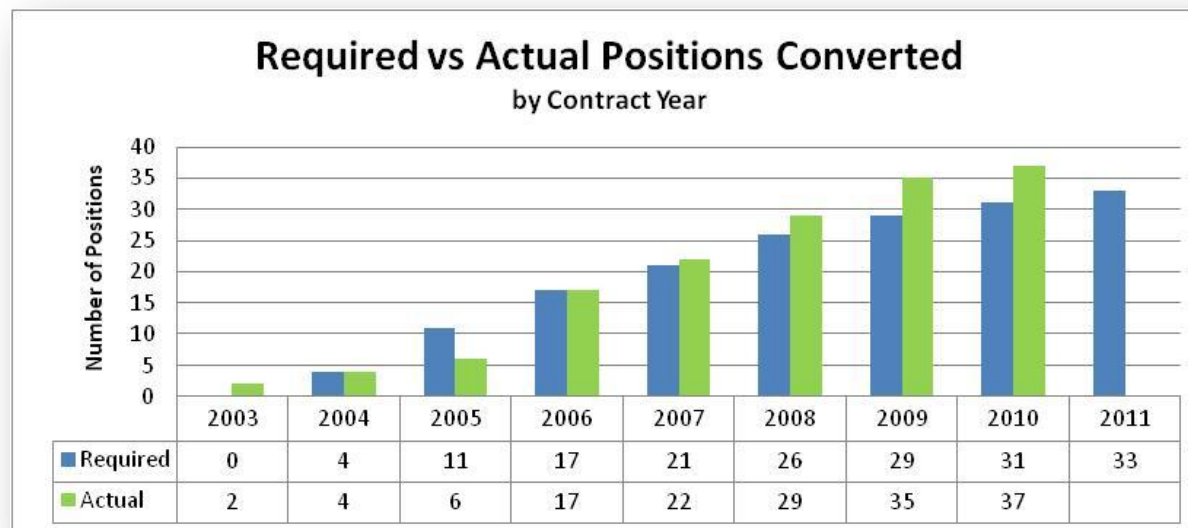

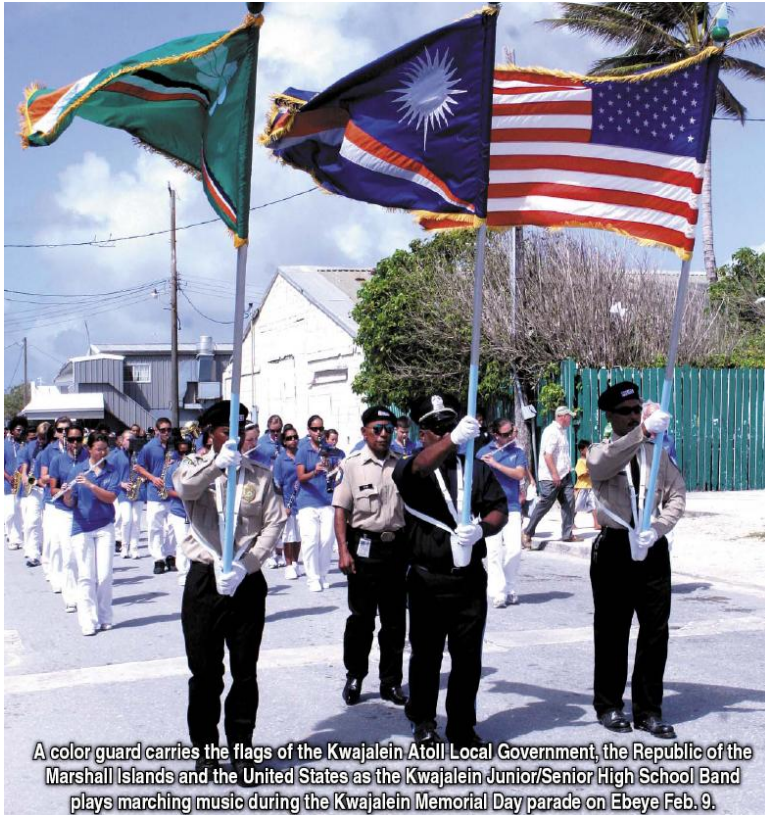
Marshallese Training & Employment Program(MTEP)

- A comprehensive program to increase employment and advancement of RMI citizens to replace off-island hires with qualified local hires and foster relations with the RMI.
- In 8th Contract year, USAKA no longer weights this contractual requirement as “critical” due to exceeding the standard each year.
- Budget constraints turned the Human Resource office to request support from National Training Council in Majuro netting \$100K in support to develop local hires.
