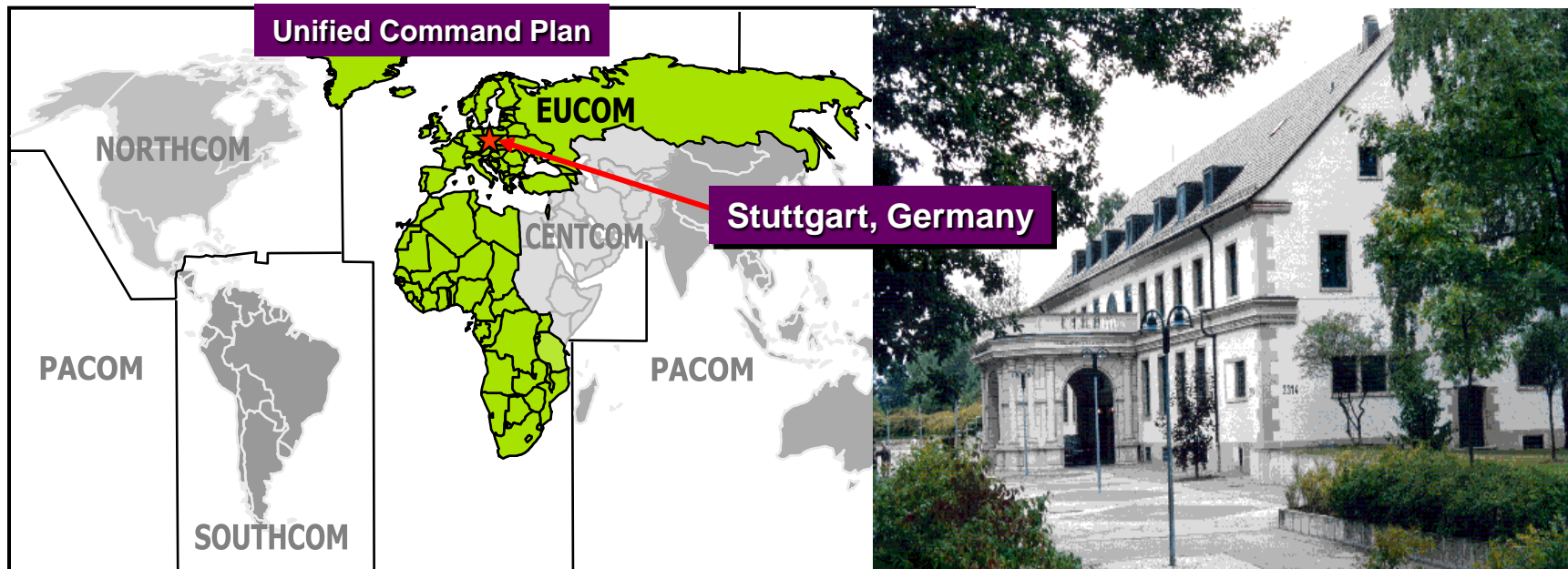

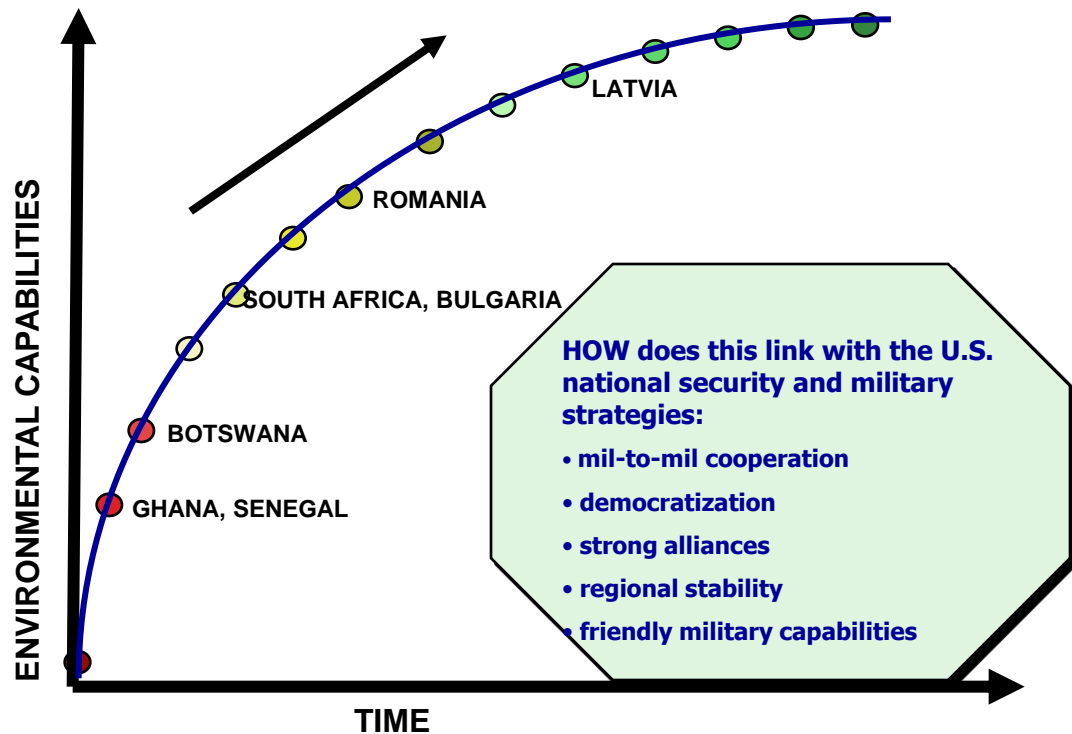


Defense Environmental International Cooperation (DEIC)

- Mechanism for construction of lasting partnerships that provide opportunities for long term influence.
- Focused on positive outcomes
- Must be appropriately leveraged!
- DEIC is funded through OSD (I&E) and has a natural linkage with the Energy Industry. Its very modest fund profile (<\$2 Million / year for global distribution) provides a tremendous return.
- Proposals are defended annually to the ODUSD(I&E)ER&S, ODASD(Policy/Policy Planning), and the Office of the Chairman of the Joint Staff.

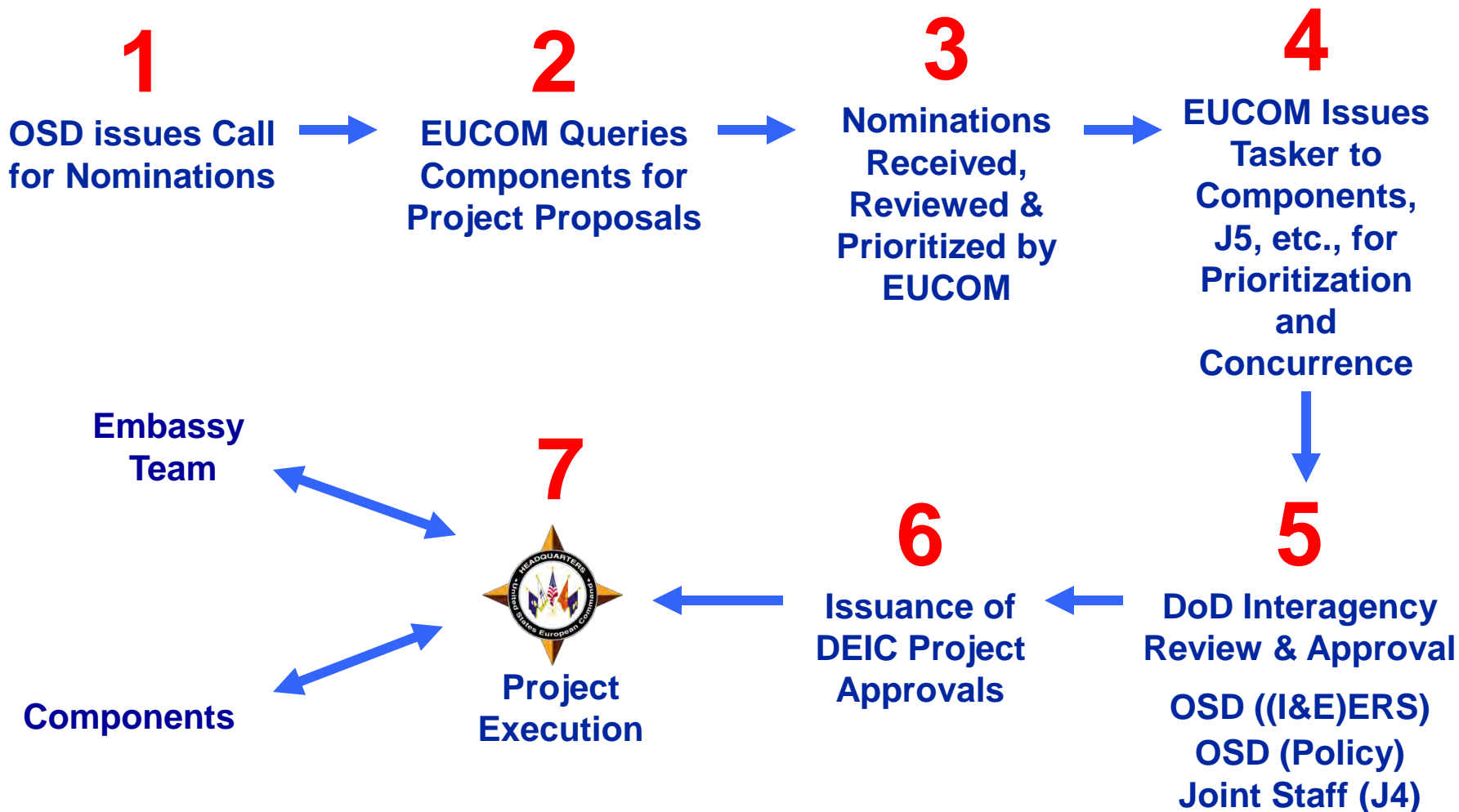

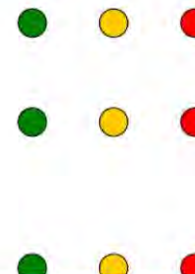

- Military Training Area Flora and Fauna Data Collection:** This effort would focus on the collection of regional information associated with military training areas.

The annual Joint Defense Environmental Symposium, June 2010 will be a joint venture between Headquarters, US European Command and the Royal Norwegian Ministry of Defence. This symposium remains the Command's premier military environmental security cooperation event and brings together NATO and partner nations to discuss cost-effective approaches to common defense environmental issues. The symposium theme of regional environmental military cooperation will showcase defense environmental initiatives to encourage cooperative efforts in regions of strategic interest to the U.S. The program will emphasize defense environmental issues and promote the discussion and exchange of ideas regarding the environmental challenges and future areas of military cooperation in both the region and the broader international arena.
